

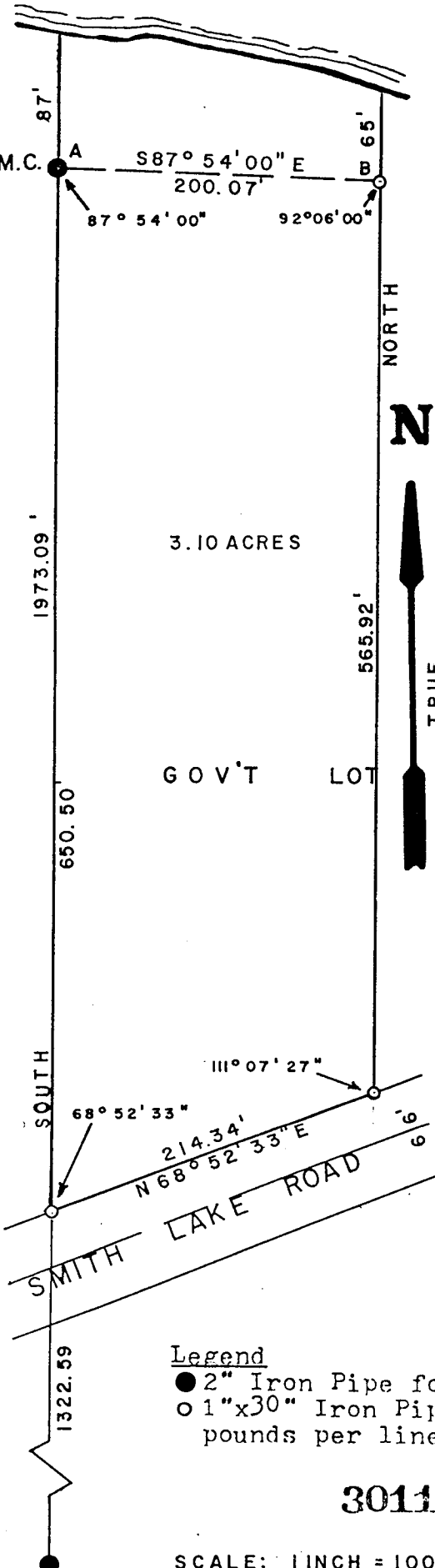

SURVEYOR'S CERTIFICATE

I, Thomas W. Nelson, Registered Land Surveyor, hereby certify that I have surveyed and mapped the following described parcel of land located in Gov't Lot 1, Section 1, T.44N., R.9W., Bayfield County, Wisconsin.

To locate the Point of Beginning, commence at the West 1/4 corner of said Section 1 and run North, along the West line of Section 1, 2060.09', to the water's edge of Sweet Lake, which is the Point of Beginning.

Thence from said Point of Beginning by metes and bounds: South, along the West line of Section 1, 87±', to a 2" iron pipe (pt A); Thence continuing South along the West Line of Section 1, 650.50' to the Northerly R.O.W. of the Smith Lake Road; Thence N68°52'33"E, along said Northerly R.O.W., 214.34'; Thence leaving the North R.O.W. of Smith Lake Road, North, 630.92'± (passing thru iron pipe B at 565.92') to the water's edge of Sweet Lake; Thence West-erly along the water's edge of Sweet Lake, 200'± to the Point of Beginning. Point B bears S87°54'00"E, 200.07' from Point A. Parcel contains 3.10 Acres.

That this Certified Survey Map is a correct representation of all the exterior boundaries of the land surveyed and the subdivision thereof.

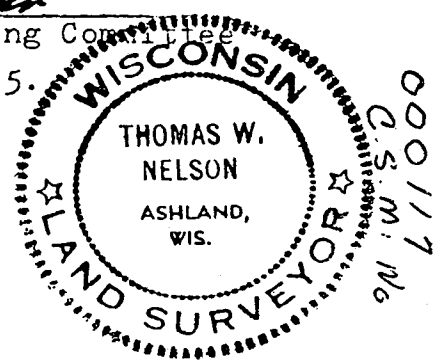
