BAYFIELD COUNTY

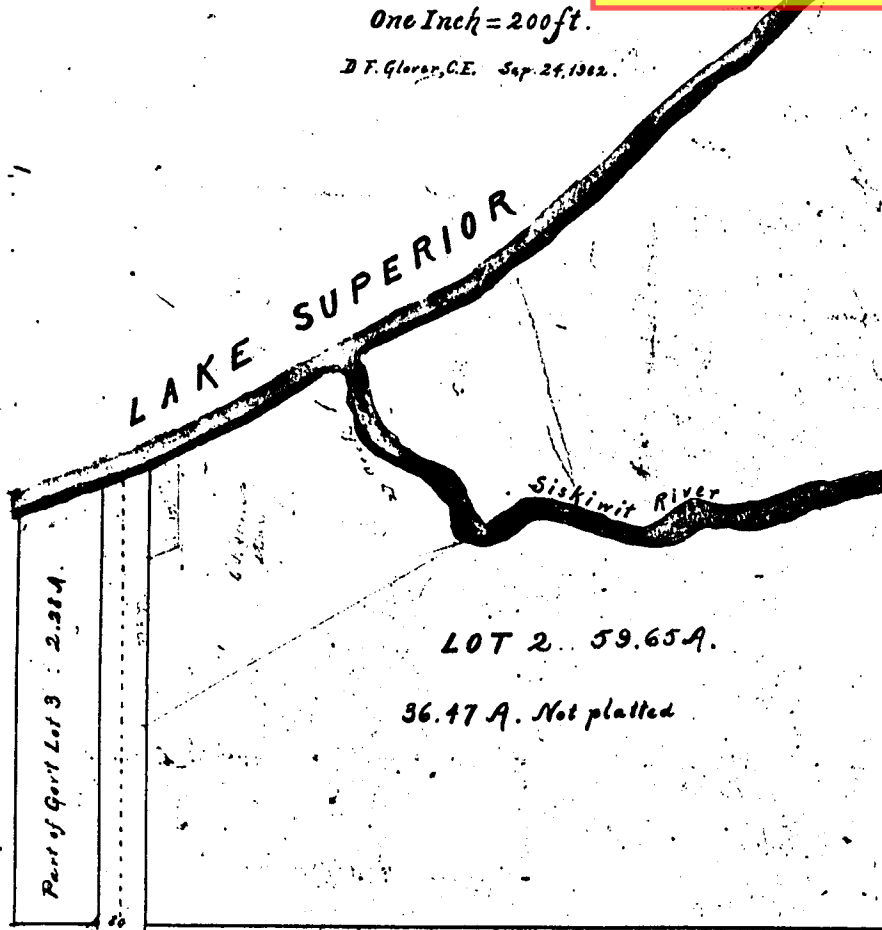

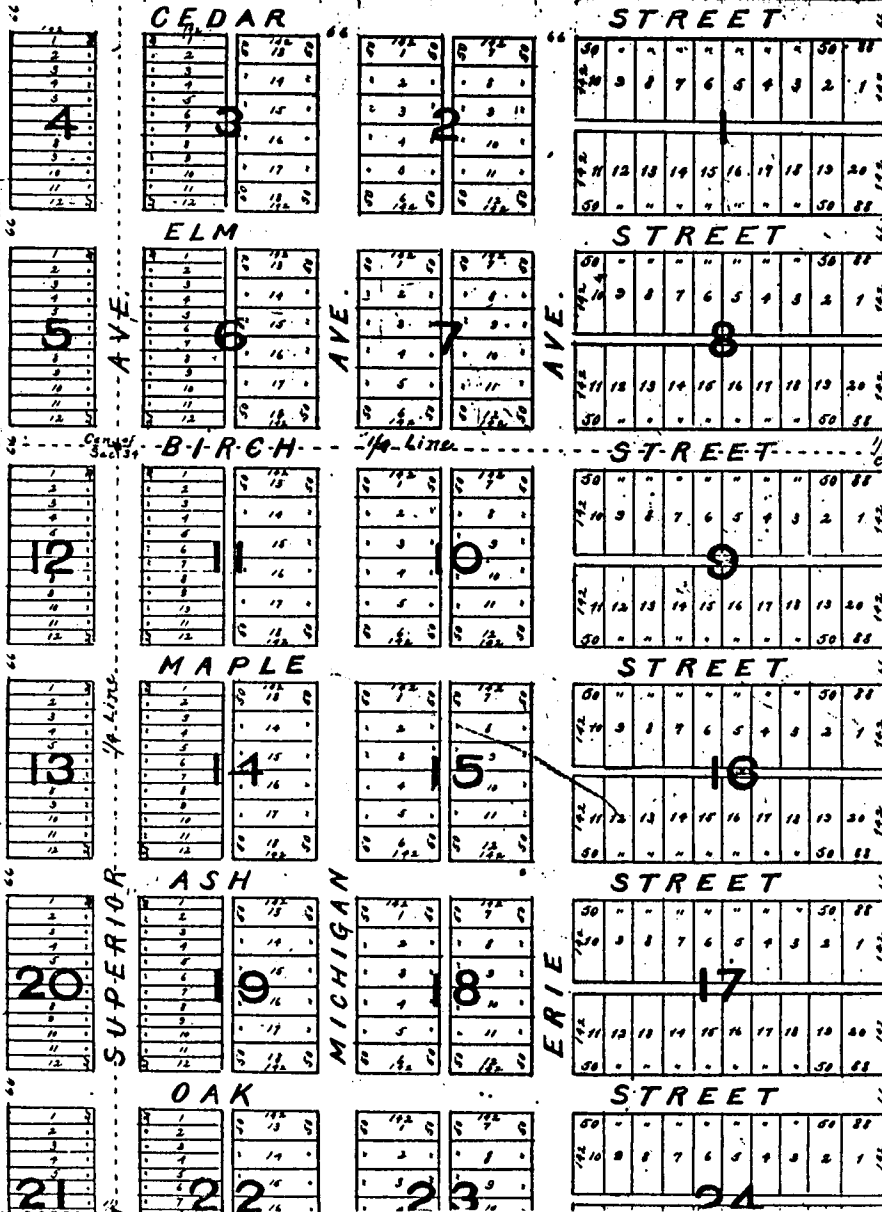

Description
 The Streets, Avenues and Alleys extend North and South and East and West according to Government Survey. The Streets and Avenues are 66 feet wide except Superior Avenues which is 80 feet wide - all alleys are 16 feet in width. The lots in Blocks 4, 5, 12, 13, 20 and 21, and in the West half of Blocks 3, 6, 11, 14, 19 and 22 are each 25 feet wide, and 142 feet long - all other lots are 50 feet wide and 142 feet long except lots 1 and 20 in Blocks 1, 8, 9, 16, 17 and 24, which are 88 feet wide and 146 feet long.

I hereby certify that the town of Cornucopia, Bayfield County, Wisconsin, herein surveyed and mapped comprises the following described lands, to wit: Lot Two (2) the North-West quarter of the Southeast quarter, also a piece of Land one hundred eleven (111) feet off the north side of the Southwest quarter of the Southeast quarter, a piece of Land one hundred eleven (111) feet wide north and south and one hundred eighty two (182) feet long in the northeast corner of the Southeast quarter of the Southwest quarter, also a piece of Land one hundred eighty two (182) feet wide off the East side of the Northeast quarter of the Southwest quarter and a piece of Land one hundred eighty two (182) feet wide off the East side of Lot Three (3), all in Section Thirty-four (34) Township Fifty-one (51) North of Range Six (6) West Fourth Principal Meridian. Thirty six and forty seven hundredths (36.47) acres in the north part of Lot Two (2) and two and twenty eight hundredths (2.28) acres in the northeast part of Lot Three (3) remaining in broad acres, the remaining portion of the above described lands is platted in Lots and Blocks, as shown on the face of this map.
