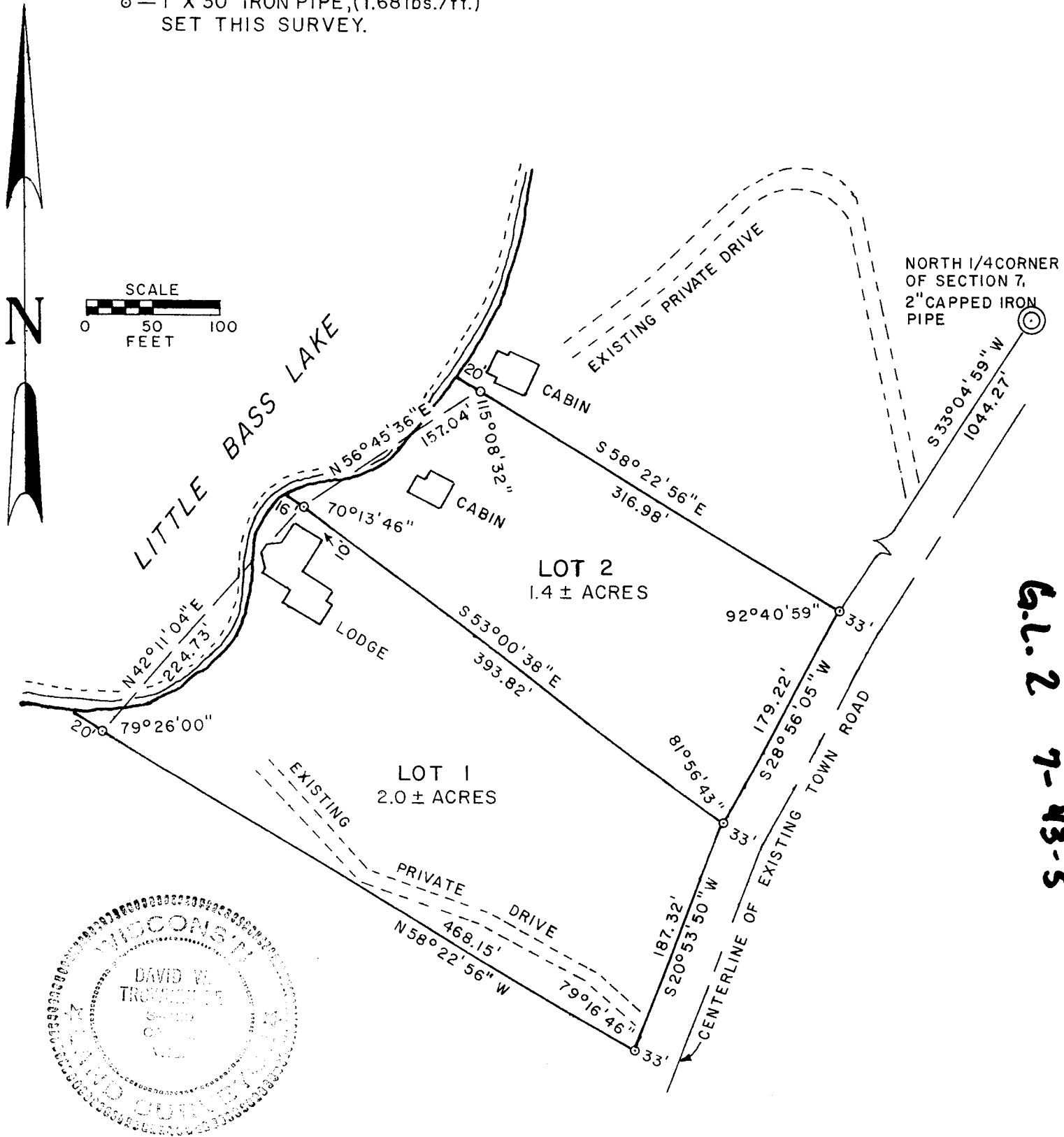

## SURVEYOR'S CERTIFICATE

I, Wayne Trowbridge, Registered Land Surveyor, do hereby  
certify;

That I have surveyed, divided and mapped part of Government  
Lot 2, Section 7, Township 43 North, Range 5 West, Town of  
Namakagon, Bayfield County, Wisconsin, bounded and described as  
follows:

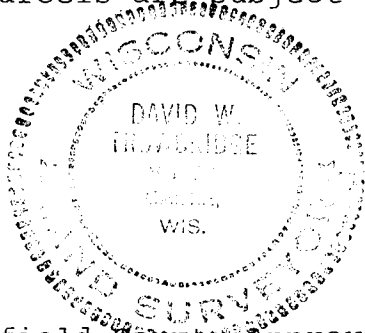
Commencing at the North 1/4 Corner of Section 7, T 43 N,  
R 5 W; thence S 33° 04' 59" W, 1044.27 feet to the Point of  
Beginning marked by a one inch iron pipe on the west Right-of-way  
of the Town Road; thence S 28° 56' 05" W, 179.22 feet along said  
west Right-of-way to a one inch iron pipe; thence S 20° 53' 50" W,  
187.32 feet along said west Right-of-way to a one inch iron pipe;  
thence N 58° 22' 56" W, 468.15 feet to a one inch iron pipe set  
20 feet from the shore of Little Bass Lake; thence on a meander  
line N 42° 11' 04" E, 224.73 feet to a one inch iron pipe set 16  
feet from said shore; thence on a meander line N 56° 45' 36" E,  
157.04 feet to a one inch iron pipe set 20 feet from said shore;  
thence S 58° 22' 56" E, 316.98 feet to the Point of Beginning;  
including all lands lying between the meander line and the waters  
edge of Little Bass Lake.

That I have made such survey and map by the direction of the  
owner of said lands; That such map is a correct representation of  
all exterior boundaries of the land surveyed and the subdivision  
thereof made. That I have fully complied with the provisions of
