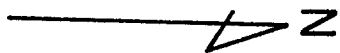
**BAYFIELD COUNTY - CERTIFIED SURVEY MAP**

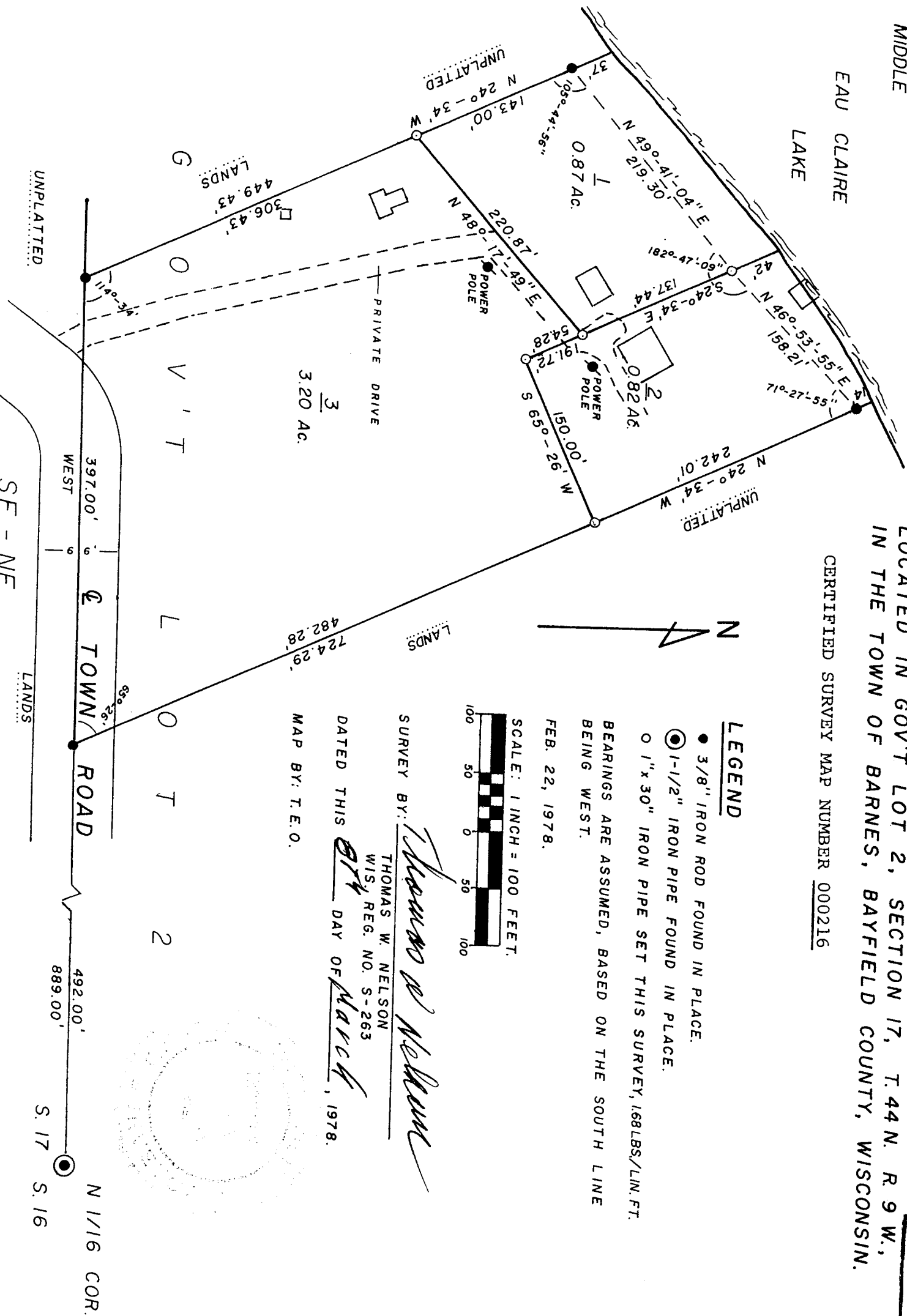
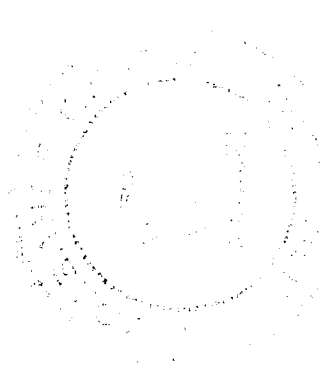

## SURVEYOR'S CERTIFICATE

I, Thomas W. Nelson, Registered Land Surveyor, hereby certify:

That on the order of James Clements, I have surveyed, divided and mapped the following described property located in Gov't. Lot 2, Section 17, T. 44N., R. 9 W., Town of Barnes, Bayfield County, Wisconsin.

To locate the Point of Beginning, commence at the SE corner of said Gov't. Lot 2, which is marked by a 1-1/2 inch iron pipe, and run West along the South line of said Gov't. Lot 2, 492.00 feet to a 3/8 inch rebar, which is the Point of Beginning.

Thence from said Point of Beginning by metes and bounds;

N.24°-34' W., 724.29 feet to a 3/8 inch rebar near the shore of Middle Eau Claire Lake (passing through a 1 inch iron pipe at 482.28 feet).

Thence along a meander line near the shore of Middle Eau Claire Lake, S. 46°-53'-55" W., 158.21 feet to a 1 inch iron pipe.

Thence S. 44°-41'-04" W., 219.30 feet to a 3/8 inch rebar.

Thence, leaving said meander line, S. 24°-34' E., 449.43 feet to a 3/8 inch rebar on the South line of said Gov't. Lot 2, (passing through a 1 inch iron pipe at 143.00 feet).


Thence East along said South line, 397.00 feet to the Point of Beginning.

Excluding that part of the Town Road lying within said described parcel.

Parcel includes that land lying between the meander line and the shore of Middle Eau Claire Lake and the extensions of the lot lines to said shore.

Parcel contains 4.89 acres.


