

YOUNG'S ASSESSORS PLAT

I, Fred A. Esch, Registered Land Surveyor, hereby certify that I have surveyed and mapped the above described plat in accordance with the provisions of Section 70.27 of the Wisconsin Statutes.

That the plat is a correct representation of all the exterior boundaries of the land surveyed and each parcel thereof; that I have fully complied with the provisions of Section 70.27 of the Wisconsin Statutes in surveying, monumenting and mapping the same.

That the description of the land surveyed is as follows:

Commencing at the N.E. corner of section 21, thence S 00° 40' E, 343.5 along the East section line thence S 86° 42' W, 343.16 along the South line of Gov't. lot 1 to the corner common to Gov't. lot 1 and the S.E. 1/4 of the N.E. 1/4 of a point on the East line of Gov't. lot 2, the point of beginning of this plat, and of the meter-bound descriptions of the parcels contained in this plat;

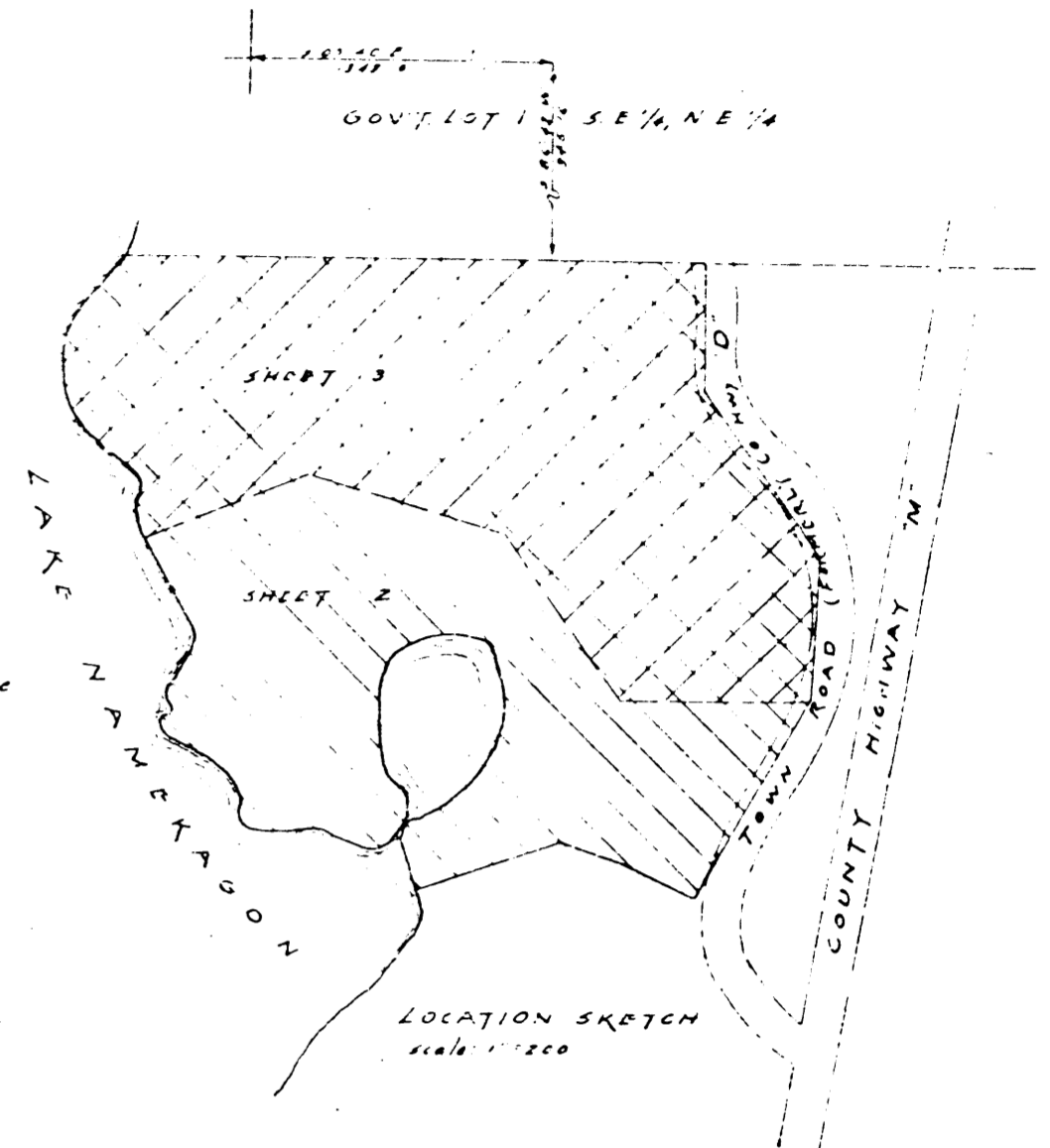
