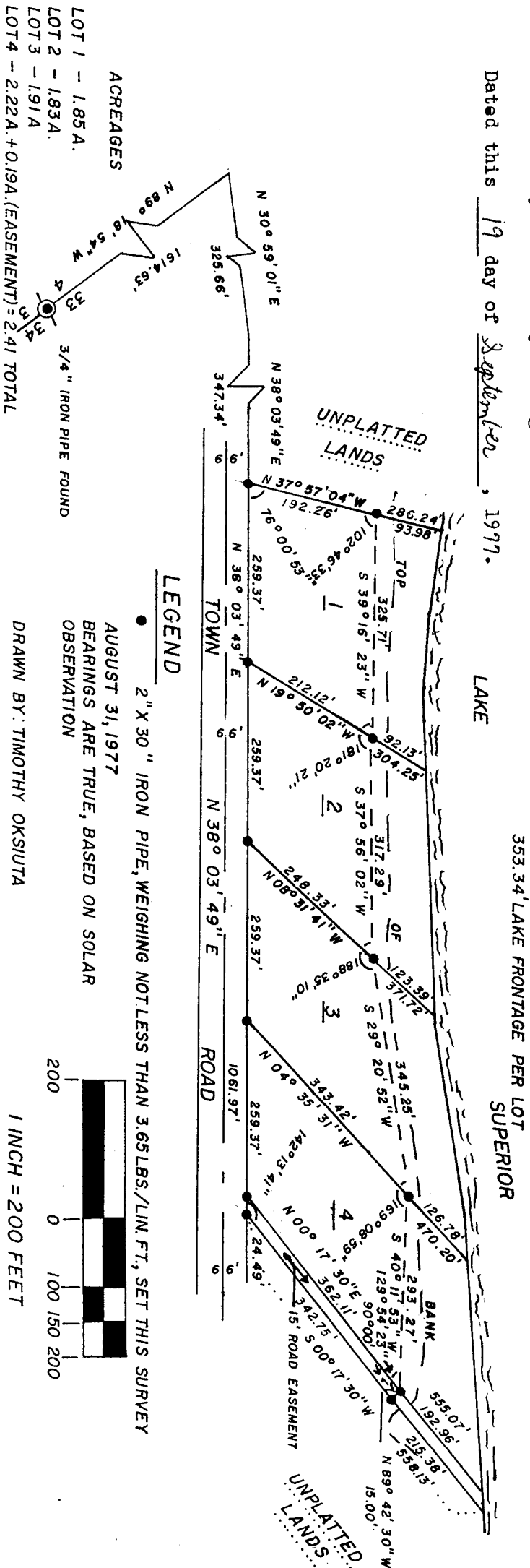
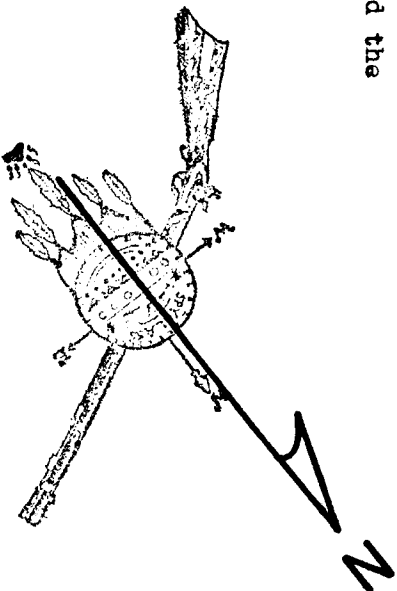

SURVEYOR'S CERTIFICATE

I, Thomas W. Nelson, Registered Land Surveyor, hereby certify:

That I have surveyed, divided, and mapped this certified survey located in Govt. Lot 1, Section 33, Township 51 North, Range 7 West, Town of Clover, Bayfield County, Wisconsin.

To locate the Point of Beginning, commence at the Southeast corner of said section 33, and run N 89°-18'-54" W, along the South line of said section 33, 1614.63 feet to a point on the Norhtwesterly Right-of-Way line of a town road. Thence along said Right-of-Way line N 30°-59'-01" E, 325.66 feet. Thence N 38°-03'-49" E, 347.34 feet to a 2 inch iron pipe which is the Point of Beginning.

Thence from said Point of Beginning by metes and bounds;

Leaving said Right-of-Way line, N 37°-57'-04" W, 192.26 feet to a 2 inch iron pipe which is 93.98 feet from the water's edge of Lake Superior. Thence along a meander line near the shore of Lake Superior, N 39°-16'-23" E, 325.71 feet to a 2 inch iron pipe. Thence N 37°-56'-02" E, 317.29 feet to a 2 inch iron pipe. Thence N 29°-20'-52" E, 345.25 feet to a 2 inch iron pipe. Thence N 40°-11'-53" E, 293.27 feet to a 2 inch iron pipe. Thence S 89°-42'-30" E, 15.00 feet to a 2 inch iron pipe which is 215.38 feet from the water's edge of Lake Superior. Thence leaving said meander line S 00°-17'-30" W, 342.75 feet to a 2 inch iron pipe on the Northwesterly Right-of-Way line of a town road. Thence S 38°-03'-49" W, along said Right-of-Way line 1061.97 feet to the Point of Beginning.


Parcel includes those lands ~~lying between the meander line~~ and the water's edge of Lake Superior and the extension of the North and South lot lines to said water's edge.
