Benande, owner of said land, I have surveyed, divided and mapped this certified survey; that such certified survey correctly represents all exterior boundaries and the subdivision of the land surveyed; and that this land is located in Government Lot Three (3), Section Thirty-five (35), Town Forty-four (44) North, Range Six (6) West, Town of Grandview, Bayfield County, to wit:

Beginning at a point on the West line of Government Lot 3, 2740.13 feet South 00°-36' East of the North Quarter corner of Section 35, thence South 00°-36' East, 764.34 feet to a point 170 feet, more or less, from the water's edge of Lake Namekagon, thence along the meander line along the lake, South 35°-16' East, 423.75 feet, thence South 16°-08' East, 222.87 feet, thence South 59°-08' East, 146.50 feet to a point 35 feet, more or less, from the water's edge of Lake Namekagon, and the end of the meander line, thence North 32°-08' East, 842.53 feet, thence North 56°-38' West, 518.29 feet, thence North 25°-35' West, 660.50 feet to the point of beginning, including all the land lying between the meander line and the water's edge of Lake Namekagon.

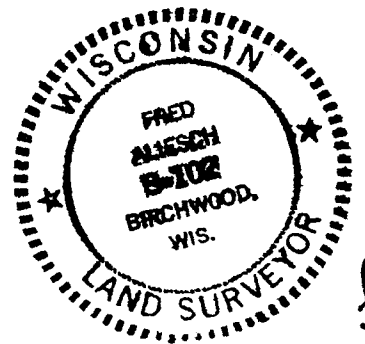
