SURVEYOR'S CERTIFICATE

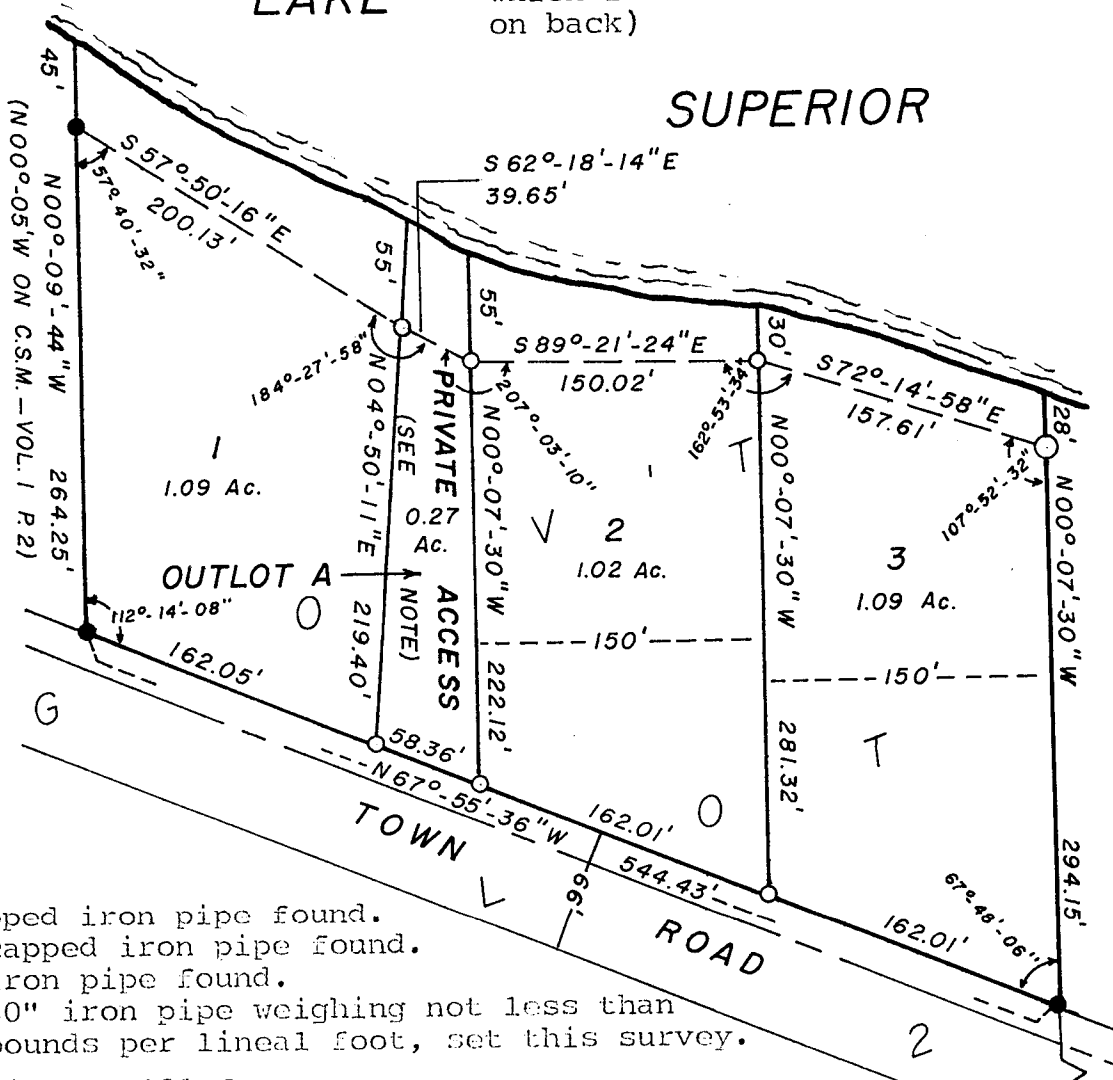
I, Larry T. Nelson, Registered Land Surveyor, hereby certify:

That I have surveyed, divided and mapped the following described parcel of land recorded on Certified Survey Map, Vol. 1, Page 2, located in Gov't Lot 2, Section 23, T. 51 N., R. 6 W., Bayfield County, Wisconsin, described as follows:

To locate the Point of Beginning commence at the SE corner of said Section 23 and run N 00°-11'-00" W, along the East line of Section 23, 1319.42 feet to a 1-1/4" capped iron pipe at the SE corner of Gov't Lot 1; Thence N 87°-57'-23" W, along the South line of Gov't Lot 1, 1305.63 feet to a 1-1/4" capped iron pipe at the SE corner of Gov't Lot 2; Thence N 00°-07'-30" W, along the East line of Gov't Lot 2, 1197.91 feet to a 3/4" iron pipe on the Northerly R.O.W. line of a Town Road which is the Point of Beginning. 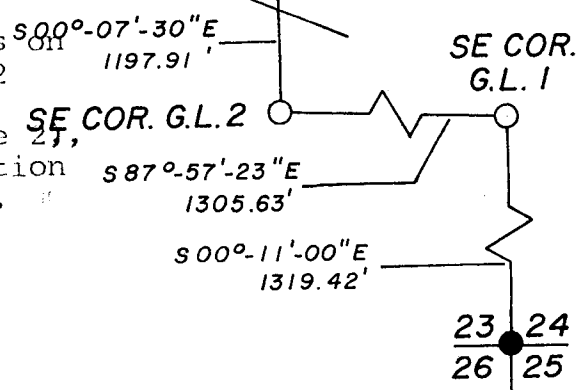
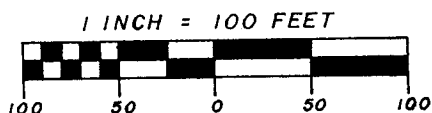

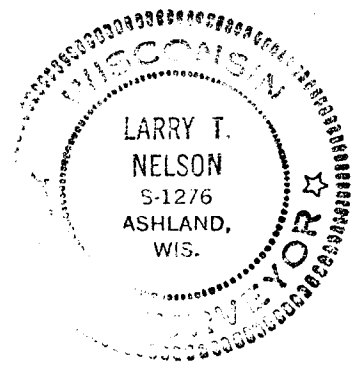

N 00°-07'-30" W, along the East line of Gov't Lot 2, 294.15 feet to a 1-1/4" capped iron pipe near the shore of Lake Superior; Thence along a meander line near the shore of Lake Superior N 72°-14'-58" W, 157.61 feet to a 1" iron pipe; Thence N 89°-21'-24" W, 150.02 feet to a 1" iron pipe; Thence N 62°-18'-14"W, 39.65 feet to a 1" iron pipe; Thence N 57°-50'-16" W, 200.13 feet to a 3/4" iron pipe; Thence leaving said meander line, S 00°-09'-44" E, 264.25 feet to a 3/4" iron pipe on the Northerly R.O.W. line of said Town Road; Thence S 67°-55'-36" E, along said Northerly R.O.W. line, 544.43 feet to the Point of Beginning.
