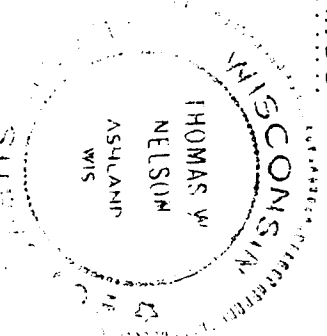
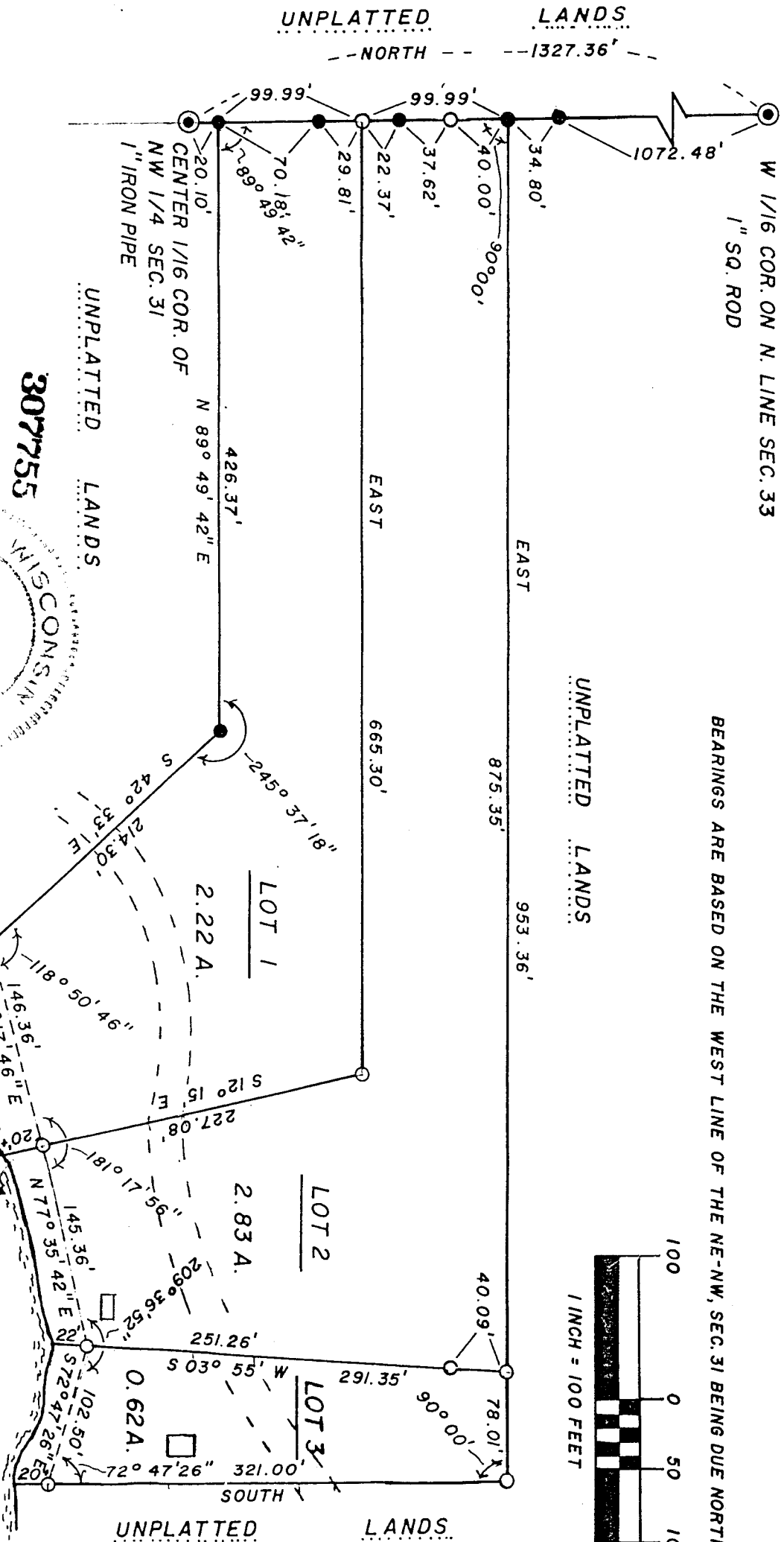
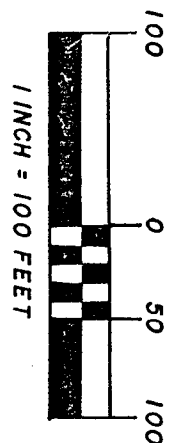

### SURVEYORS CERTIFICATE


I, Thomas W. Nelson, Registered land surveyor, hereby certify:

That on the order of Ronald Rogers, I made a survey of the following described property in the NE $\frac{1}{4}$  of the NW $\frac{1}{4}$  and part of the SE $\frac{1}{4}$  of the NW $\frac{1}{4}$ , Sec. 33, T. 47N., R. 8 W., Bayfield County, Wisconsin.

To locate the Point Of Beginning, commence at the W1/16 Corner on the North line of said Sec. 33; Thence run South along the West line of said NE-NW 1107.28 feet (passing through a 1" iron pipe at 1072.48.) which is the Point Of Beginning; Thence from the said Point Of Beginning by metes and bounds; East- 953.36' to a 1" iron pipe ( passing through a 1" iron pipe at 875.35'); Thence South - 321.00' to a 1" iron pipe; Thence N 72°-47'-26" W along a meander line 102.50' to a 1" iron pipe; Thence S 77° -35'-12" W 145.36' to a 1" iron pipe; Thence S 76°-17'-45" W 146.36' to a 1" iron pipe; Thence leaving said meander line N 42°-33'W 214.30' to a 1" iron pipe; Thence S 89°-49'-42" W 426.37' to a 1" iron pipe; Thence North along the West line of said NE-NW 199.98' (passing through iron pipes at 70.18', 99.99', 122.36 and 159.98') to a 1" iron pipe which is the Point Of Beginning; Intending to include those lands lying between the meander line and the Waters Edge of Bass Lake, and between the respective Lot lines extended to said Water's Edge.

Said parcel contains 5.67 acres more or less.
