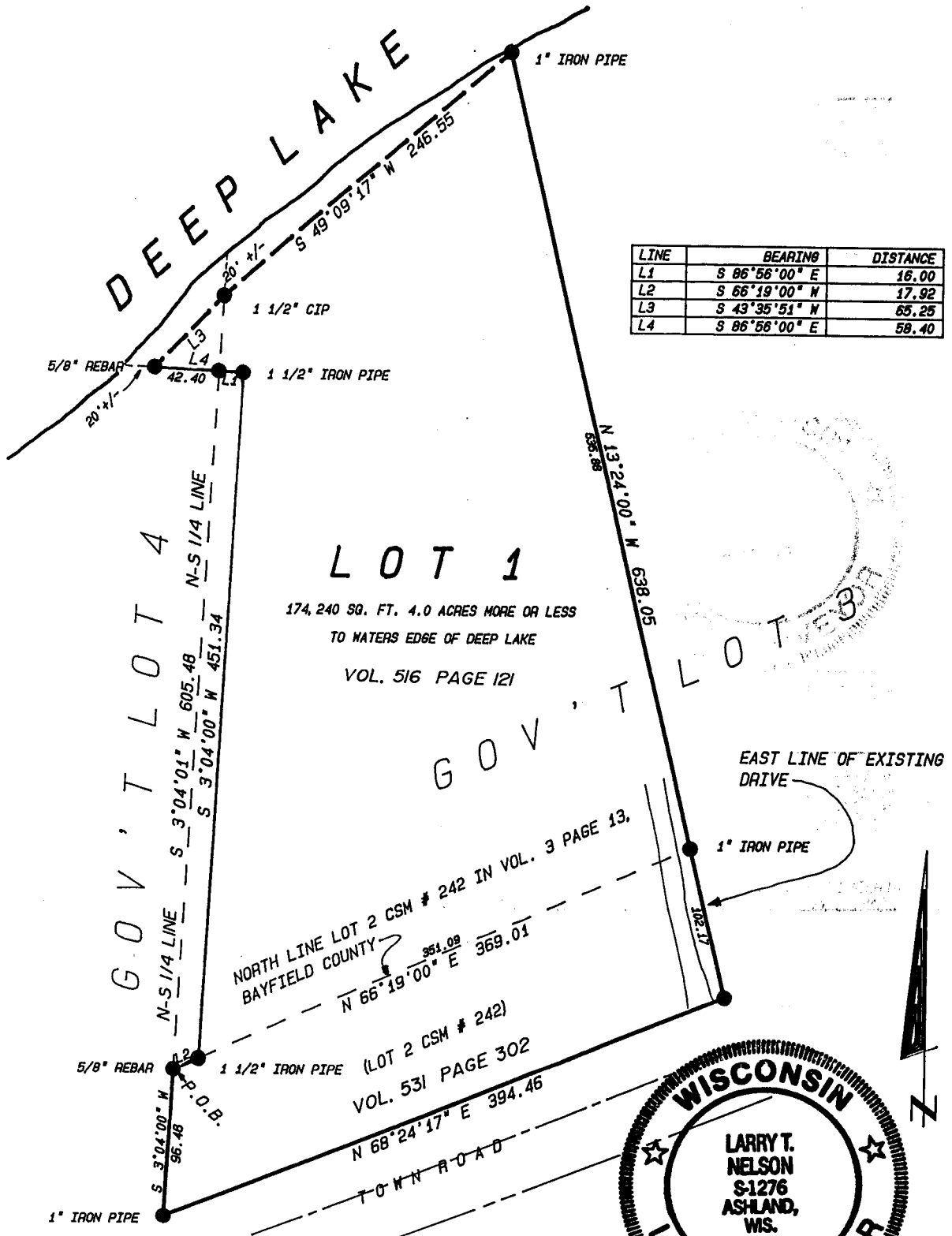

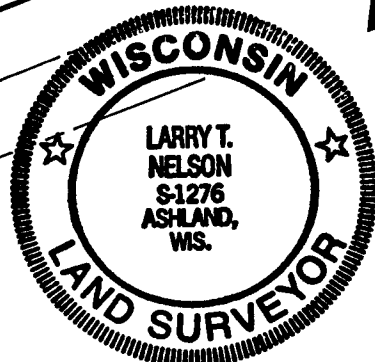

SURVEYORS CERTIFICATE:

I, Larry T. Nelson, Registered Land Surveyor in the State of Wisconsin, hereby certify:

That on the order of CECELIA JACKSON, I have made a survey of a parcel of land located in Government Lots 3 and 4, Section 14, Town 47 North, Range 9 West, in the Town of Hughes, Bayfield County, Wisconsin.

Beginning at the NW corner of Lot 2 of Certified Survey Map No. 242 as recorded in Vol. 3 page 13 in the Bayfield County Register of Deeds, run S 03°04'00" W, 96.48 feet to a 1 1/4" iron pipe on the north right-of-way of a Town Road; thence N 68°24'17" E, 394.46 feet along the north line of said Town Road to a 1 1/4" iron pipe on the east edge of a private drive; thence leaving said Town Road right-of-way, N 13°24'00" W, 638.05 feet to 1" iron pipe on the shore of Deep Lake; thence S 49°09'17" W, 246.55 feet, along a meanderline near the shore of Deep Lake, to a 1 1/2" capped iron pipe that is on the north - south 1/4 line of said Section 14 and is 20 feet, more or less, S 03°04'00" W from said shoreline; thence S 43°35'51" W, 65.25, feet along said meanderline, to a 5/8" reinforcing rod that is 20 feet, more or less, S 86°56'00" E of said shoreline; thence leaving said meanderline, S 86°56'00" E, 58.40 feet to a 1 1/2" iron pipe that is 16.00 feet east of the north-south 1/4 line of said Section; thence S 03°04'00" W, 451.34 feet; thence S 66°19'00" W 17.92 feet to the Point of Beginning.


