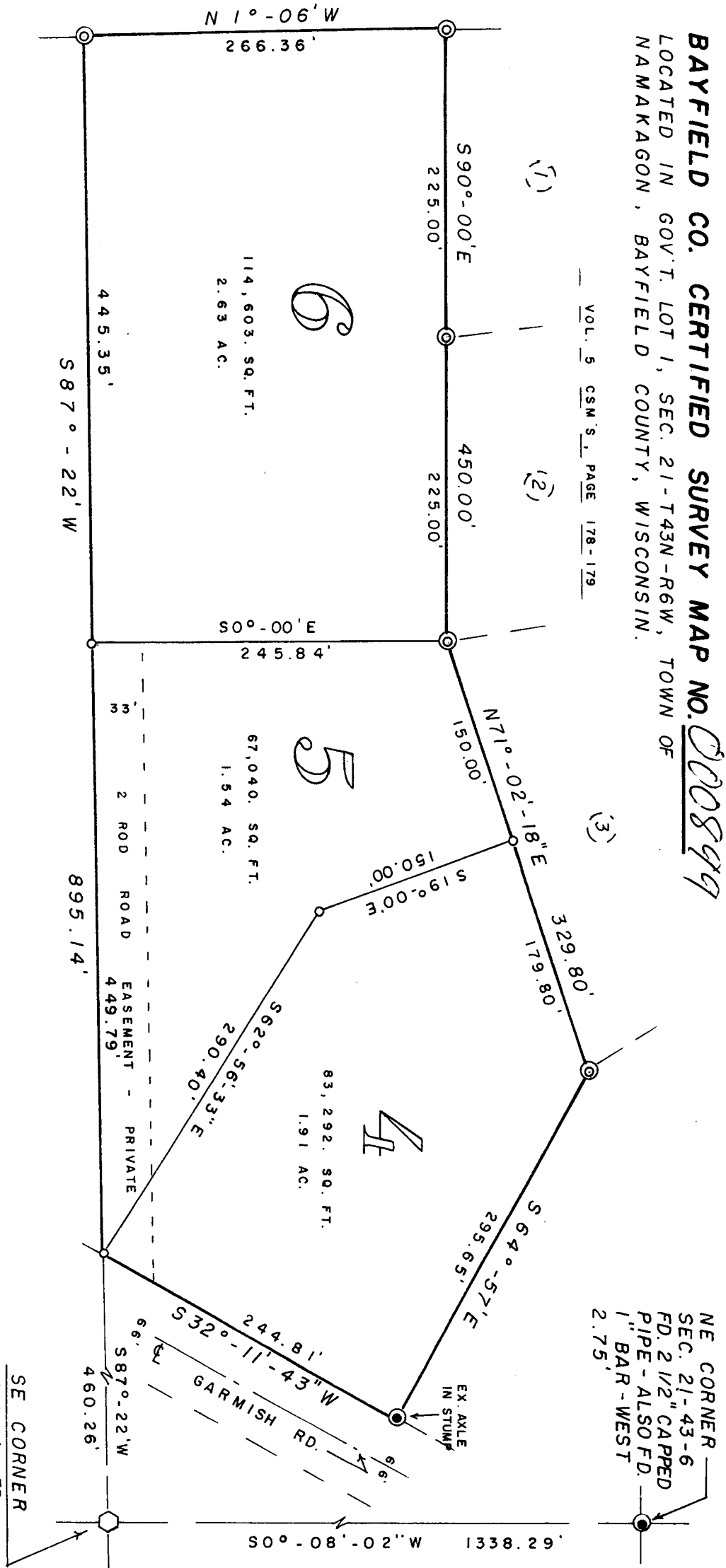

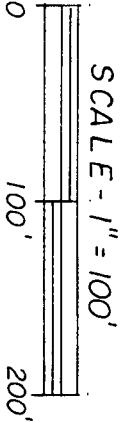
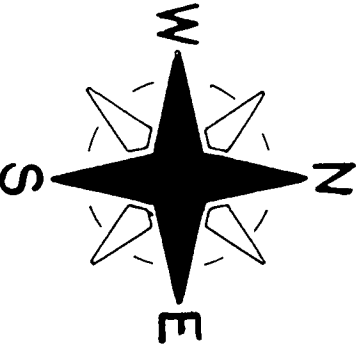

 NAMAKAGON, BAYFIELD COUNTY, WISCONSIN.

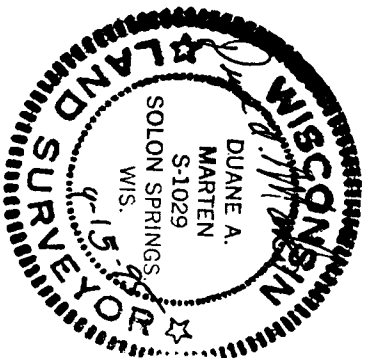

I, Duane A. Marten, Registered Land Surveyor, hereby certify:

That I have surveyed, divided and mapped that part of Gov't. Lot 1, Sec. 21-T43N-R6W, Town of Namakagon, Bayfield County, Wisconsin, bounded and described as follows;

Commencing at the NE corner of said Sec. 21; thence S0°-08'-02"W along the East line of the Sec., 1338.29 feet to the SE corner of Gov't. Lot 1; thence S87°-22'W along the South line of Gov't. Lot 1, 460.26 feet to the Northwesterly line of Garmish Road and the point of beginning; thence continuing S87°-22'W along said South line, 895.14 feet to the West line of Gov't. Lot 1; thence N1°-06'W along said West line, 266.36 feet; thence S90°-00'E, 450.00 feet; thence N71°-02'-18"E, 329.80 feet; thence S64°-57'E, 295.65 feet to the Northwesterly line of Garmish Road; thence S32°-11'-43"W along said Northwesterly line, 244.81 feet to the point of beginning. Subject to the Southerly 33 feet along the South lines of Lots 4 & 5 for ingress and egress purposes and all other easements and reservations of record.
