SURVEYOR'S CERTIFICATE

I, Larry T. Nelson, Registered Land Surveyor, hereby certify:

That on the order of THE ESTATE OF WILLIAM G. DARGIE, EDWARD FARNADY, PERSONAL REPRESENTATIVE, I have surveyed divided and mapped the following described parcel of land located in the NW $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 7, T. 47 N., R. 8 W., in the Village of Iron River, Bayfield County, Wisconsin.

To locate the Point of Beginning, commence at the East $\frac{1}{4}$ corner of said Section 7 and run N 88°-52'-42" W, 2089.99 feet; Thence N 89°-21'-15" W, 40.00 feet a 1 $\frac{1}{2}$ " iron pipe at the SE corner of Block 8 of Staples Addition to the Village of Iron; Thence S 04°-42'-30" W, along the Westerly Right-of-Way line of Main Street, 75.00 feet to a 3/4" iron rod, which is the Point of Beginning.

Thence from said Point of Beginning by metes and bounds:

Continue S 04°-42'-30" W, along said West Right-of-Way line, 201.91 feet to a 1 $\frac{1}{4}$ " iron pipe on the Northerly Right-of-Way line of the Northern Pacific Railroad; Thence N 85°-21'-10" W, along said Northerly Right-of-Way line, 142.08 feet to a 1" iron rod; Thence N 03°-18'-59" E, 191.59 feet to a 1 $\frac{1}{4}$ " iron pipe; Thence S 89°-23'-45" E, 147.11 feet to the Point of Beginning.

Parcel contains 0.65 Acres.

That this Certified Survey Map is a correct representation of all the exterior boundaries of the land surveyed and the subdivision thereof.
