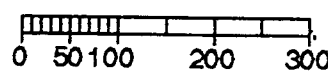

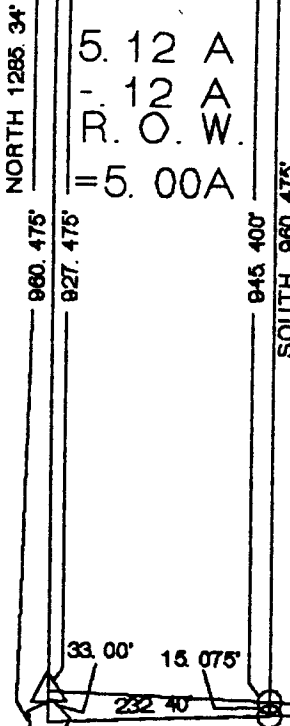


○ 1" O. D. X 24" lg. (min.) IRON PIPE PLACED NORTH

PARCEL DESCRIPTIONS:

The Southwest One-Quarter of the Northwest One-Quarter of Section 14, Township 43 North, Range 7 West of the Fourth Principle Meridian, Town of Cable, Bayfield County, Wisconsin, more particularly described as follows: Commencing at the One-Quarter Corner common to Sections 14 and 15-43N-7W marked by an aluminum Bayfield County survey monument in the center of "Old "D" Road"; Thence North, 1285.34 feet to a 1" O.D. iron pipe marking the North One-Sixteenth Corner common to said Sections 14 and 15; Thence North 88d 05' 39.4" East, 1346.07 feet to a 1" O.D. iron pipe marking the Northwest One-Sixtyfourth Corner of said Section 14-43-7; Thence South 03' 39" East, 1274.62 Feet to a 1" O.D. iron pipe marking the Center West One-Sixteenth Corner of said Section 14-43-7; Thence South 87d 38' 29.4" West, 1345.11 feet to the aluminum survey monument at the West One-Quarter Corner, which is the point-of-beginning. With a 5.00 acre parcel in the Southwest Corner described as follows: Commencing at the West One-Quarter Corner of said Section 14-43N-7W marked by an aluminum Bayfield County Survey Monument in the center of "Old "D" Road", which is the point-of-beginning; Thence North, 960.475 feet to a 1" O.D. iron pipe, said line passing through a steel post with a survey marker sign at 33.00 feet; Thence North 87d 38' 29.4" East 232.40 feet to a 1" O.D. iron pipe; Thence South 960.475 feet to a 1" O.D. iron pipe on the East-West Quarter Line of said Section 14, said line passing through a 1" O.D. iron pipe at 945.400 feet marking the North right-of-way line of "Old "D" Road"; Thence South 87d 38' 29.4" West, 232.40 feet to the said West One-Quarter Corner, which is the point-of-beginning. Said "Forty" and 5.00 Acre parcel being subject to any/all easements and reservations of record.
