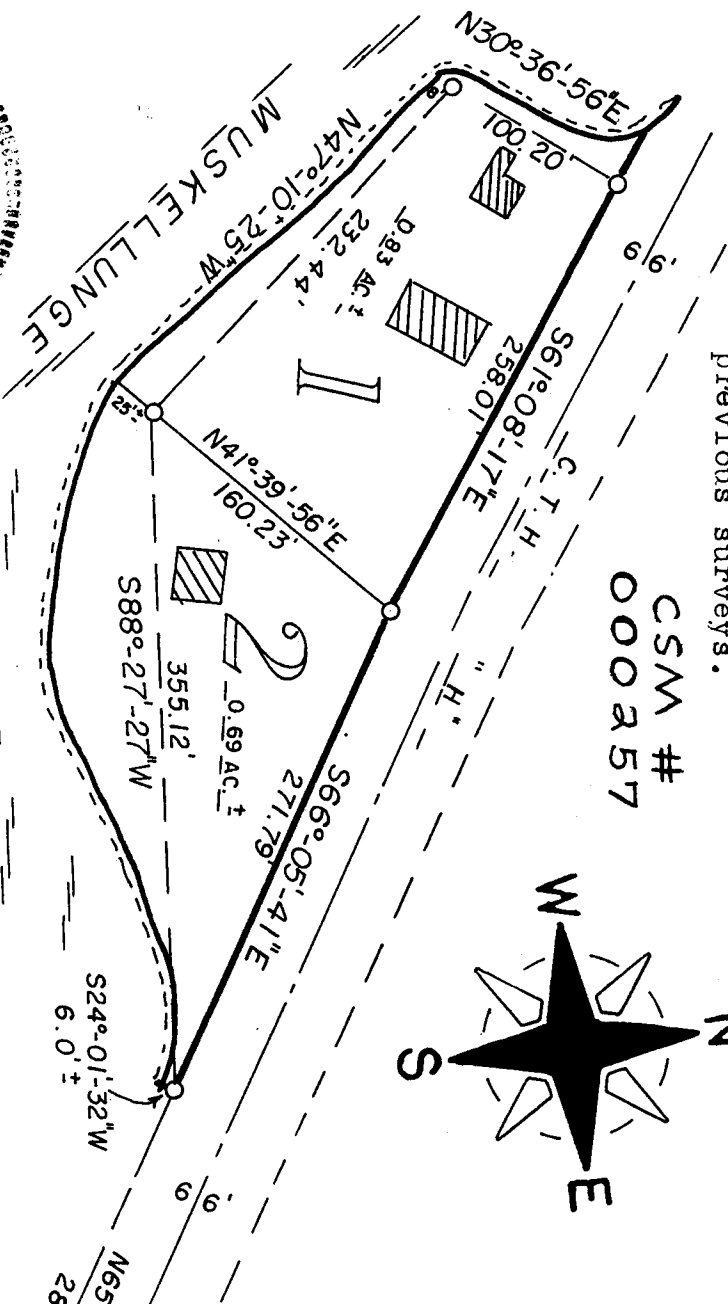
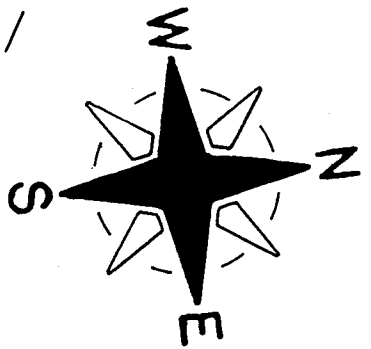

SURVEYOR'S CERTIFICATE

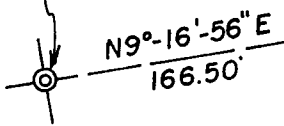
I, Duane A. Marten, Registered Land Surveyor, hereby certify: That I have surveyed divided and mapped that part of the NW 1/4-NE 1/4, Sec. 4-T46N-R8W, Town of Delta, Bayfield County, Wisconsin, bounded and described as follows:

Commencing at the SE corner of the NW 1/4-NE 1/4 of said Sec. 4; thence N90°-16'-56"E 166.50 feet to an iron pipe; thence N65°-58'-28"W, 286.85 feet to an iron pipe; and the point of beginning; thence S24°-01'-32"W, 6.0 feet, more or less, to the water's edge of Muskellunge Lake; thence N24°-01'-32"E, 6.0 feet, more or less, to aforesaid iron pipe; thence S88°-27'-27"W along a meanderline, 355.12 feet to an iron pipe; thence N47°-10'-25"W, along a meanderline, 232.44 feet to an iron pipe; thence N30°-36'-56"E along a meanderline, 100.20 feet to an iron pipe and the Southerly line of C.T.H. "H"; thence S61°-08'-17"E along said Southerly line, 258.01 feet to an iron pipe; thence S66°-05'-41"E along said Southerly line, 271.79 feet to an iron pipe and the point of beginning.
