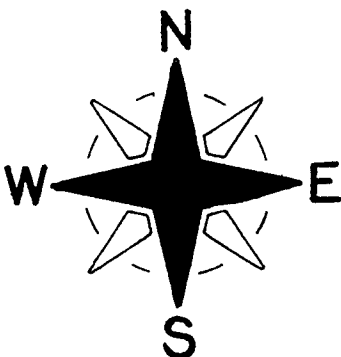
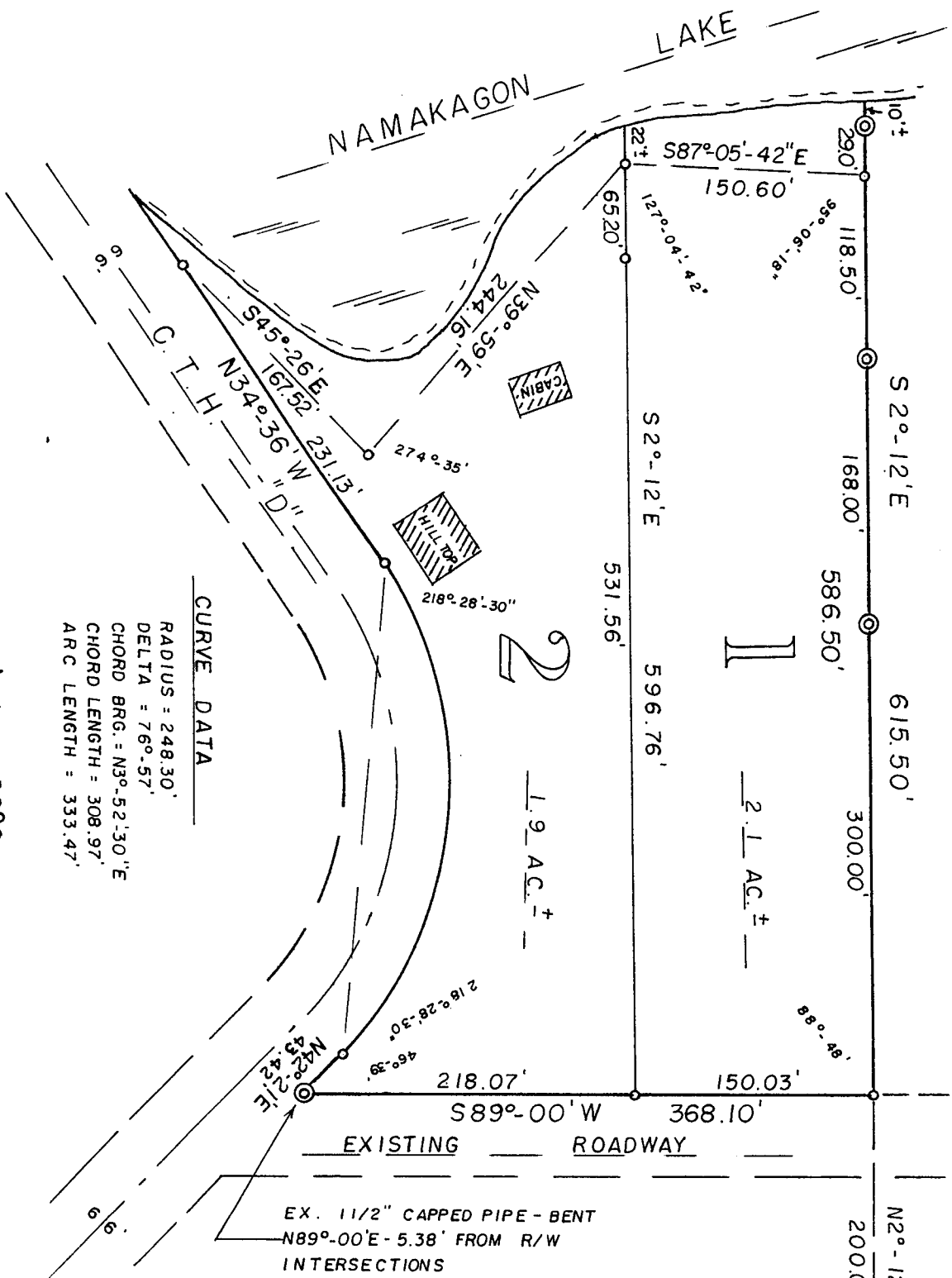
EAST LINE SEC. 10 ASSUMED TO BEAR N2°-12'W.

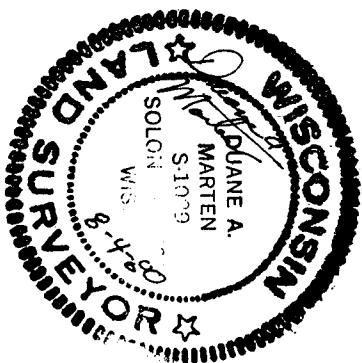
E1/4 CORNER

## SURVEYOR'S CERTIFICATE

I, Duane A. Marten, Registered Land Surveyor, hereby certify:

That I have surveyed, divided and mapped that part of Gov't. Lot 5, Sec. 10-T43N-R6W, Town of Namakagon, Bayfield County, Wisconsin, bounded and described as follows:

Commencing at the E<sup>1</sup> corner of said Sec. 10; thence N20-12'W along the East line of said Sec. 10, 200.00 feet to the point of beginning; thence S890-00'W along the North boundary of a roadway, 368.10 feet to the East line of C.T.H. "D"; thence N420-21'E along said East line, 43.42 feet; thence along said East line on a curve concave to the NW and having a radius of 248.30 feet (the chord of which bears N30-52'-30"E, 308.97 feet); a distance of 333.47 feet; thence N340-36'W along said Easterly line of C.T.H. "D", 231.13 feet; thence S450-26'E along a meanderline on Namakagon Lake, 167.52 feet; thence N390-59'E along a meanderline, 244.16 feet; thence S870-05'-42"E along a meanderline, 150.60 feet to a point 39 feet, more or less, from the water's edge of Namakagon Lake and being on the East line of said Sec. 10; thence S20-12'E along said East line, 586.50 feet to the point of beginning. Including all lands lying between the above described meanderline and the water's edge of Namakagon Lake.

That such plat is a correct representation of all exterior boundaries of the land surveyed and the subdivision thereof made.

That I have made such survey, land division and plat by the order and under the direction of Mr. John Dean.

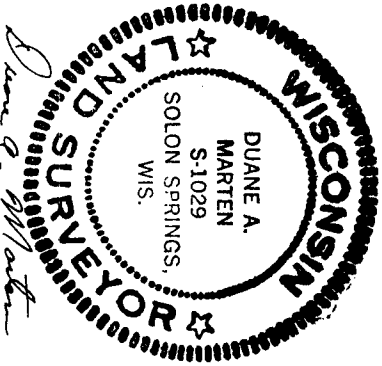
