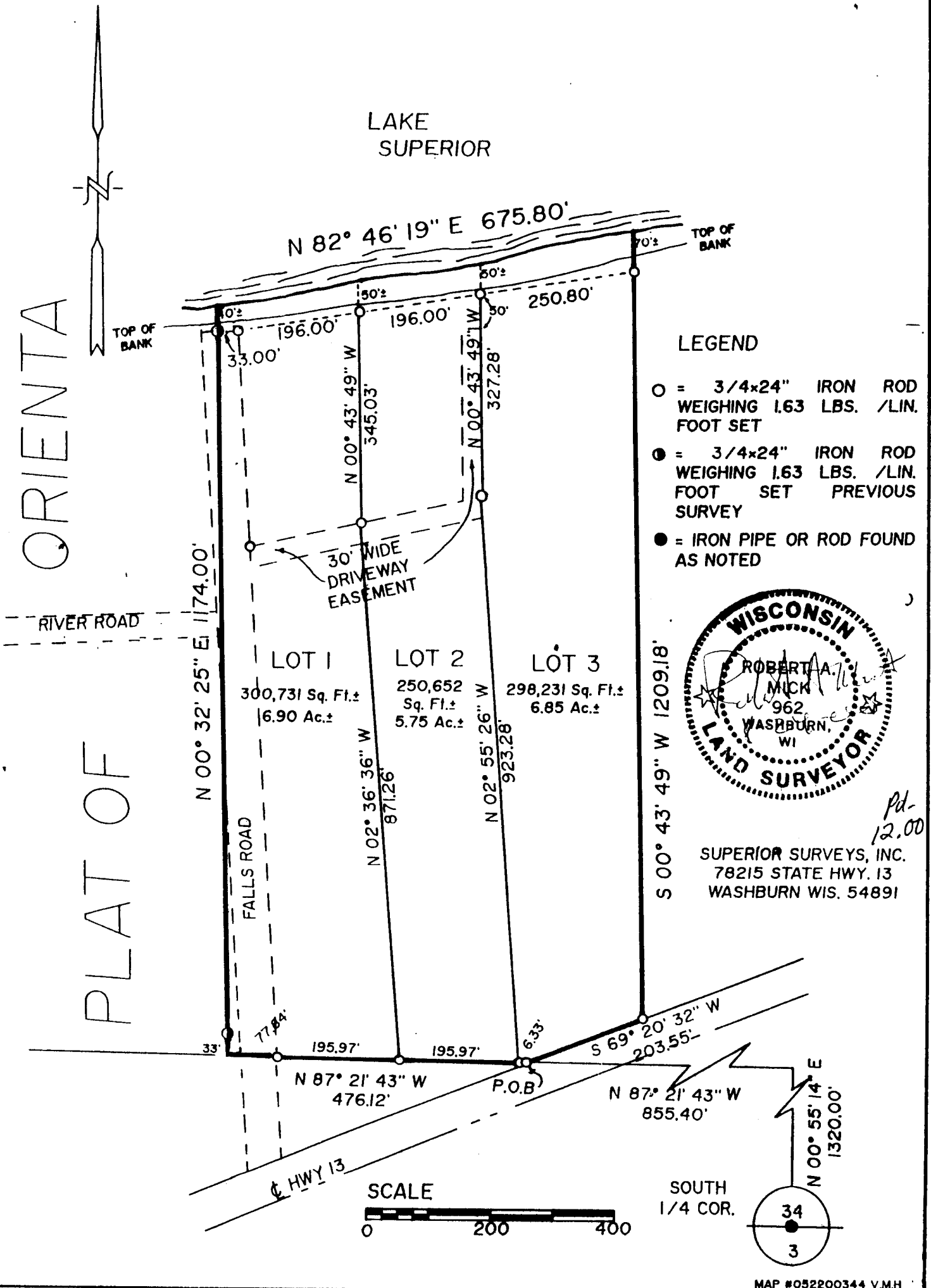

CERTIFICATE OF SURVEY

I, Robert A. Mick, Registered Land Surveyor in the State of Wisconsin, hereby certify:

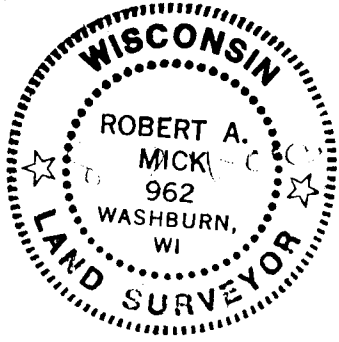
That on the order of **REBECCA POSNER**, I have surveyed and mapped the following parcel of land located in Govt. Lot 3, Section 34, T50N, R9W, Town of Orienta, Bayfield County, Wisconsin, described as:

Commencing at the quarter corner common to Sections 3 & 34; thence N00°55'14"E 1320.00 feet; thence N87°21'43"W 855.40 feet to a point located on the Northerly edge of State Hwy. 13 which is the POINT OF BEGINNING; thence continuing N87°21'43"W 476.12 feet; thence N00°32'25"E 1174.00 feet to an iron rod which marks the beginning of a meander line to Lake Superior; said line continues N00°32'25"E to the water's edge; thence N82°46'19"W 675.80 feet along said meander line to an iron rod which marks the ending of said meander line; thence S00°43'49"W 1209.18 feet to a point located on the Northerly right-of-way of State Hwy. 13; thence along said right-of-way S69°20'32"W 203.55 feet to the POINT OF BEGINNING; said line also runs N00°43'49"E to the water's edge; containing 849,614 square feet, which is 19.5 acres, including all land between the meander line and the water's edge, and part of right-of-way of Falls Road, and is subject to road and any other easements of record.

That such plat is a true representation of said survey;

That I have fully complied with Chapter 236.34 of the Wisconsin Statutes and the Bayfield County Subdivision Control Ordinance in making the same; and
