Part of Gov't. Lot 9 and all of Gov't. Lots 8 and 13 of Section 28, Township 44 North, Range 7 West, Town of Drummond, Bayfield County, Wisconsin.

I, Ladd D. Gould, Registered Land Surveyor, do hereby certify:

That I have surveyed, divided and mapped part of Gov't. Lot 9 and all of Gov't. Lots 8 and 13 of Section 28, T 44 N, R 7 W, Town of Drummond, Bayfield County, Wisconsin, bounded and described as follows:

Commencing at a brass capped iron pipe marking the East 1/4 Corner of Section 28, T 44 N, R 7 W; thence S 86° 45' 43" W, 262.12 feet to an existing iron pipe; thence S 71° 10' 14" W, 1021.12 feet to an existing iron pipe and the Point of Beginning; thence S 2° 50' 15" E, 151.42 feet to a 1¼ inch iron pipe; thence S 86° 08' 12" W, 304.85 feet to a 1¼ inch iron pipe; thence N 4° 34' 04" W, 203.58 feet to a 1¼ inch iron pipe; thence N 70° 05' 19" W, 378.67 feet to a 1¼ inch iron pipe; thence N 7° 55' 31" W, 196.99 feet along the meander line of Lake Owen to a 1¼ inch iron pipe; thence N 1° 47' 51" W, 174.55 feet along the meander line of Lake Owen to a 1¼ inch iron pipe; thence N 32° 53' 47" E, 57.57 feet along the meander line of Lake Owen to a 1¼ inch iron pipe; thence S 46° 27' 54" E, 195.46 feet along the meander line of Lake Owen to a 1¼ inch iron pipe; thence S 40° 14' 19" E, 199.22 feet along the meander line of Lake Owen to a 1¼ inch iron pipe; thence N 82° 46' 04" E, 288.50 feet along the meander line of Lake Owen to a 1¼ inch iron pipe; thence S 41° 10' 43" E, 156.80 feet along the meander line of Lake Owen to an existing iron pipe; thence S 2° 50' 15" E, 209.91 feet to the Point of Beginning, including all of the lands between the meander line and lot lines extended to the waters edge of Lake Owen; also, the following private drive easement, Said easement being 20 feet wide, 10 feet each side of the following described traverse: Commencing at a brass capped iron pipe marking the East 1/4 Corner of Section 28, T 44 N, R 7 W, thence S 82° 07' 20" E, 291.46 feet to a steel pin which marks the end of an existing Town Road laid out and traveled January 1, 1979 and the Point of Beginning of said driveway easement. Thence S 55° 51' 37" W, 391.42 feet to a steel pin; thence S 29° 50' 37" W, 572.33 feet to a steel pin; thence S 38° 48' 14" W, 135.42 feet to a steel pin; thence S 81° 23' 57" W, 643.71 feet to a steel pin; thence N 77° 32' 39" W, 421.40 feet to a steel pin; thence N 81° 27' 09" W, 218.00 feet to a steel pin; thence N 4° 18' 24" W, 170.00 feet to a steel pin marking the end of the driveway easement held in common by said owners of Lots 1 and 2. At this point the driveway easement splits, thence to Lot 1 commencing at the end of the easement held in common by said owners of Lots 1 and 2; thence N 25° 44' 39" W, 106.00 feet to a steel pin; thence N 7° 42' 23" W, 124.70 feet to a steel pin; thence N 28° 50' 36" W, 104.00 feet to a steel pin; thence N 31° 09' 11" W, 124.70 feet to a steel pin; thence N 17° 45' 52" W, 135.00 feet to a steel pin within the boundaries of Lot 1 and the Point of Ending of the driveway easement to Lot 1. Thence to Lot 2 commencing at the end of the easement held in common by said owners of Lots 1 and 2; thence N 8° 52' 51" W, 141.27 feet to a steel pin; thence N 0° 06' 12" W, 194.85 feet to a steel pin; thence N 31° 49' 30" E, 232.08 feet to a steel pin within the boundaries of Lot 2 and the Point of Ending of the driveway easement to Lot 2.

That I have made such survey and map by the direction of the owner of said lands; That such map is a correct representation of all exterior boundaries of the land surveyed and the subdivision
