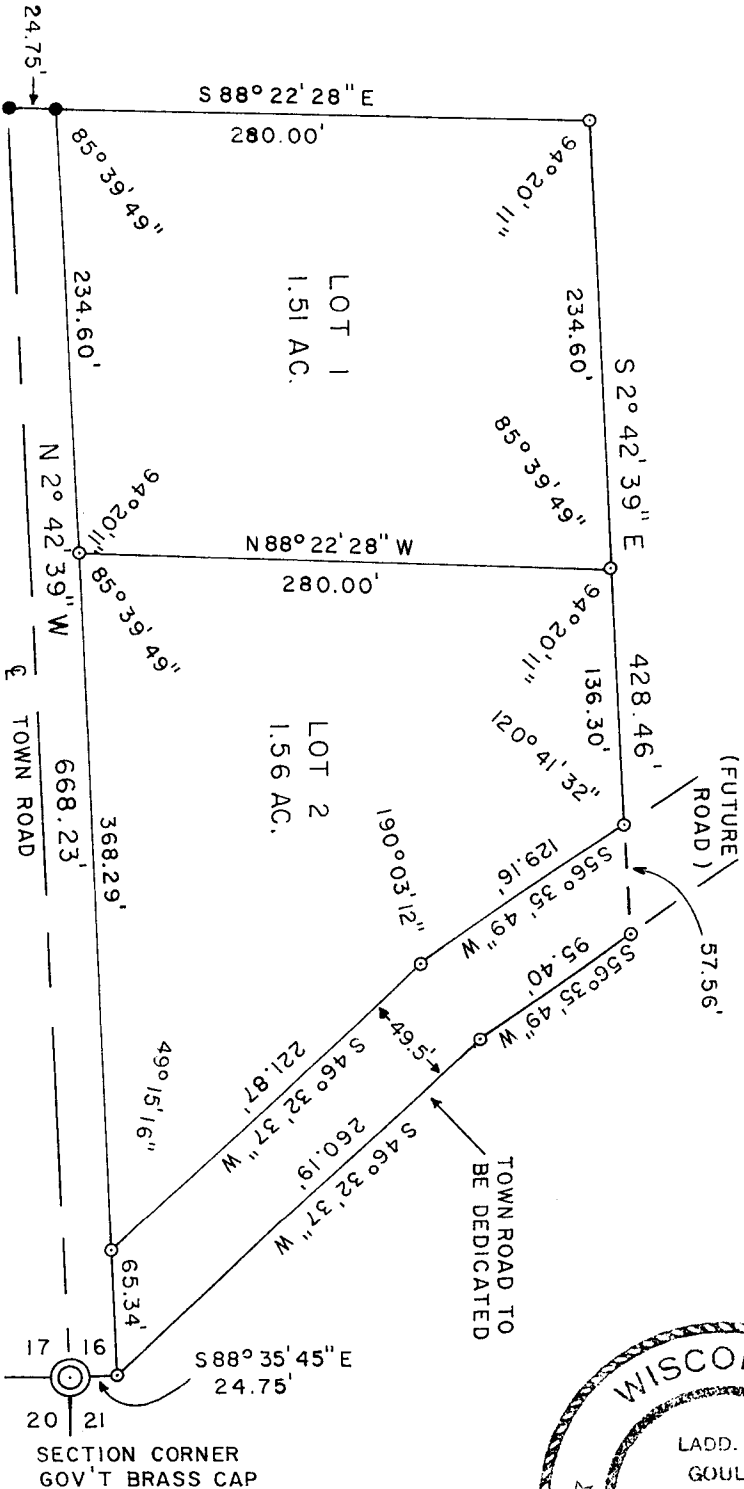

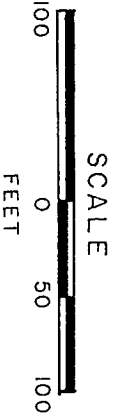

That I have surveyed, divided and mapped part of the SW $\frac{1}{4}$ -SW $\frac{1}{4}$ ,  
Section 16, T 43 N, R 7 W, Town of Cable, Bayfield County, Wisconsin,  
bounded and described as follows:

Commencing at a brass capped iron pipe marking the Southwest  
Section Corner of Section 16, T 43 N, R 7 W; thence S 88° 35' 45" E,  
24.75 Feet to a 1 inch iron pipe and the Point of Beginning; thence  
N 2° 42' 39" W, 668.23 feet to a 1 inch iron pipe; thence S 88° 22' 28" E,
