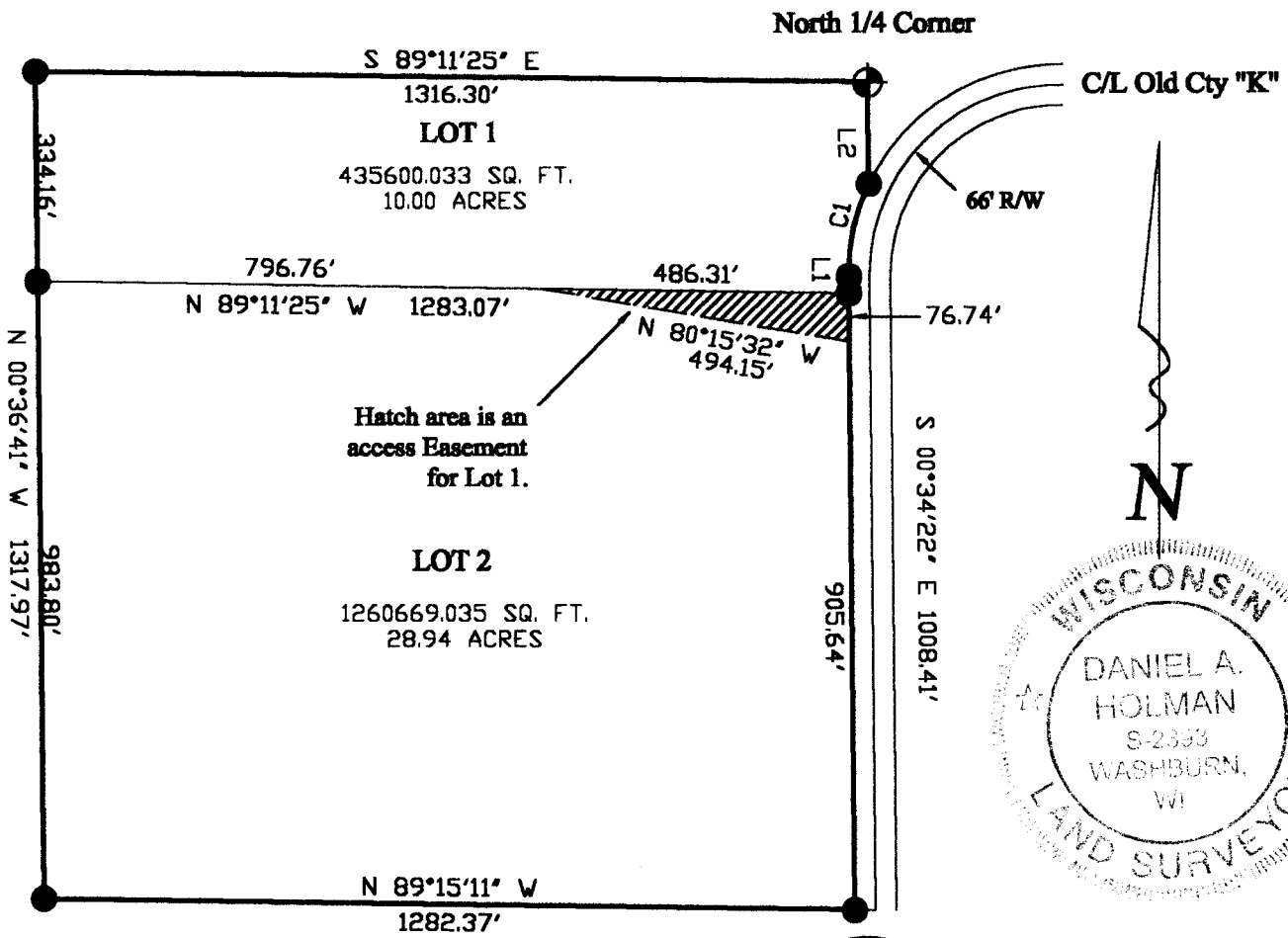

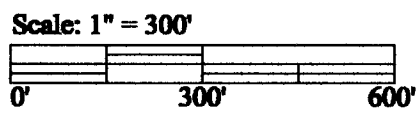

Beginning at the N ¼ of said Section 8; thence S 00°34'22" E 162.80'; thence along the arc of a curve to the left having a Radius of 333.00' a Central Angle of 25°43'24" a Chord Bearing of S 12°17'20" W 148.25' and an Arc Length of 149.50'; thence S 00°34'22" E 26.03'; thence N 89°11'25" W 1283.07'; thence N 00°36'41" W 334.16'; thence S 89°11'25" E 1316.30' to the Point of Beginning. Parcel contains 435600.00 SQ. FT., 10.00 Acres.

Access Easement for Lot 1: Commencing at the N ¼ of said Section 8; thence S 00°34'22" E 162.80'; thence along the arc of a curve to the left having a Radius of 333.00' a Central Angle of 25°43'24" a Chord Bearing of S 12°17'20" W 148.25' and an Arc Length of 149.50'; thence S 00°34'22" E 26.03' to the Point of Beginning; thence S 00°34'22" E 76.74'; thence N 80°15'32" W 494.15'; thence S 89°11'25" E 486.31' to the Point of Beginning. 

Parcel contains 1260669.035 SQ. FT., 28.94 Acres.

That said map is a correct representation of the exterior boundaries of the land surveyed and the subdivision thereof made.

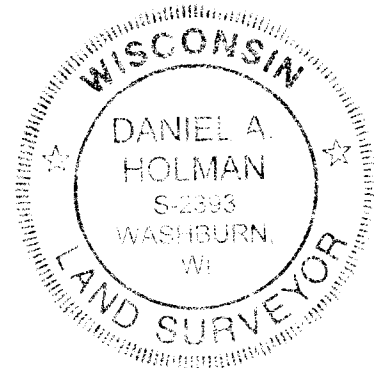
