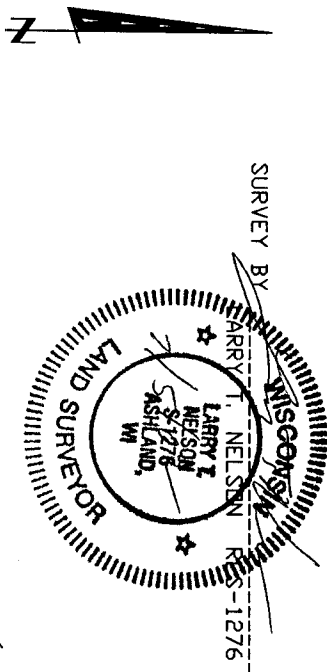

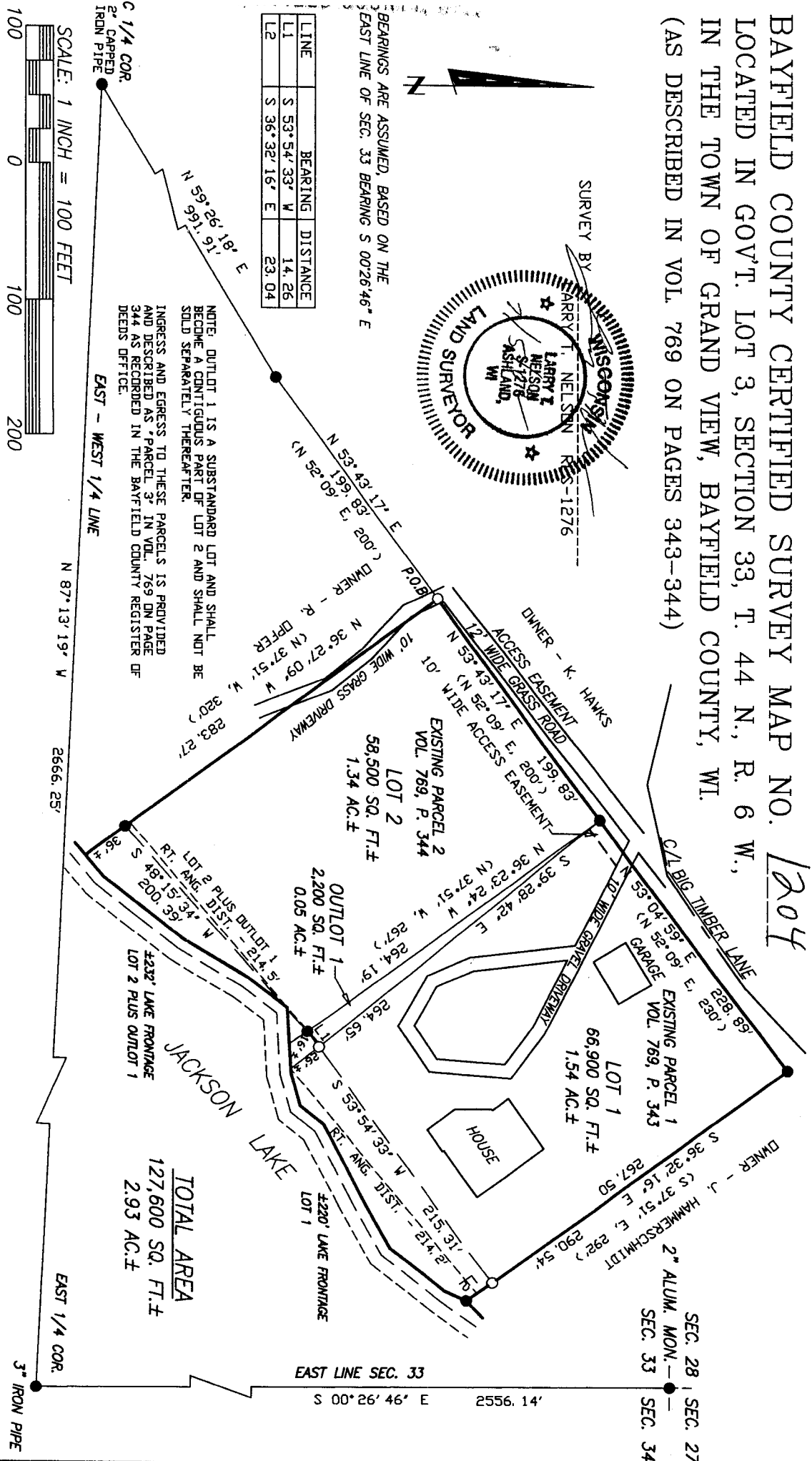

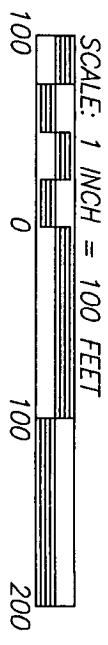

THAT ON THE ORDER OF DAVE REICHERT, OWNER, I HAVE SURVEYED, DIVIDED AND MAPPED THE FOLLOWING DESCRIBED PARCEL OF LAND LOCATED IN GOV'T. LOT 3, SECTION 33, T. 44 N., R. 6 W., IN THE TOWN OF GRAND VIEW, BAYFIELD COUNTY, WISCONSIN;

TO LOCATE TO POINT OF BEGINNING COMMENCE AT THE NE CORNER OF SAID SECTION 33 AND RUN ALONG THE EAST LINE OF SAID SECTION 33, S 00°26'46" E, 2556.14 FEET TO THE EAST 1/4 CORNER OF SAID SECTION 33; THENCE ALONG THE MONUMENTED EAST - WEST 1/4 LINE OF SECTION 33, N 87°13'19" W, 2666.25 FEET TO THE C 1/4 CORNER OF SAID SECTION 33; THENCE LEAVING SAID EAST - WEST 1/4 LINE, N 59°26'18" E, 991.91 FEET; THENCE N 53°43'17" E, 199.83 FEET TO THE POINT OF BEGINNING;

THENCE FROM SAID POINT OF BEGINNING BY METES AND BOUNDS:

CONTINUE N 53°43'17" E, 199.93 FEET; THENCE N 53°04'59" E, 228.89 FEET; THENCE S 36°32'16" E, 290.54 FEET TO A MEANDER CORNER WHICH IS N 36°32'16" W, 23 FEET, MORE OR LESS, FROM THE WATER'S EDGE OF JACKSON LAKE; THENCE ALONG A MEANDER LINE NEAR SAID WATER'S EDGE, S 53°54'33" W, 215.31' FEET; THENCE S 53°54'33" W, 14.26 FEET; THENCE S 48°15'34" W, 200.39 FEET TO A MEANDER CORNER WHICH IS N 36°27'09" W, 36 FEET, MORE OR LESS FROM THE WATER'S EDGE OF JACKSON LAKE; THENCE LEAVING SAID MEANDER LINE, N 36°27'09" W, 283.27 FEET TO THE POINT OF BEGINNING;

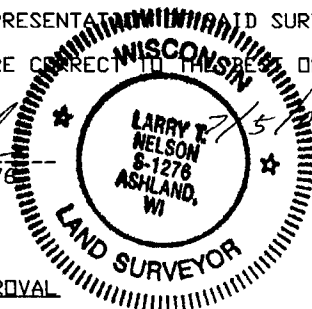
