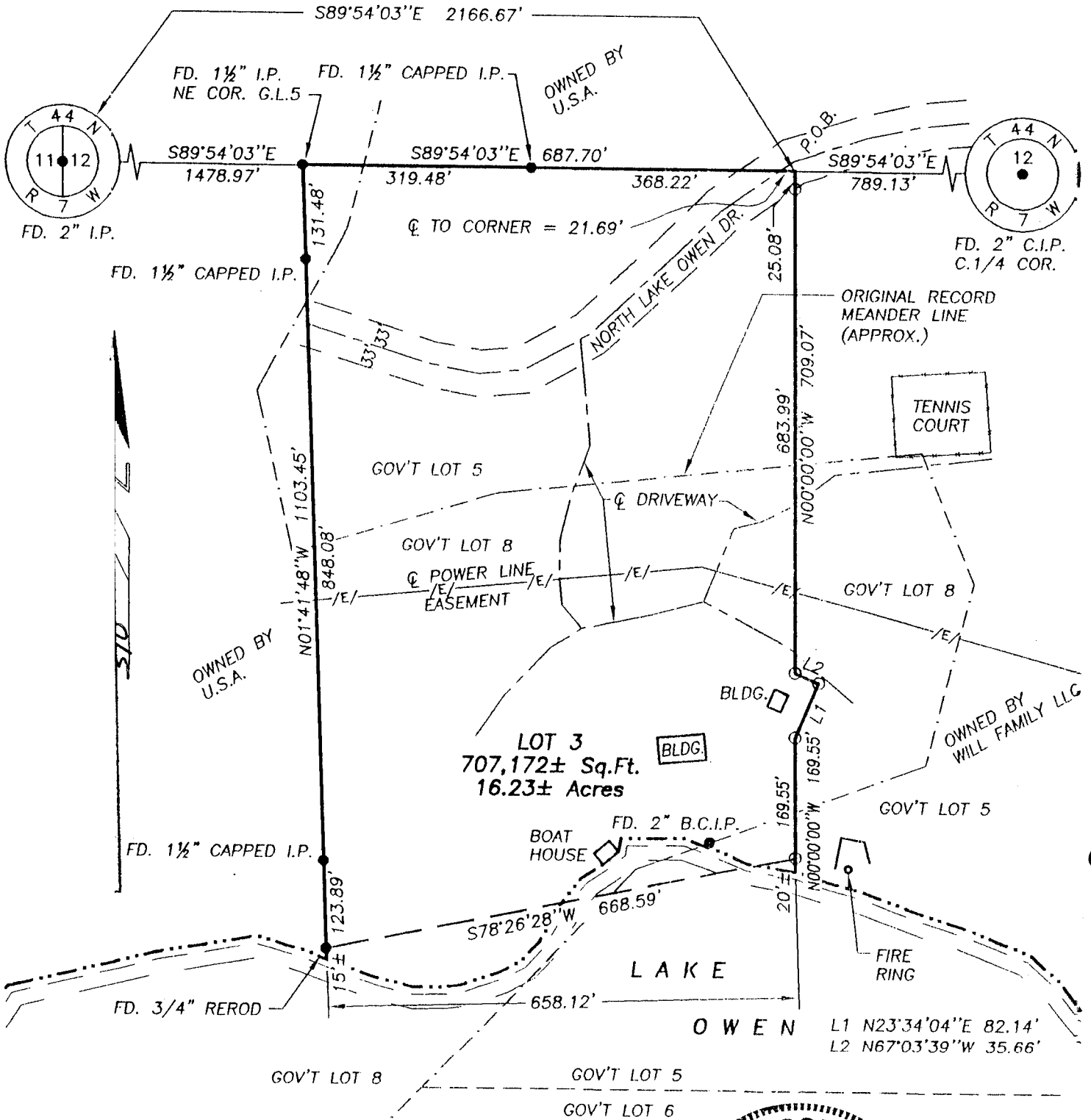

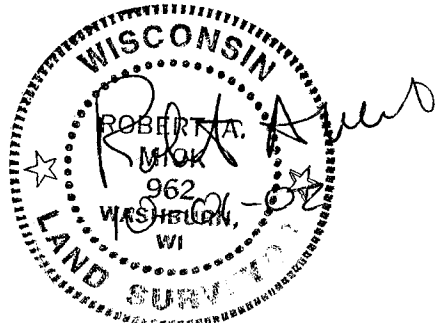

## CERTIFICATE OF SURVEY

I, Robert A. Mick, Registered Land Surveyor in the State of Wisconsin, hereby certify:


That on the order of WILL FAMILY LLC, I have surveyed and mapped the following parcel of land located in the Govt. Lots 5 & 8, Section 12, T44N, R7W, Town of Drummond, Bayfield County, Wisconsin, described as:

Commencing at the quarter corner common to Sections 11 & 12, T44N, R7W; thence S89°54'03"E 2,166.67 feet to the POINT OF BEGINNING; thence Due South 709.07 feet; thence S67°03'39"E 35.66 feet; thence S23°34'04"W 82.14 feet; thence Due South 169.55 feet to an iron rod which marks the beginning of a meander line to Lake Owen, said line continuing Due South to the water's edge; thence along said meander line S78°26'28"W 668.59 feet to an iron rod marking the ending of said meander line; thence N01°41'48"W 1103.45 feet; said line also runs S01°41'48"E to the water's edge; thence S89°54'03"E 687.70 feet to the POINT OF BEGINNING; containing 707,172 square feet, more or less, which is 16.23 acres, more or less, including road right-of-way and all land between the meander line and the water's edge, but excluding all lake bottom between the meander line and the water's edge, and is subject to town road, power line, and any other easements of record and not of record..

That such plat is a true representation of said survey;

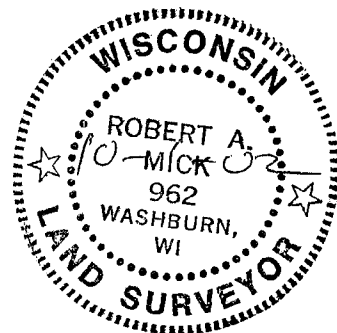


