

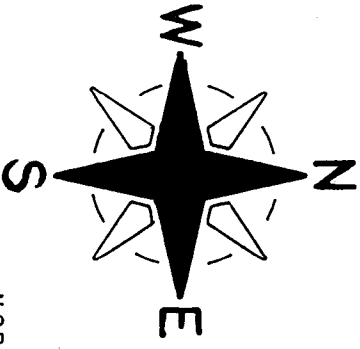
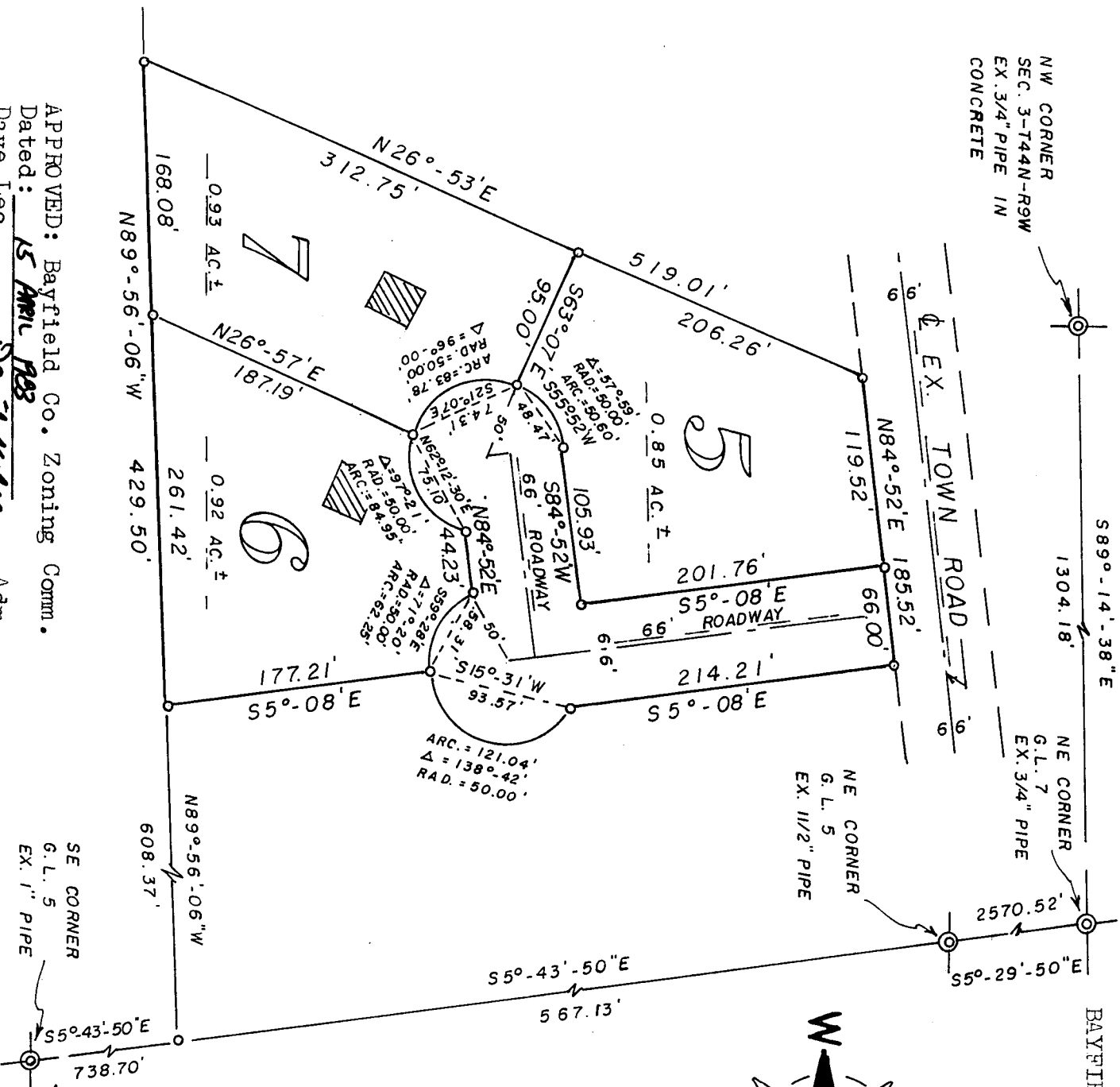

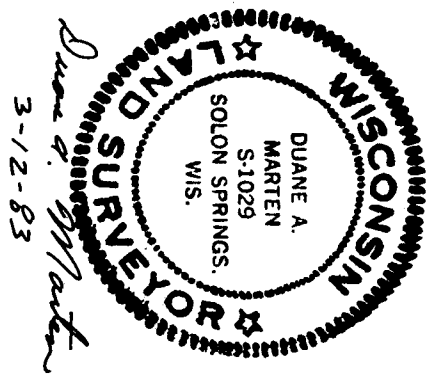
BAYFIELD CO. CERTIFIED SURVEY MAP NO. 000389

SURVEYOR'S CERTIFICATE

I, Duane A. Marten, Registered Land Surveyor, hereby certify:

That I have surveyed, divided and mapped that part of Gov't. Lot 5, Sec. 3-T44N-R9W, Town of Barnes, Bayfield County, Wisconsin, bounded and described as follows:

Commencing at the NW corner of said Sec. 3; thence S890-14'-38"E along the North line of the Sec., 1304.18 feet; thence S50-29'-50"E, 2570.52 feet to the NE corner of Gov't. Lot 5; thence S50-43'-50"E along the East line of Gov't. Lot 5, 567.13 feet; thence N890-56'-06"W, 608.37 feet to the point of beginning; thence continuing N890-56'-06"W, 429.50 feet; thence N260-53'E, 519.01 feet; thence N840-52'E, 185.52 feet; thence S50-08'E, 214.21 feet; thence on a curve concave to the NW and having a radius of 50.00 feet (the chord which bears S150-31'W, 93.57 feet) a distance of 121.04 feet; thence S50-08'E, 177.21 feet to the point of beginning.

That such plat is a correct representation of all exterior boundaries of the land surveyed and the subdivision thereof made.

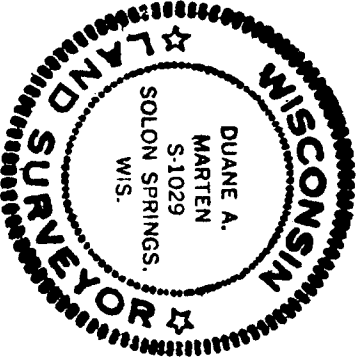
