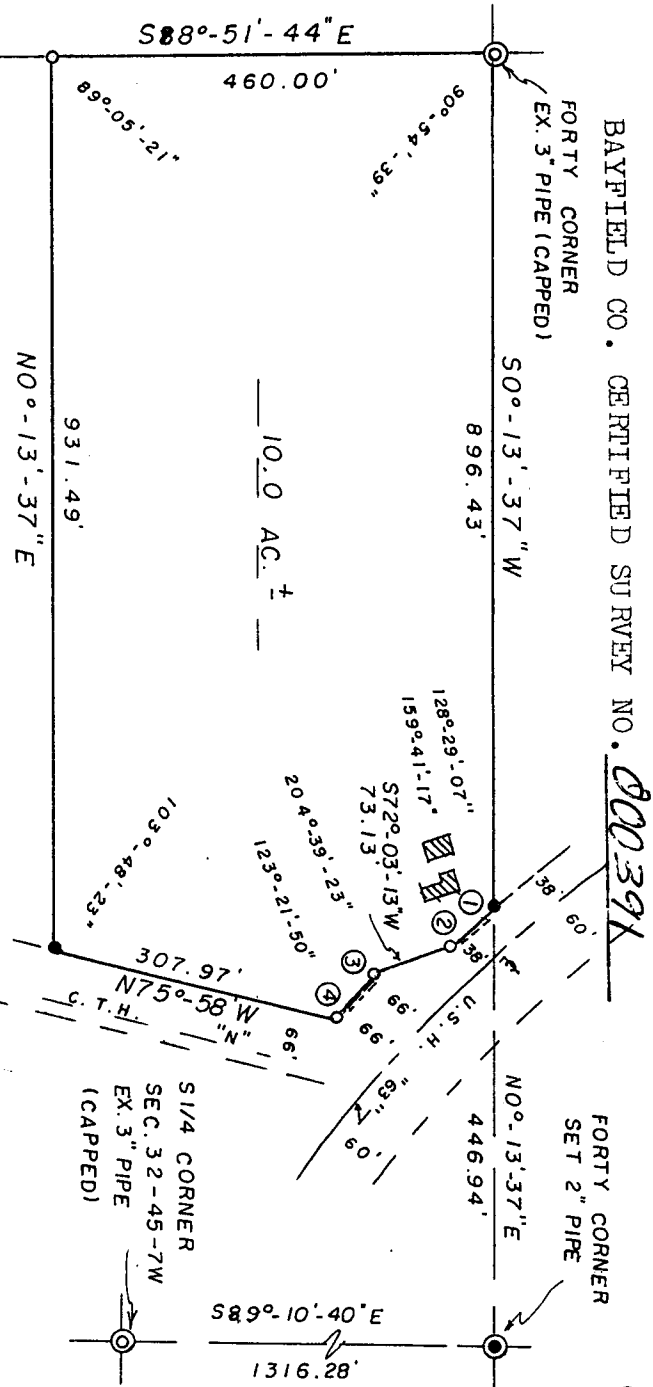

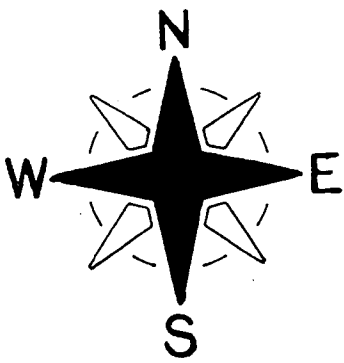

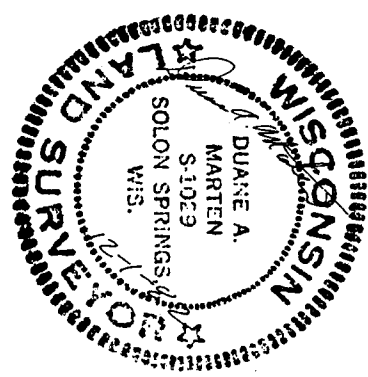

SURVEYOR'S CERTIFICATE - I, Duane A. Marten, Registered Land Surveyor, hereby certify: That I have surveyed, divided and mapped that part of the SW 1/4-SE 1/4, Sec. 32-T45N-R7W, Town of Drummond, Bayfield County, Wisconsin, bounded and described as follows: Commencing at the S 1/4 corner of said Sec. 32; thence S89°-10'-40"E along the South line of the Sec., 1316.28 feet; thence N0°-13'-37"E, 446.04 feet along the East line of the forty to the Northwesterly line of U.S.H. "63" and the point of beginning; thence on a curve concave to the SE and having a radius of 1675.30 feet (the chord which bears S51°-44'-30"W, 60.95 feet) a distance of 60.96 feet; thence S72°-03'-13"W, 73.13 feet; thence on a curve concave to the SE and having a radius of 1703.30 feet (the chord which bears S47°-23'-50"W, 59.56 feet) a distance of 59.56 feet; thence N75°-58'W along the Northernly line of C.T.H. "N", 307.97 feet; thence N0°-13'-37"E parallel with the East line of the forty, 931.49 feet; thence S88°-51'-44"E, 460.00 feet; thence S0°-13'-37"W, 896.43 feet to the Northwesterly line of U.S.H. "63" and the point of beginning. Contains 10.0 acres of land, more or less. That such plat is a correct representation of all exterior boundaries of the land surveyed and the subdivision thereof made. That I have made such survey by the order and under the direction of Mr. Ken Greenwood. That I have fully complied with Chapter 236 of the Wis. Stat. to the best of my knowledge and belief.
