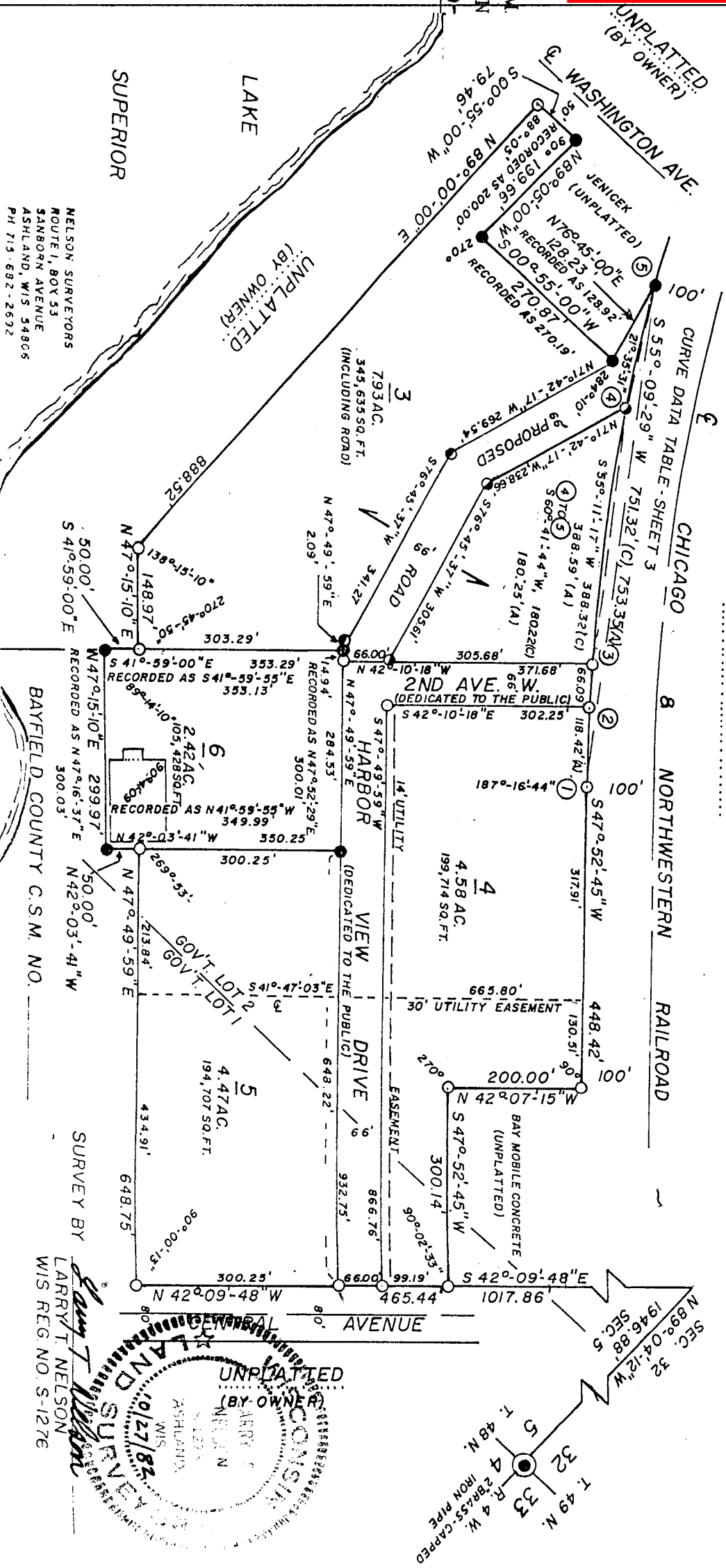
BAYFIELD COUNTY CERTIFIED SURVEY MAP NO. 000369

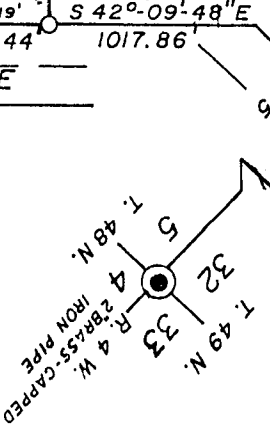
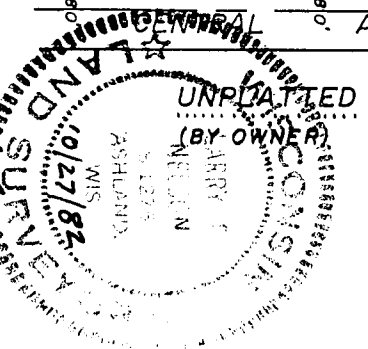
ORIGINAL TOWNSITE

SURVEYOR'S CERTIFICATE

I, Larry T. Nelson, registered land surveyor, hereby certify:

That on the order of JAMES D. MATTSON, Mayor of the City of Washburn, Wis., and JOHN'S PRIME STEAK PIT, INC., I have surveyed, divided, and mapped the following described property located in Gov't. Lots 1 and 2, Section 5, T. 48 N., R. 4 W., in the City of Washburn, Wisconsin.

To locate the Point of Beginning, commence at the NE corner of said Section 5, and run N 89°-04'-12" W, 1946.88 feet along the north line of said Section 5, to the westerly R/W line of Central Avenue. Thence along said westerly R/W line, S 42°-09'-48" E, 1017.86 feet to the Point of Beginning.

Thence from said Point of Beginning by metes and bounds:

Leaving said westerly R/W line, S 47°-52'-45" W, 300.14 feet;

Thence N 42°-07'-15" W, 200.00 feet to the southerly R/W line of the Chicago and Northwestern Railroad;

Thence along said southerly R/W line, S 47°-52'-45" W, 448.42 feet;

Thence along the arc of a curve to the right, having a radius of 2965.00 feet, a central angle of 14°-33'-28", and a chord which bears S 55°-09'-29" W, and measures 751.32 feet, 753.35 feet;

Thence leaving said southerly Railroad R/W line, N 76°-45'-00" E, 128.23 feet;

Thence S 00°-55'-00" W, 270.87 feet;

Thence N 89°-05'-00" W, 199.66 feet to the east R/W line of Washington Avenue;

Thence along said east R/W line, S 00°-55'-00" W, 79.46 feet;

Thence leaving said east R/W line, N 89°-00'-00" E, 888.52 feet;

Thence N 47°-15'-10" E, 148.97 feet;

Thence S 41°-59'-00" E, 50.00 feet;

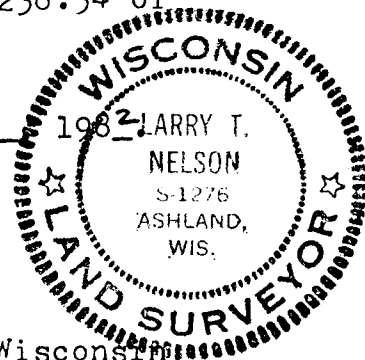
