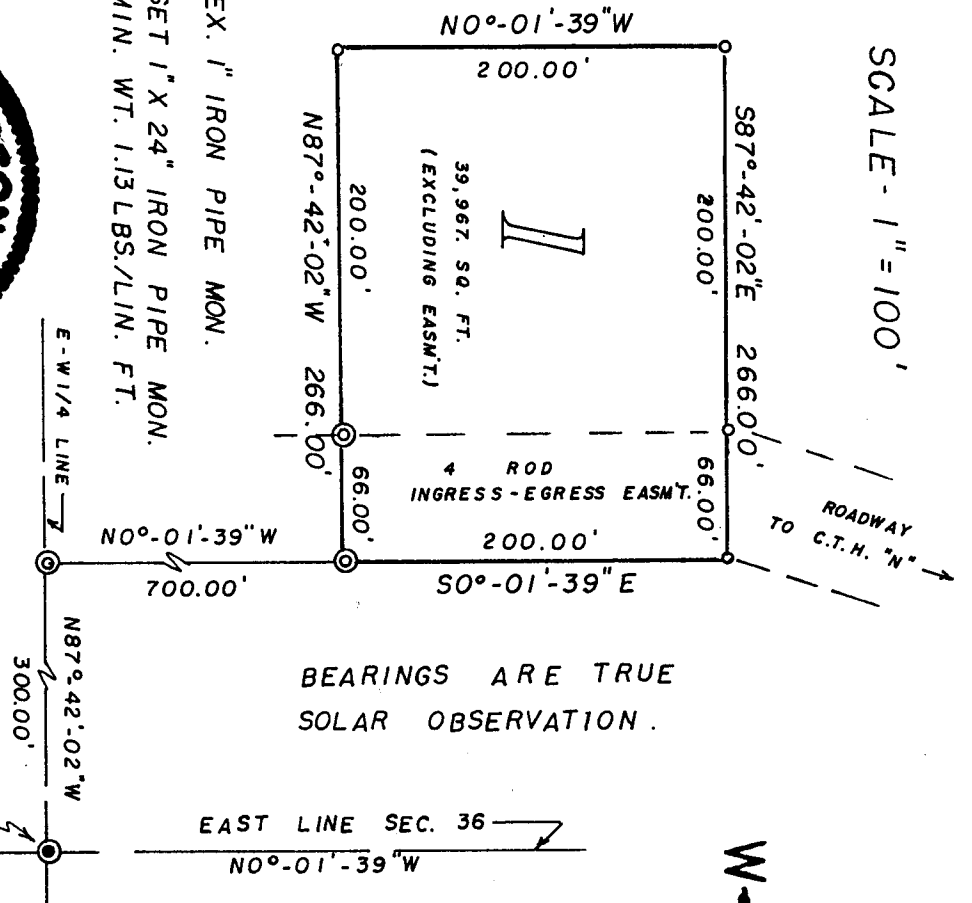

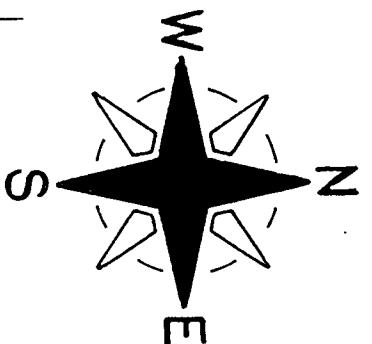

SURVEYOR'S CERTIFICATE:
I, Duane A. Marten, Registered Land Surveyor, here by certify: That I have surveyed, divided and mapped that part of the SE $\frac{1}{4}$ -NE $\frac{1}{4}$, Sec. 36-T45N-R9W, Town of Barnes, Bayfield County, Wisconsin, bounded and described as follows:
Commencing at the E $\frac{1}{4}$ corner of said Sec. 36; thence N87°-42'-02"W, along the E-W $\frac{1}{4}$ line, 300.00 feet; thence N0°-01'-39"W, 700.00 feet to the point of beginning; thence N87°-42'-02"W parallel with the E-W $\frac{1}{4}$ line, 266.00 feet; thence N0°-01'-39"W, parallel with the East line of the Sec., 200.00 feet; thence S87°-42'-02"E parallel with the E-W $\frac{1}{4}$ line, 266.00 feet; thence S0°-01'-39"E parallel with the East line of the Sec., 200.00 feet to the point of beginning. Subject to a 4 rod ingress-egress easement along the Easterly line thereof. Also subject to all other easements and reservation of record.
That such plat is a correct representation of all exterior boundaries of the land surveyed and the subdivision thereof made. That I have made such survey, land division and plat by the order and under the direction of Annita Rauwolf. 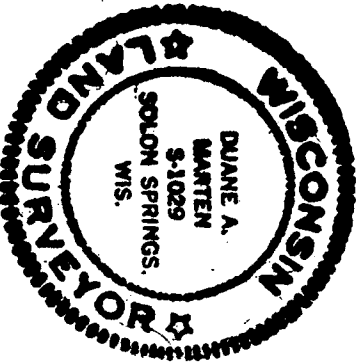
