

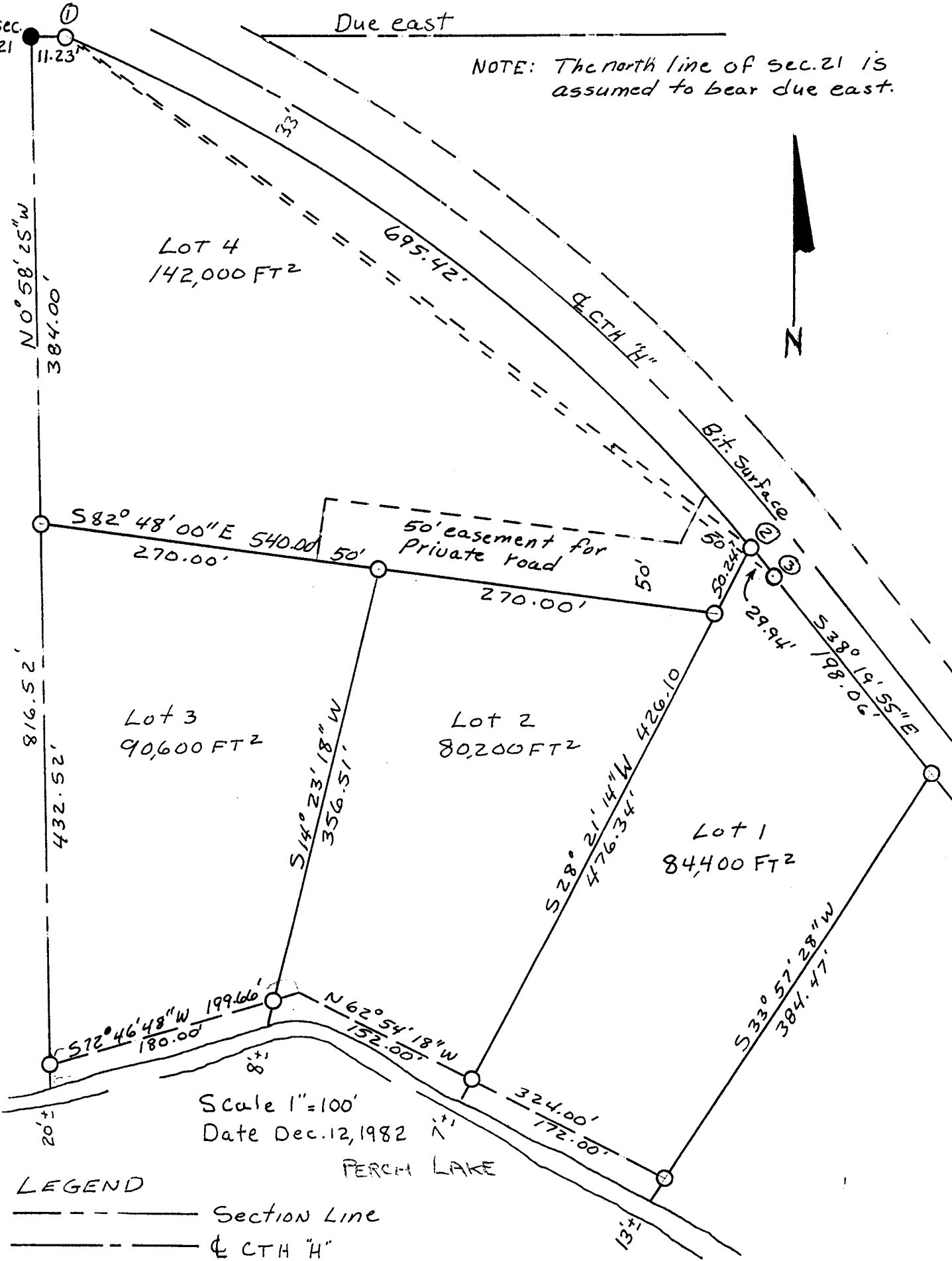

SURVEYOR'S CERTIFICATE

I, Dale Darwin, Registered Land Surveyor, hereby certify:

That I have surveyed, divided, and mapped all of that part of the Northwest Quarter of the Northwest Quarter of Section 21, Township 47 North, Range 8 West, Bayfield County, Wisconsin, bounded and described as follows:

Commencing at the northwest section corner of Section 21, the place of beginning; thence due east 11.23 feet; thence along the arc of a curve to the right, (the chord of which bears S53° 06' 29" E, 717.34 feet), for a distance of 725.36 feet; thence S38° 19' 55" E, 198.06 feet; thence S33° 57' 28" W, 384.47 feet to a meander line; thence N62° 54' 18" W, 324.00 feet; thence S72° 46' 49" W 199.66 feet to the end of said meander line; thence N0° 53' 25" W 316.52 feet to the place of beginning.

That I have made such survey, land division, and map by the direction of Jay Darwin, owner of said land.

That such map is a correct representation of all exterior boundaries of the land surveyed and subdivision thereof made.
