

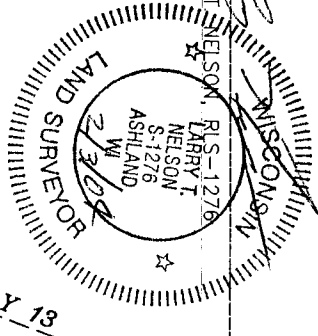

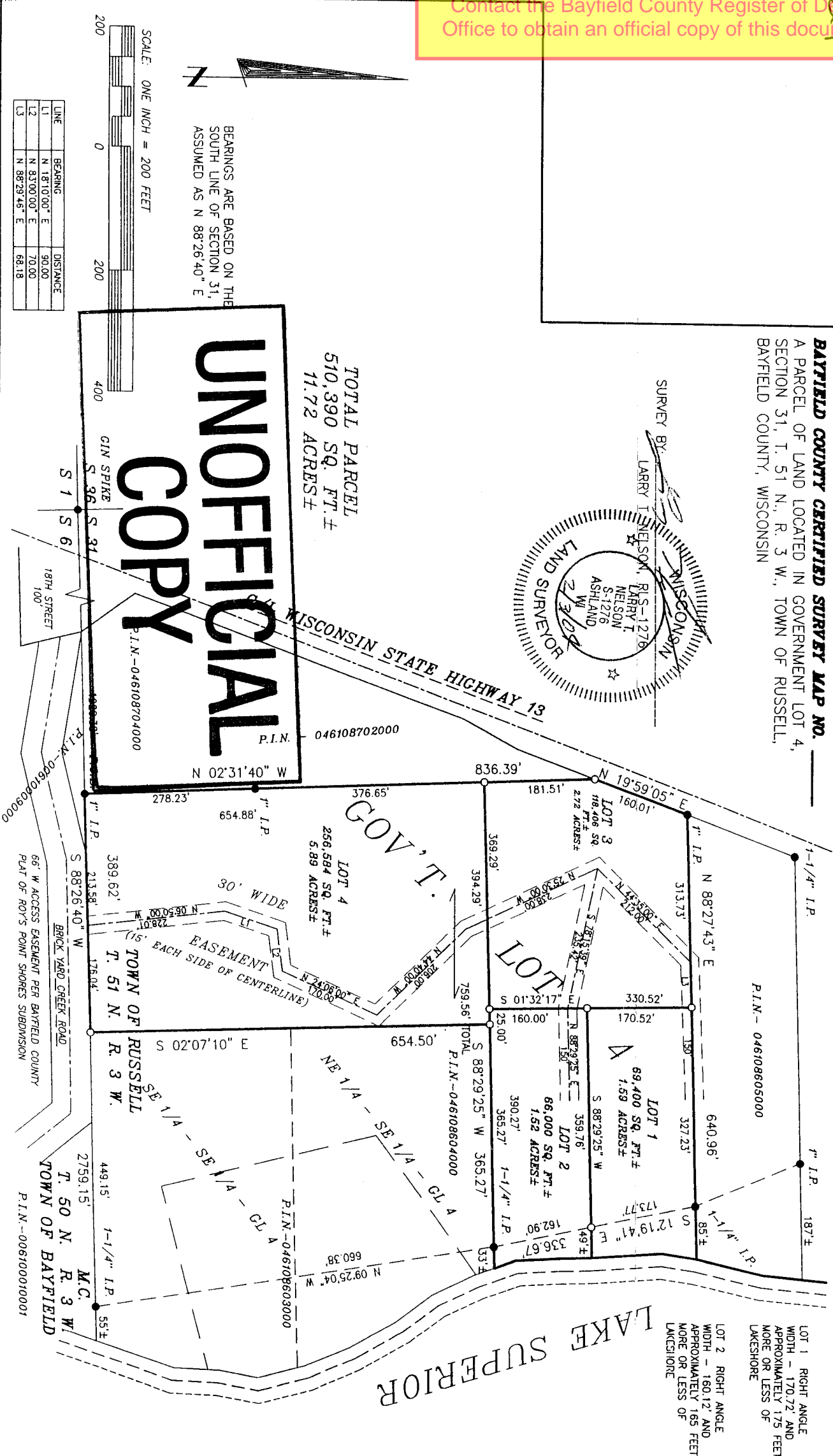

THAT ON THE ORDER OF BRICKYARD CREEK III, L.L.C., OWNER, I HAVE SURVEYED, DIVIDED AND MAPPED A
PARCEL OF LAND LOCATED IN GOVERNMENT LOT 4, SECTION 31, T. 51 N., R. 3 W., TOWN OF RUSSELL,
BAYFIELD COUNTY, WISCONSIN, DESCRIBED AS FOLLOWS;

TO LOCATE THE POINT OF BEGINNING, COMMENCE AT THE SOUTHWEST CORNER OF SAID SECTION 31 AND RUN
N 88°26'40" E, 1920.38 FEET ALONG THE SOUTH LINE OF SAID SECTION 31 TO THE POINT OF BEGINNING;

THENCE FROM SAID POINT OF BEGINNING COMMENCE BY METES AND BOUNDS;



RIGHT-OF-WAY LINE, N 88°27'43" E, 640.96 FEET TO A MEANDER LINE NEAR THE WATER'S EDGE OF LAKE
SUPERIOR; THENCE ALONG SAID MEANDER LINE, S 12°19'41" E, 336.67 FEET; THENCE LEAVING SAID MEANDER
LINE, S 88°29'25" W, 365.27 FEET; THENCE S 02°07'10" E, 654.50 FEET TO THE SOUTH LINE OF SAID


