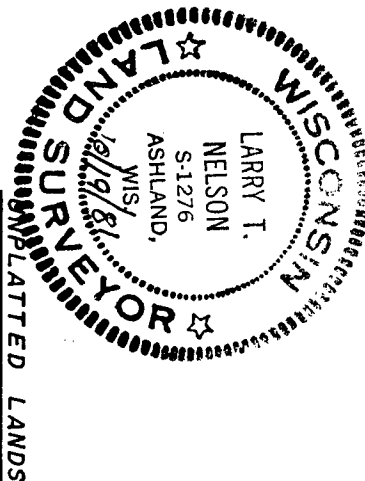

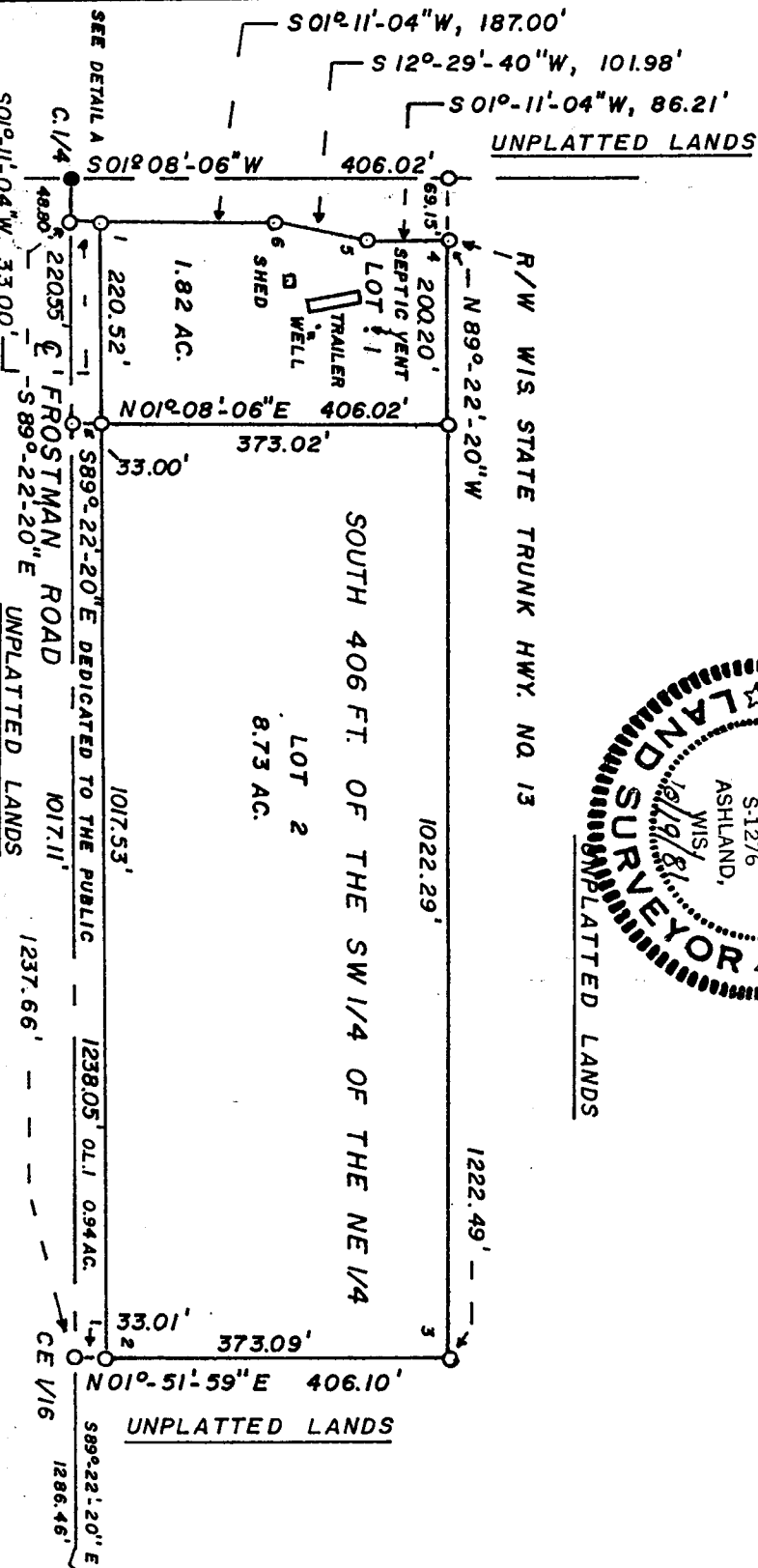

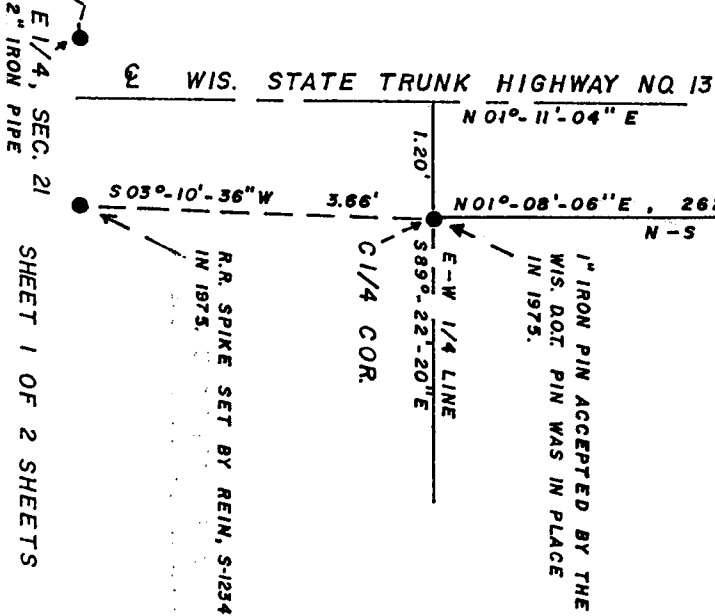

I, Larry T. Nelson, registered land surveyor, hereby certify:

That on the order of Florance Fritz, I have surveyed, divided and mapped the following described property located in the South 406.00 feet of the SW 1/4 of the NE 1/4 of Section 21, T. 49 N., R. 4 W., in the Town of Bayview, Bayfield County, Wisconsin.

To locate the Point of Beginning, commence at the E. 1/4 corner of said Section 21 and run N 89°-22'-20" W, 2524.12 feet, along the E-W 1/4 line of said Section 21, to a 1-1/4" iron pipe on the East right-of-way line of Wisconsin State Trunk Highway No. 13, which is the Point of Beginning.

Thence from said Point of Beginning by metes and bounds;

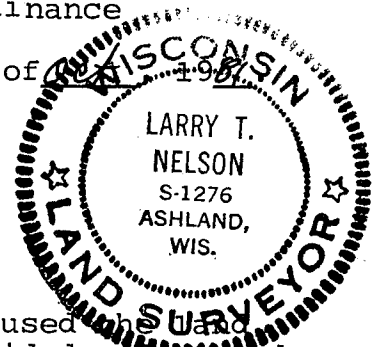
S 89°-22'-20" E, 1237.66 feet, to the CE 1/16 corner of said Section 21, which is marked by a 1-1/4" iron pipe; Thence N 01°-51'-59" E, 406.10 feet, along the East line of said SW 1/4 - NE 1/4, to a 1-1/4" iron pipe; Thence N 89°-22'-20" W, 1222.49 feet, parallel with the East - West 1/4 line of said Section 21, to a 1-1/4" iron pipe on the East right-of-way line of Wisconsin State Trunk Highway No. 13; Thence along said right-of-way line, S 01°-11'-04" W, 86.21 feet to a 1-1/4" iron pipe; Thence S 12°-29'-40" W, 101.98 feet to a 1-1/4" iron pipe; Thence S 01°-11'-04" W, 220.00 feet to the Point of Beginning. Parcel contains 11.49 Acres.
