Part of Gov't Lot 2 in Section 9, Township 43 North, Range 6 West, Town of Namakagon, Bayfield County, Wisconsin.

I, Ladd Gould, Registered Land Surveyor, do hereby certify:

That I have surveyed, divided, and mapped part of Gov't Lot 2 in Section 9, Township 43 North, Range 6 West, Town of Namakagon, Bayfield County, Wisconsin, bounded and described as follows:

Commencing at a 2 1/2 inch capped iron pipe marking a witness corner on the west shore of Namakagon Lake and the south line of Gov't Lot 2, T 43 N, R 6 W; thence N 37° 28' 59" W, 553.46 feet to a 1 inch iron pipe on the Northwesterly Right-of-Way line of an existing town road and the point of beginning of this description; thence N 71° 22' 20" W, 88.93 feet along the meander line of Lake Namakagon to a 1 inch iron pipe; thence N 8° 01' 02" E, 91.94 feet along the meander line of Lake Namakagon to a 1 inch iron pipe; thence N 9° 56' 38" W, 149.39 feet along the meander line of Lake Namakagon to a 1 inch iron pipe; thence N 15° 59' 42" E, 137.30 feet along the meander line of Lake Namakagon to a 1 inch iron pipe; thence N 40° 41' 33" E, 121.30 feet along the meander line of Lake Namakagon to a 1 inch iron pipe; thence N 65° 35' 13" E, 101.29 feet along the meander line of Lake Namakagon to a 1 inch iron pipe on the Westerly Right-of-Way line of an existing town road, thence along said Right-of-Way 55.79 feet along the arc of a curve whose radius bears westerly and chord bears S 2° 41' 42" E, 55.77 feet to a 1 inch iron pipe; thence continuing along said Right-of-Way 167.38 feet along the arc of a curve whose radius bears easterly and chord bears S 6° 25' 18" E, 167.04 feet to a 1 inch iron pipe; thence continuing along said Right-of-Way S 12° 39' 18" E, 69.44 feet to a 1 inch iron pipe; thence continuing along said Right-of-Way 113.34 feet along the arc of a curve whose radius bears westerly and chord bears S 2° 10' 55" E, 112.71 feet to a 1 inch iron pipe; thence continuing along said Right-of-Way 19.19 feet along the arc of a curve whose radius bears northwesterly and chord bears S 24° 57' 17" W, 18.92 feet to a 1 inch iron pipe; thence continuing along said Right-of-Way 85.77 feet along the arc of a curve whose radius bears northwesterly and chord bears S 48° 22' 02" W, 85.57 feet to a 1 inch iron pipe; thence continuing along said Right-of-Way S 55° 07' 02" W, 98.48 feet to the Point of Beginning, including all the land between the described meander line and the waters edge of Namakagon Lake.

That I have made such survey and map by the direction of the owner of said lands; that such map is a correct representation of all exterior boundaries of the land surveyed and the subdivision thereof made. That I have fully complied with the provisions of Chapter 236 of the Wisconsin Statutes and the subdivision regulations of Bayfield County in surveying and mapping same.
