SURVEYOR'S CERTIFICATE

I, TIMOTHY E. OKSIUTA, REGISTERED LAND SURVEYOR IN THE STATE OF WISCONSIN, HEREBY CERTIFY:

THAT ON THE ORDER OF ERIK FINSTAD, OWNER, I HAVE SURVEYED, DIVIDED AND MAPPED A PARCEL OF LAND LOCATED IN THE SE 1/4 OF THE SE 1/4 OF SECTION 18, T. 47 N., R. 8 W., IN THE TOWN OF IRON RIVER, BAYFIELD COUNTY, WISCONSIN, DESCRIBED AS FOLLOWS;

TO LOCATE THE POINT OF BEGINNING, COMMENCE AT THE SOUTH 1/4 CORNER OF SAID SECTION 18 AND RUN ALONG THE SOUTH LINE OF SAID SECTION, N 89°11'39" E, 1085.47 FEET TO THE E 1/16 CORNER; THENCE N 89°08'16" E, 66.00 FEET TO THE POINT OF BEGINNING.

THENCE FROM SAID POINT OF BEGINNING BY METES AND BOUNDS;

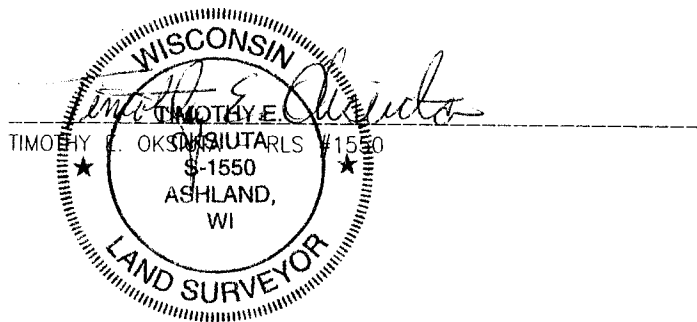
ALONG THE EAST RIGHT OF WAY LINE OF SPIDER LAKE ROAD, N 00°29'22" W, 200.00 FEET. THENCE LEAVING SAID EAST RIGHT OF WAY LINE, N 89°08'16" E, 434.00 FEET. THENCE N 00°29'22" W, 450.00 FEET. THENCE N 89°08'16" E, 668.05 FEET TO THE EAST LINE OF SAID GOVERNMENT LOT 3. THENCE ALONG SAID EAST LINE, S 01°04'45" W, 3.80 FEET TO A 2" CAPPED IRON PIPE MEANDER CORNER WHICH IS N 01°04'45" E, 50 FEET, MORE OR LESS, FROM THE WATER'S EDGE OF SPIDER LAKE. THENCE ALONG A MEANDER LINE NEAR SAID WATER'S EDGE S 49°14'50" W, 383.90 FEET. THENCE S 32°06'03" E, 233.91 FEET. THENCE S 02°45'32" E, 200.11 FEET TO A 3" IRON PIPE MEANDER CORNER WHICH IS S 89°08'16" W, 22 FEET, MORE OR LESS, FROM THE WATER'S EDGE OF SPIDER LAKE AND ON THE SOUTH LINE OF SAID GOVERNMENT LOT 3. THENCE LEAVING SAID MEANDER LINE AND ALONG SAID SOUTH LINE, S 89°08'16" W, 39.9 FEET TO THE POINT OF BEGINNING.

SAID PARCEL CONTAINS 452,800 SQUARE FEET, MORE OR LESS, WHICH IS 10.39 ACRES, MORE OR LESS, INCLUDING THAT LAND LYING BETWEEN THE MEANDER LINE AND THE WATER'S EDGE OF SPIDER LAKE AND THE EXTENSIONS OF THE LOT LINES TO SAID WATER'S EDGE AND IS SUBJECT TO EASEMENTS, RESERVATIONS AND RESTRICTIONS OF RECORD, IF ANY.

THAT THIS MAP IS A TRUE REPRESENTATION OF SAID SURVEY AND SUBDIVISION;


