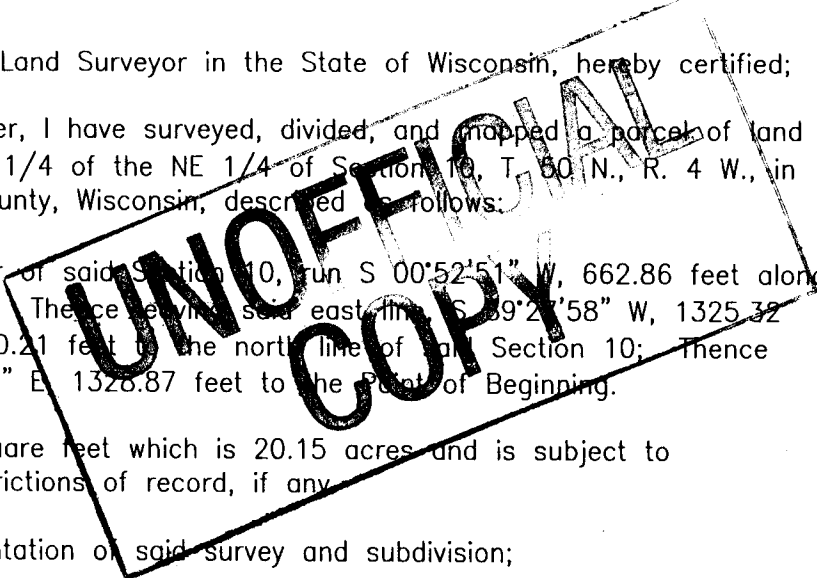

easements, reservations and restrictions of record, if any.

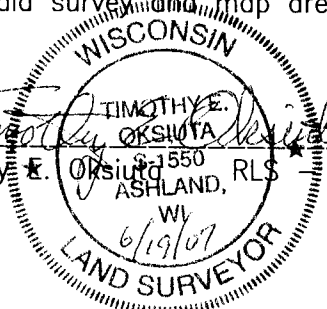

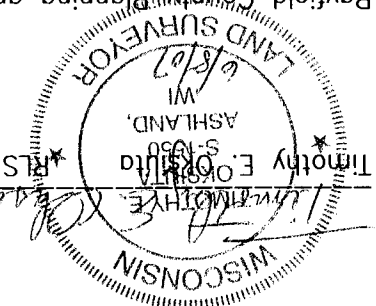
