CERTIFICATE OF SURVEY

I, Robert A. Mick, Registered Land Surveyor in the State of Wisconsin, hereby certify:

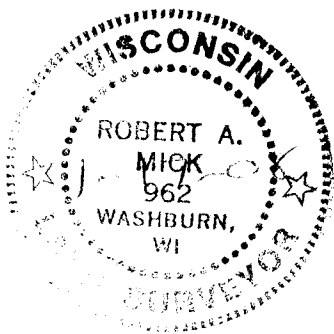
That on the order of BILL VAN SANT, I have surveyed, combined, divided and mapped the following parcel of land located in Gov't. Lot 2, Section 14, T50N, R4W, Town Bayfield, Bayfield County, WI, and more particularly described as:

Commencing at the quarter corner common to Sections 14 & 23, T50N, R4W; thence S89°54'37"E 1055.61 feet to a point located on the Easterly right-of-way line of Lakeshore Drive which is the POINT OF BEGINNING; thence along said right-of-way line N01°54'32"E 363.27 feet; thence continuing along said right-of-way line N01°33'14"E 197.29 feet; thence S79°33'46"E 228.63 feet; thence S51°57'15"E 140.34 feet to a point marking the beginning of a meander line to Lake Superior; said line continues S51°57'15"E to the water's edge; thence along said meander line S36°22'22"W 150.18 feet; thence continuing along said meander line S11°38'49"W 318.33 feet to a point marking the end of said meander line; thence N09°54'37"W 199.49 feet to the POINT OF BEGINNING; said line also runs S89°54'37"E to the water's edge; containing 147,072 square feet, more or less, which is 3.33 acres, more or less; and is subject to any easements of record.
