SURVEYOR'S CERTIFICATE

I, Mark E. Krause, a Registered Land Surveyor, hereby certify that pursuant to a request from GARY JOHNSON, I have caused the hereinafter described lands to be surveyed, divided and mapped under my direction and supervision; and to my best knowledge and belief this Certified Survey Map is a true and correct representation of that survey;

THAT the exterior boundary of the land parcel surveyed and mapped is described as follows:

A parcel of land located in Government Lot 5 and 6, Section 20, Township 50 North, Range 06 West, Town of Bell, County of Bayfield, State of Wisconsin and more particularly described as follows:

Commencing at the South Quarter Corner of Section 20;

THENCE N02°18'36"E 1351.85 feet to the Southwest Corner of Government Lot 5 being the Point of Beginning;

THENCE N02°18'36"E 1274.81 feet along the West Line of Government Lot 5 to the South Line of the Plat of Siskiwit Shores;

THENCE southerly along the South Line of said plat 119.66 feet along the arc of a circle concave to the East whose radius is 163.32 feet the chord of said arc bearing S18°40'47"E 117.01 feet;

THENCE S39°40'09"E 422.76 feet along said South plat line;

THENCE S68°39'19"E 120.12 feet along said South plat line;

THENCE S56°33'03"E 709.89 feet along said South plat line;

THENCE easterly along the South Line of said plat 74.29 feet along the arc of a circle concave to the North whose radius is 121.25 feet the chord of said arc bearing S74°06'15"E 73.14 feet;

THENCE S69°28'31"E 699.64 feet along the South Line of said plat to a meander line of Siskiwit Lake;

THENCE S17°55'40"E 460.33 feet along said meander line;

THENCE N84°38'35"W 600.00 feet to the West Line of Government Lot 6;

THENCE N02°00'42"E 200.00 feet to the Northwest Corner of Government Lot 6;

THENCE N88°04'46"W 1340.64 feet to the Point of Beginning.


