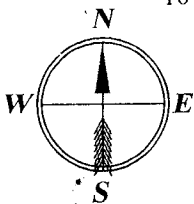

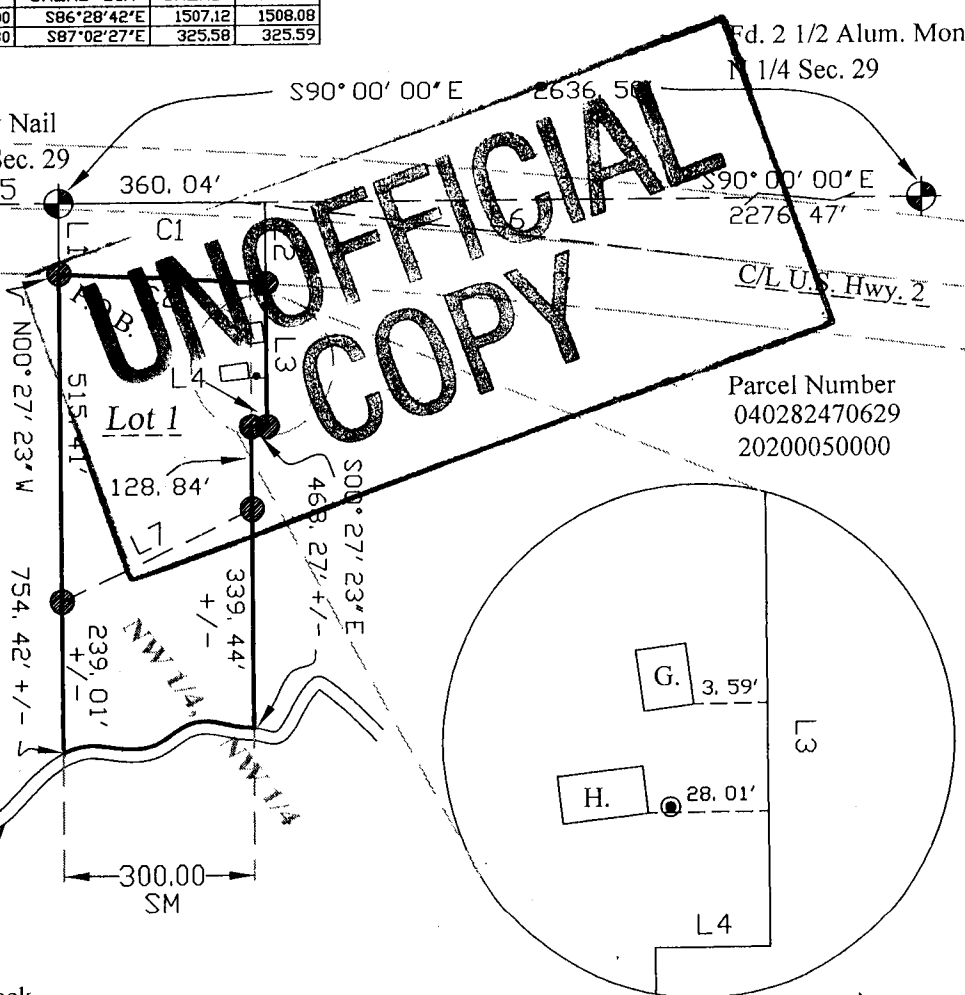

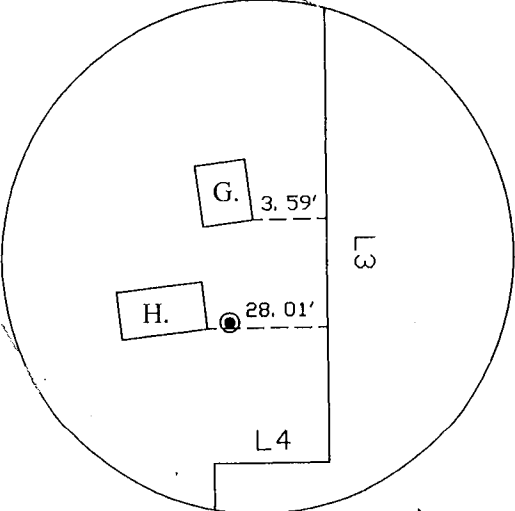
Approx. Location Spring Creek

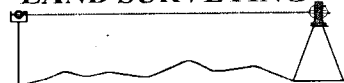

That said map is a correct representation of the exterior boundaries of the land surveyed and the subdivision thereof made. Described as follows:



Thence along an arc of a curve to the right having a Radius of 12096.70, a Delta Angle of 1°32'32", A Chord which bears S 87°02'27" E 325.58', and an Arc Length of 325.59'; thence S 00°27'23" E 228.96'; thence S 89°32'37" W 25.00'; thence S 00°27'23" E 128.84' to a point N 00°27'23" W 339.44' more or less from the High Water Mark; thence along the meander line S 64°48'15" W 330.32' to a point N 00°27'23" W 239.01 more or less from the High Water Mark; thence N 00°27'23" W 515.41' to the point of beginning. Parcel Contains: 222,383 square feet, or 5.11 acres more or less to the High Water Mark of North Fish Creek.

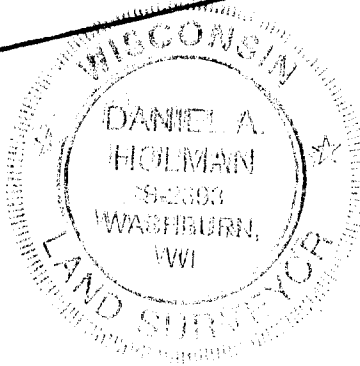

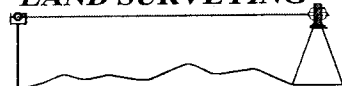
