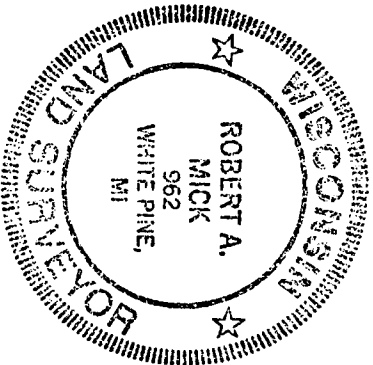
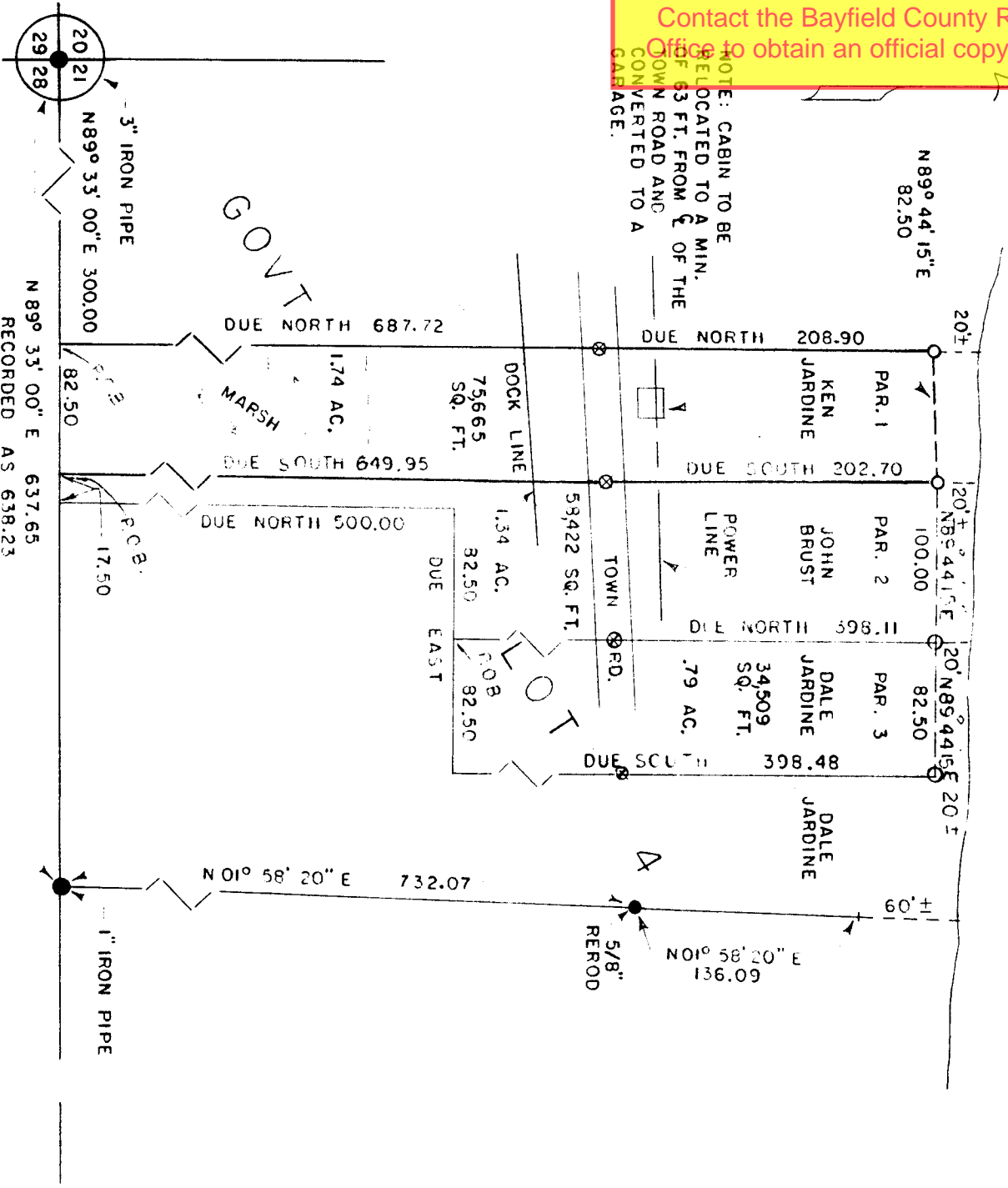

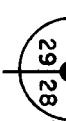

### Legal Description

#### Parcel No. 1

A parcel of land located in Govt. Lot 4, Sec. 21, T50N, R8W, Port Wing Township, Bayfield County, WI, as hereafter described.

Commencing at the corner common to Sections 20, 21, 28 and 29; thence N89°33'00"E 300.00 feet to the point of beginning; thence due North 687.72 feet; thence due North 208.90 feet to a 3/4" iron rebar located near the high water line of Lake Superior; said line continues to the water's edge. Thence N89°44'15"W 82.50 feet to a 3/4" iron rebar located near the high water line of Lake Superior; thence due South 201.70 feet; said line continues Northerly to the water's edge. Thence due South 649.95 feet; thence S89°33'00"W 82.50 feet to the point of beginning. The above-described parcel contains 75,665 square feet or 1.74 acres.

This parcel is subject to a right-of-way easement across said property which may be hereafter laid out and described as a town highway for public use without infringement of the property owners and other easements of record.

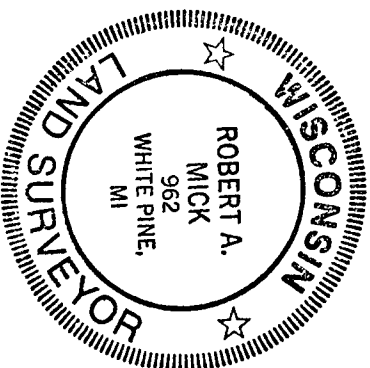

Commencing at a corner common to Sections 20, 21, 28 and 29; thence N89.1531°W 400.00 feet; thence due North 500.00 feet; thence due East

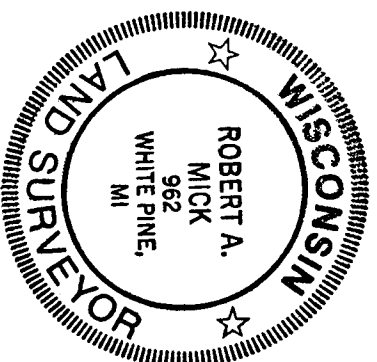
