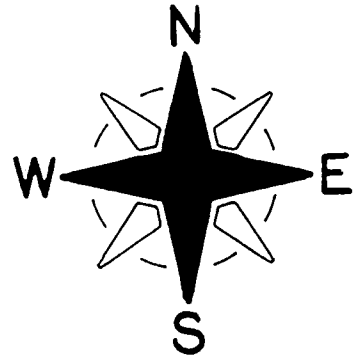
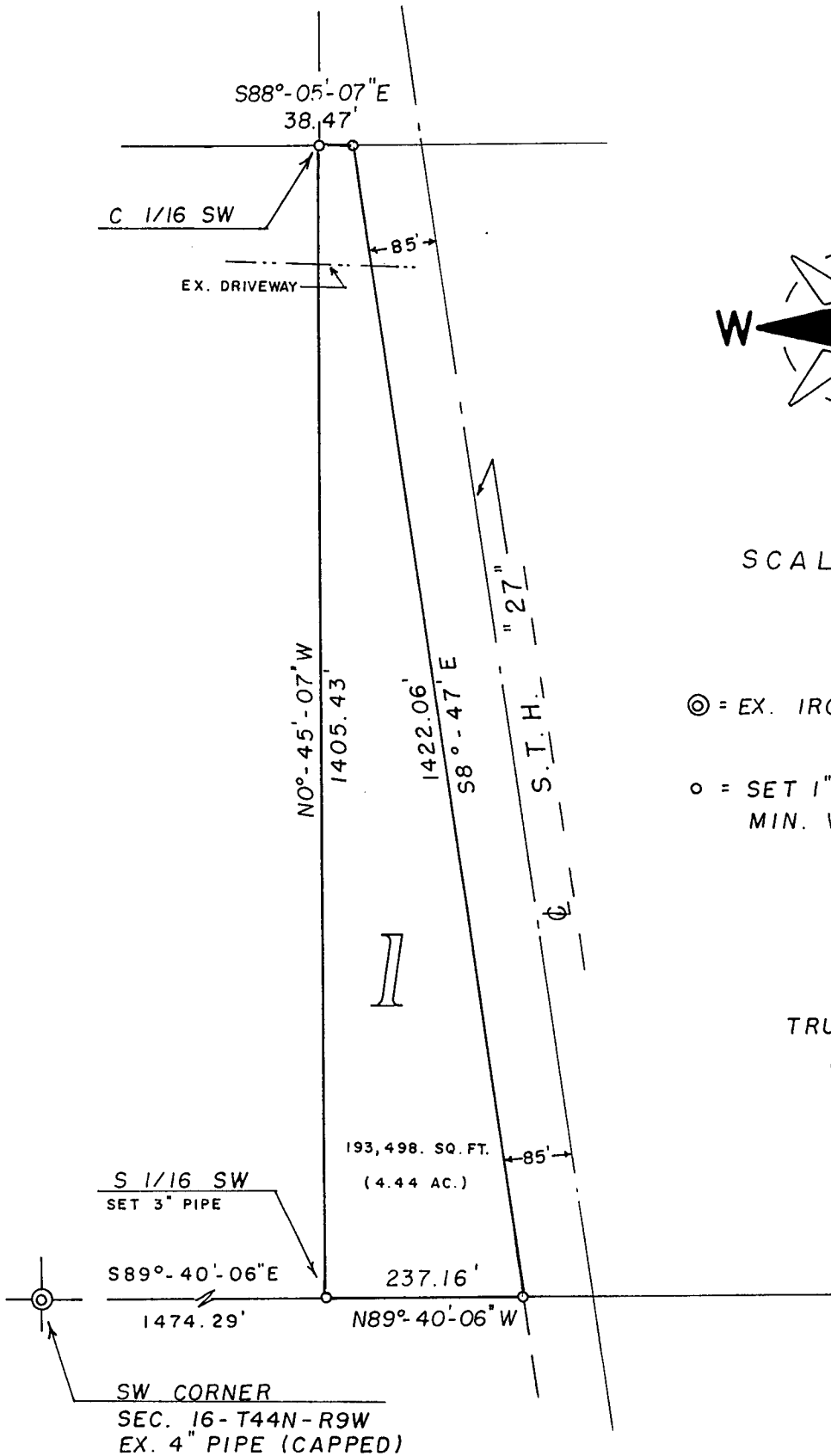

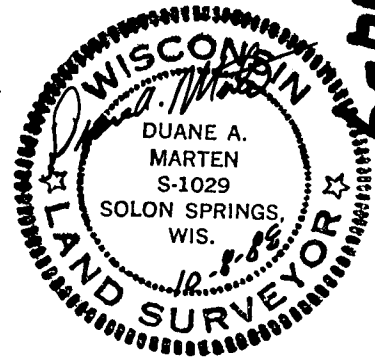


SCALE - 1" = 200'

SURVEYOR'S CERTIFICATE:

I, Duane A. Marten, Registered Land Surveyor, hereby certify:

That I have surveyed, divided and mapped that part of the SE $\frac{1}{4}$ -SW $\frac{1}{4}$, Sec. 16-T44N-R9W, Town of Barnes, Bayfield County, Wis., bounded and described as follows:

Commencing at the SW corner of said Sec. 16; thence S89°-40'-06"E along the South line of the Sec., 1474.29 feet to the S 1/16 SW corner and the point of beginning; thence N0°-45'-07"W along the West line of the forty, 1405.43 feet to the C 1/16 SW corner; thence S88°-05'-07"E along the North line of the forty, 38.47 feet to the Westerly line of S.T.H. "27"; thence S8°-47'E along said Westerly line, 1422.06 feet to the South line of Sec. 16; thence N89°-40'-06"W along said South line, 237.16 feet to the S 1/16 SW corner and the point of beginning. Subject to an existing East-West driveway as now being used and subject to all other easements and reservations of record.
