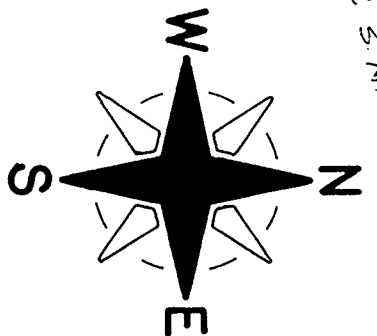
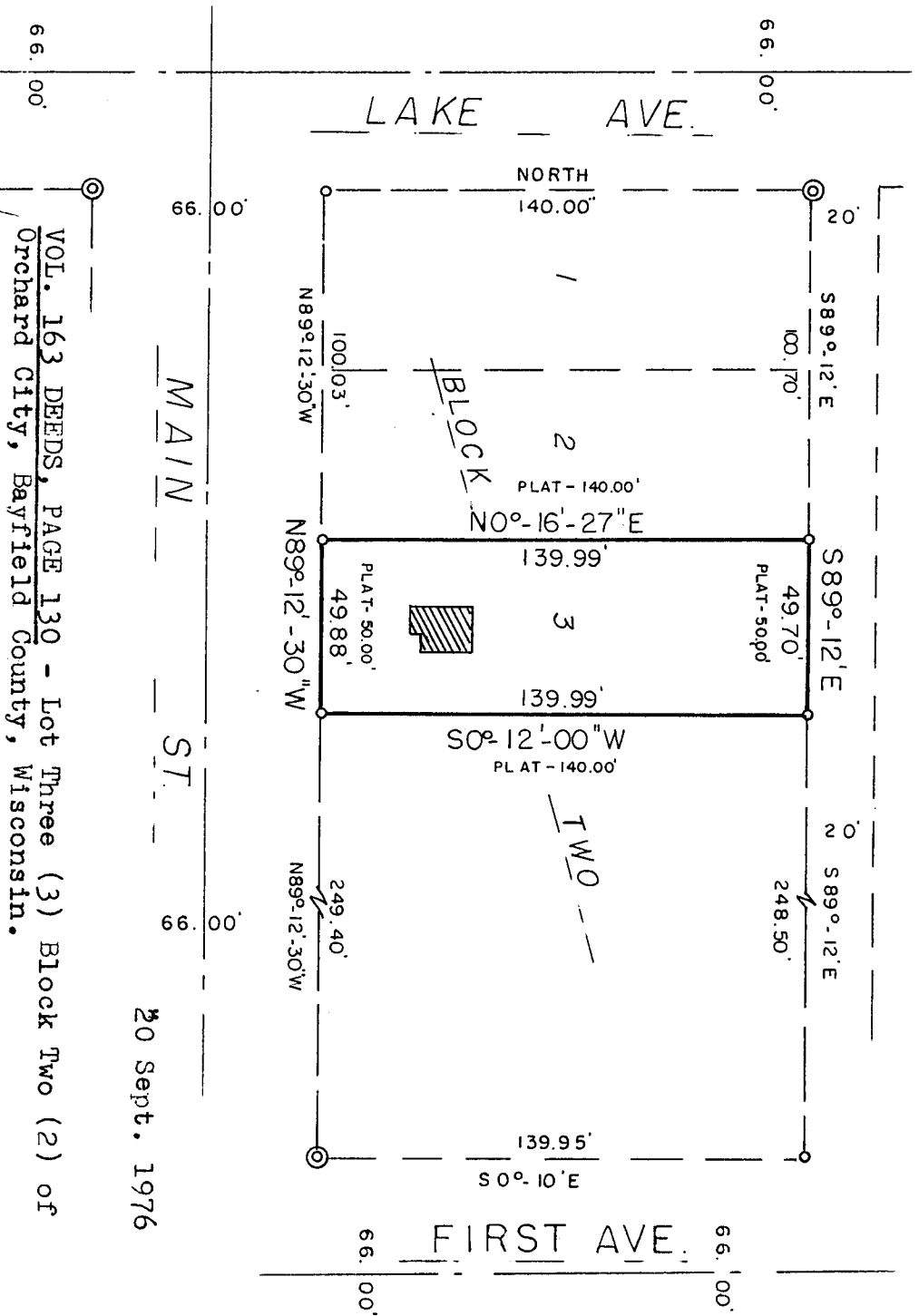

West line of Block Two assumed to bear North-South.



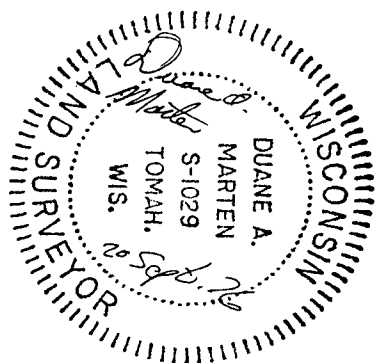

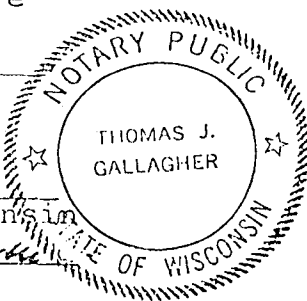
2. That the description of the real estate included in said survey map contains a typographical error in referring to Range 5 West and said Range should be 7 West.
