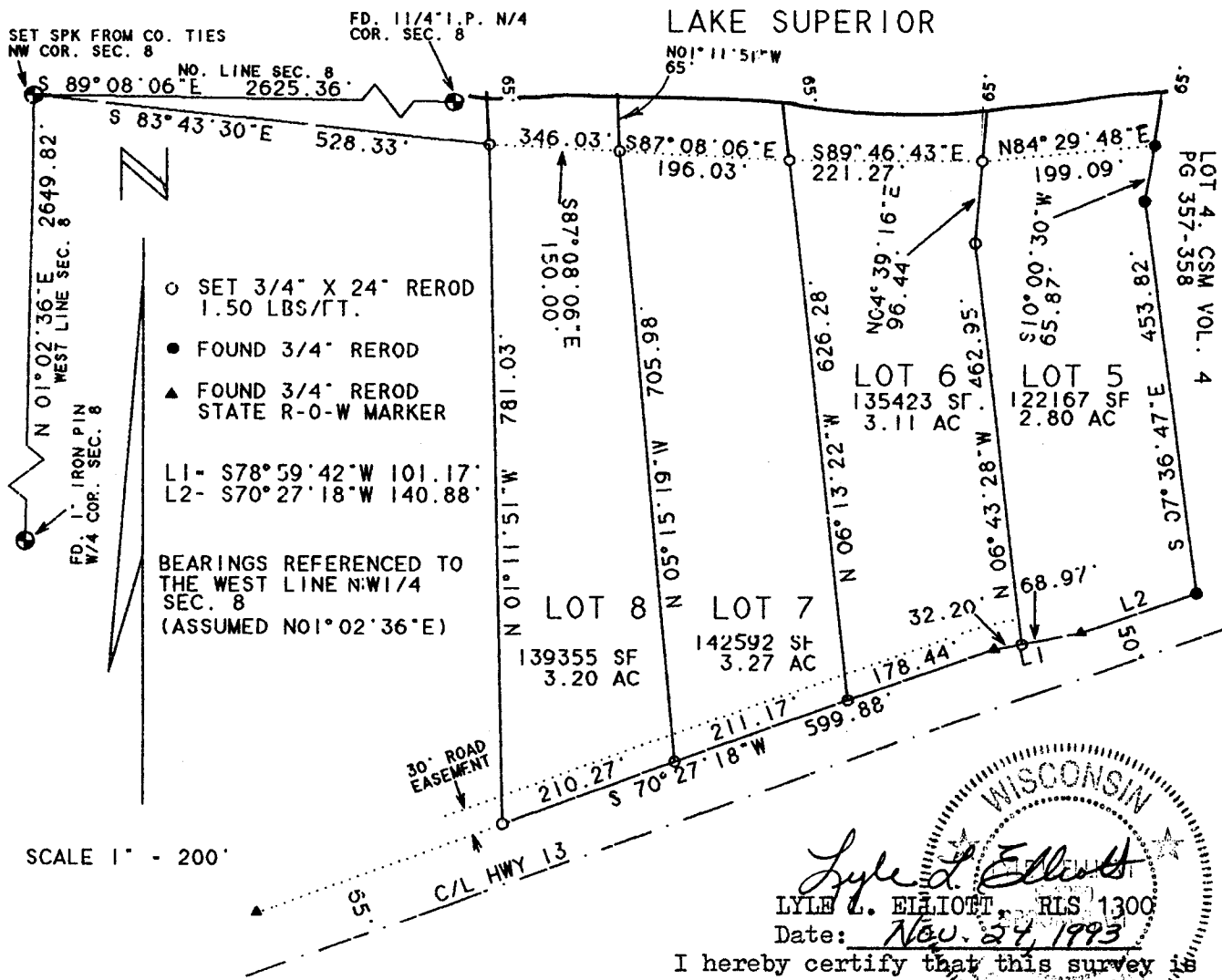


I, LYLE L. ELLIOTT, registered land surveyor hereby certify that by the direction of BOYD SKILLE, I have surveyed and mapped the land parcel which is represented by this Certified Survey Map. The exterior boundaries of the land parcel surveyed and mapped is described as follows. A part of G.L. 2, Sec. 5, part of the NW1/4-NW1/4, Sec. 8, T.50N R. 7 W., Town of Clover, Bayfield County Wisconsin, and more particularly described as follows; Commencing at the NW cor.
