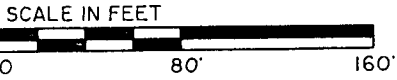

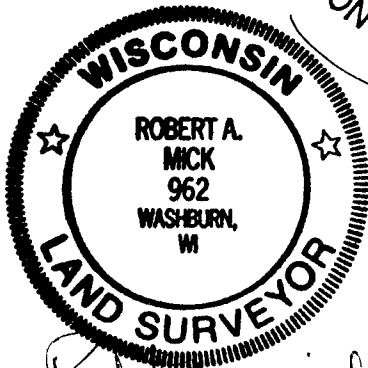

Legal Description

A parcel of land located in Government Lot 2 and the NE $\frac{1}{4}$ of the NW $\frac{1}{4}$, Section 34, T44N, R6W, Grandview Township, Bayfield County, WI, described as:

Commencing at the quarter corner common to Sections 33 and 34; thence S86°52'39"E 1279.48 feet; thence N00°47'33"W 1310.49 feet; thence N15°16'00"W 556.45 feet to the point of beginning; thence S61°55'43"W 255.79 feet; thence S71°38'19"W 190.63 feet; thence S84°10'29"W 55.00 feet; thence N42°26'13"W 143.72 feet; thence N34°32'28"E 150.00 feet; thence N72°15'42"E 129.08 feet; thence N55°00'10"E 214.20 feet; thence S56°28'43"E 300.00 feet; thence S61°55'43"W 85.28 feet to the point of beginning.
