Part of Government Lot three (3) section five (5) Township (44) north range (9) west, more particularly described as follows: Commencing at a point thirty-three (33) feet north and thirty-three (33) feet west of the center one fourth (1/4) corner of said section five (5); thence running variation north four degrees twenty-nine minutes west (N4°29'W) a distance of six hundred fiftythree and five tenths (653.51) feet to an iron stake; thence running variation south sixty-six degrees forty-three minutes west (S66°43'W) a distance of sixty-four and eighty-three hundredths (64.831) feet to an iron stake; thence running variation south four degrees thirty-eight minutes (S4°38'W) a distance of one hundred twenty-one and one tenth (121.101) feet to an iron stake; thence running variation south thirty-nine degrees forty-four minutes west (S39°44'W) a distance of two hundred eighty-five and sixty one hundredths (285.601) feet to an iron stake; thence running variation south eighty-three degrees twenty-one minutes west (S83°21'W) a distance of one hundred fifty-five (155) feet to an iron stake; thence running variation south four degrees twenty-nine minutes east (S4°29'E) a distance of two hundred eighty-three and fifty-five hundredths (283.551) feet to the north right of way line of a town roadway; thence running variation north eighty-eight degrees one minute east (N88°01'E) a distance of four hundred thirty-five (435.001) feet to the point of beginning;


