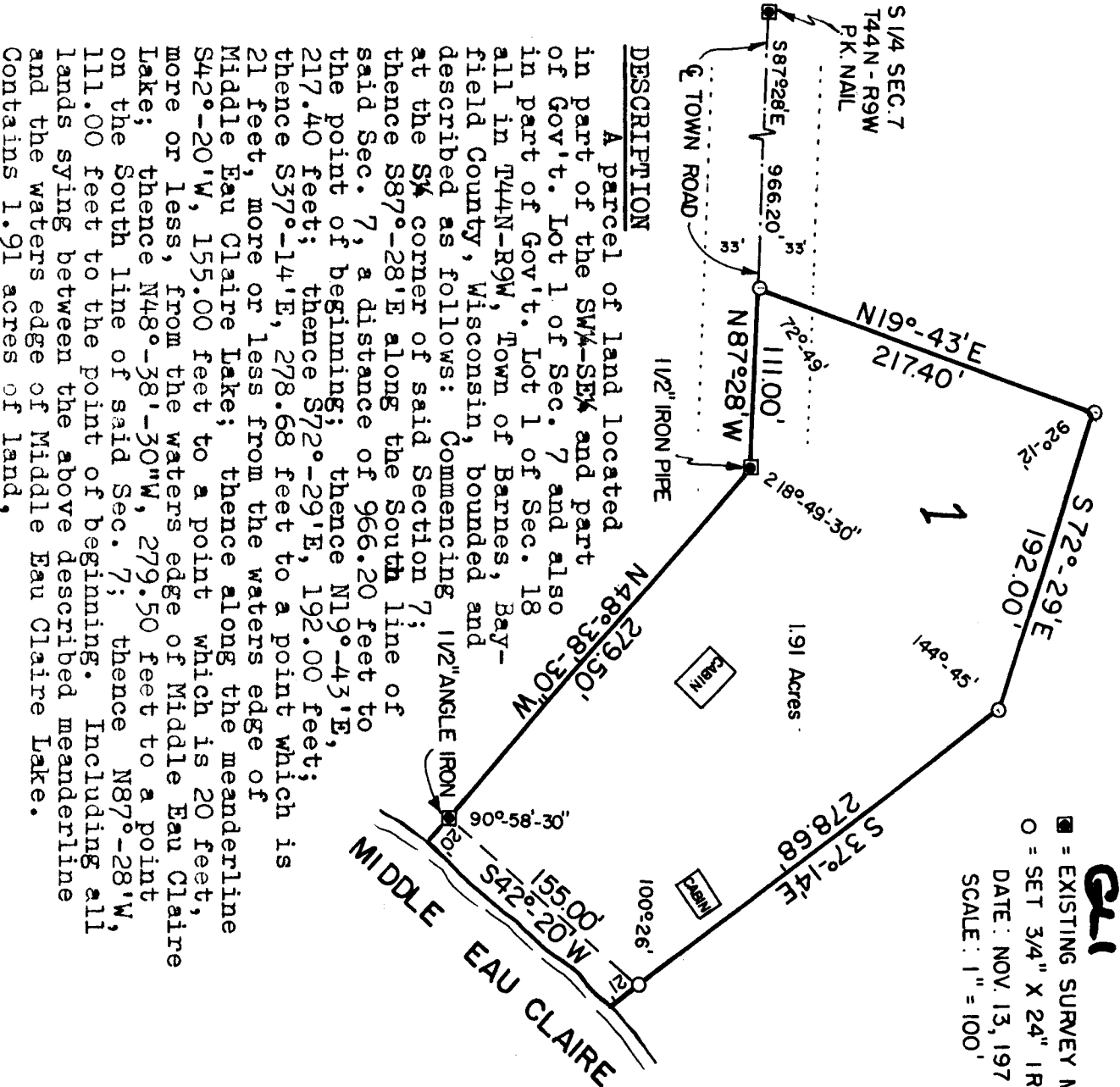


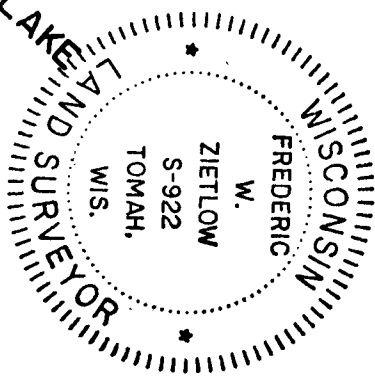

**DESCRIPTION**  
 A parcel of land located in part of the SW $\frac{1}{4}$ -SE $\frac{1}{4}$  and part of Gov't. Lot 1 of Sec. 7 and also in part of Gov't. Lot 1 of Sec. 18 all in T44N-R9W, Town of Barnes, Bayfield County, Wisconsin, bounded and described as follows: Commencing 1/2" ANGLE IRON PIPE at the SW corner of said Section 7; thence S87°-28'E along the South line of said Sec. 7, a distance of 966.20 feet to the point of beginning; thence N19°-43'E, 217.40 feet; thence S72°-29'E, 192.00 feet; thence S37°-14'E, 278.68 feet to a point which is 21 feet, more or less from the waters edge of Middle Eau Claire Lake; thence along the meanderline S42°-20'W, 155.00 feet to a point which is 20 feet, more or less, from the waters edge of Middle Eau Claire Lake; thence N48°-38'-30"W, 279.50 feet to a point on the South line of said Sec. 7; thence N87°-28'W, 111.00 feet to the point of beginning. 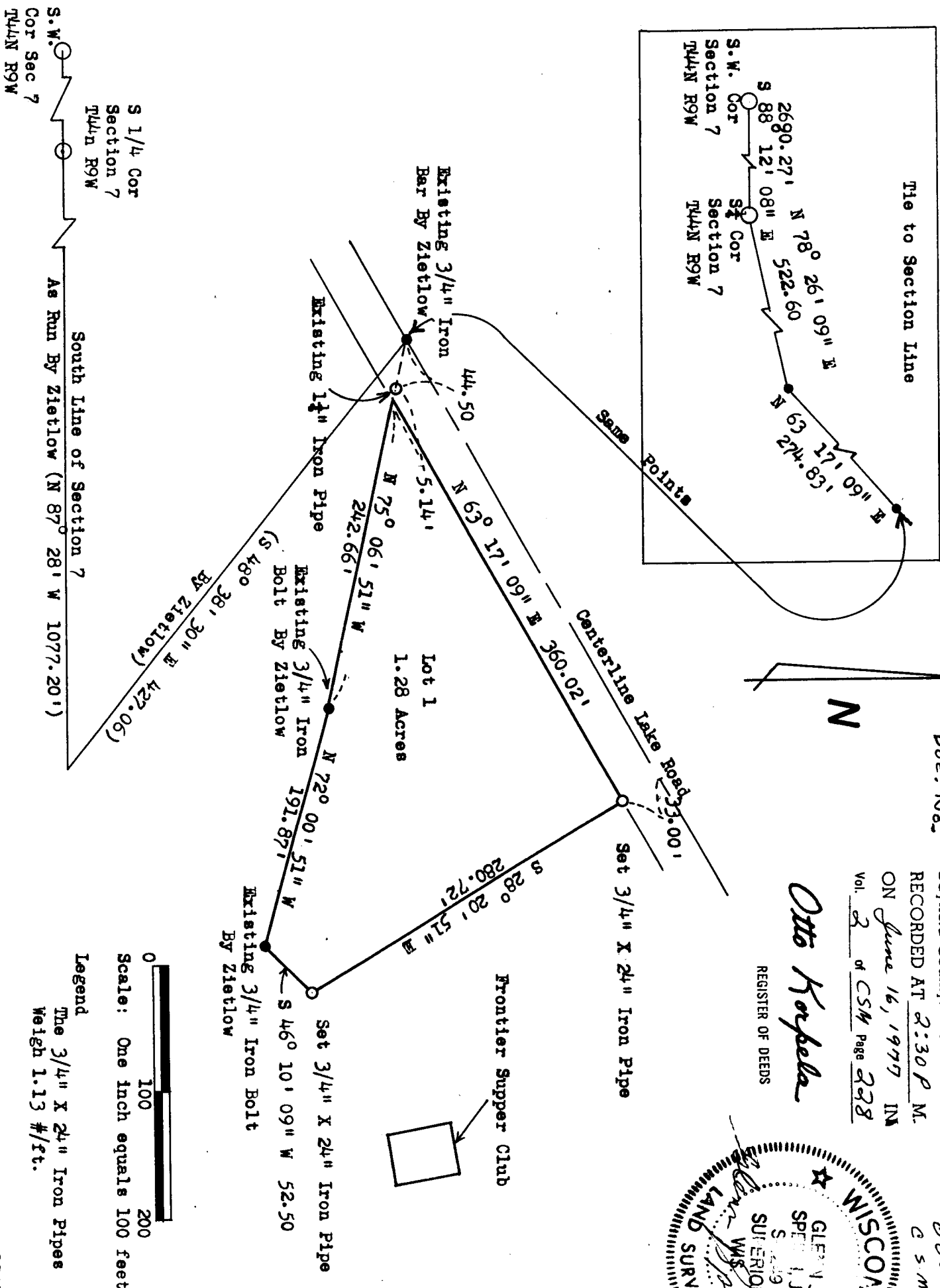

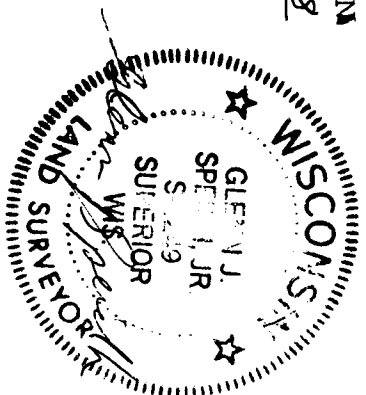
