S. Sheldon Okrestrom, Surveyor, of the County of Bayfield and State of Wisconsin, hereby certify that between the 1st day of January and the 1st day of February A.D. 1893, I surveyed and plotted the following described lands, situated in the County of Bayfield and State of Wisconsin to wit: all that part of the S. E. 1/4, N. E. 1/4 & E. 1/4 of Section Twenty-nine (29) Township Fifty (50) North of Range Eight (8) West of Range and Township of the 2nd Range East of the South East (S.E.) Corner of said Section Twenty-nine (29) and running northward 145 feet; thence running westward 27 right angles with said section corner, ten hundred and thirty feet; thence running northward in a straight line parallel with said section line, thirteen hundred (1300) feet; thence running eastward 165 feet; thence eastward along the north shore of said section line to the south shore of said section line, the west line of said section corner, near (29) there remaining southward on said east shore line to a point on hundred sixty four (165) feet north of the starting point; and that I made the survey & map of said land under the order and direction of George A. Howard and Sheldon Okrestrom; that the map is a correct representation of all the exterior boundaries of the land surveyed and of the divisions thereon made; that I have fully complied with the provisions of Chapter one hundred and one (101) of the laws of the State of Wisconsin, in Surveying, Subdividing and Mapping the same.
