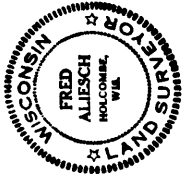


The Village Kame

I, Fred Alesch, registered land surveyor, hereby certify that in full compliance with the provisions of Chapter 236 of the Wisconsin Statutes and the subdivision regulations of the Town of Cable, and under the direction of The Telemark Land Co., Inc., owner of said land, I have surveyed, divided and mapped the Village Kame; that such plat correctly represents all exterior boundaries and the subdivision of the land surveyed; and that this land is located in the S.E. 1/4, S.E. 1/4 of section 21, and the S.W. 1/4, S.W. 1/4 of section 22, T. 43N, R. 7W, Town of Cable, Bayfield County, Wisconsin, to-wit: Commencing at the southeast corner of section 21, thence N. 88° 40' W, 270.00'; thence S. 23° 50' W, 340.00'; thence S. 02° 24' E, 222.80'; thence S. 77° 24' E, 190.00'; thence S. 24° 59' E, 150.00'; thence S. 72° 04' E, 145.00'; thence N. 16° 50' E, 190.00'; thence N. 79° 20' E, 175.00'; thence S. 88° 10' E, 70.00'; thence N. 15° 50' E, 190.00'; thence S. 73° 10' E, 50.00'; thence N. 11° 00' E, 50.26'; thence N. 73° 10' W, 46.50'; thence N. 04° 18' E, 132.89'; thence along the arc of a curve whose chord bears N. 13° 59' W, 154.63'; thence N. 58° 01' E, 122.92'; thence N. 50° 40' W, 185.00'; thence N. 40° 40' W, 185.00'; thence N. 51° 10' W, 130.00'; thence N. 88° 40' W, 150.00% to the point of beginning.
