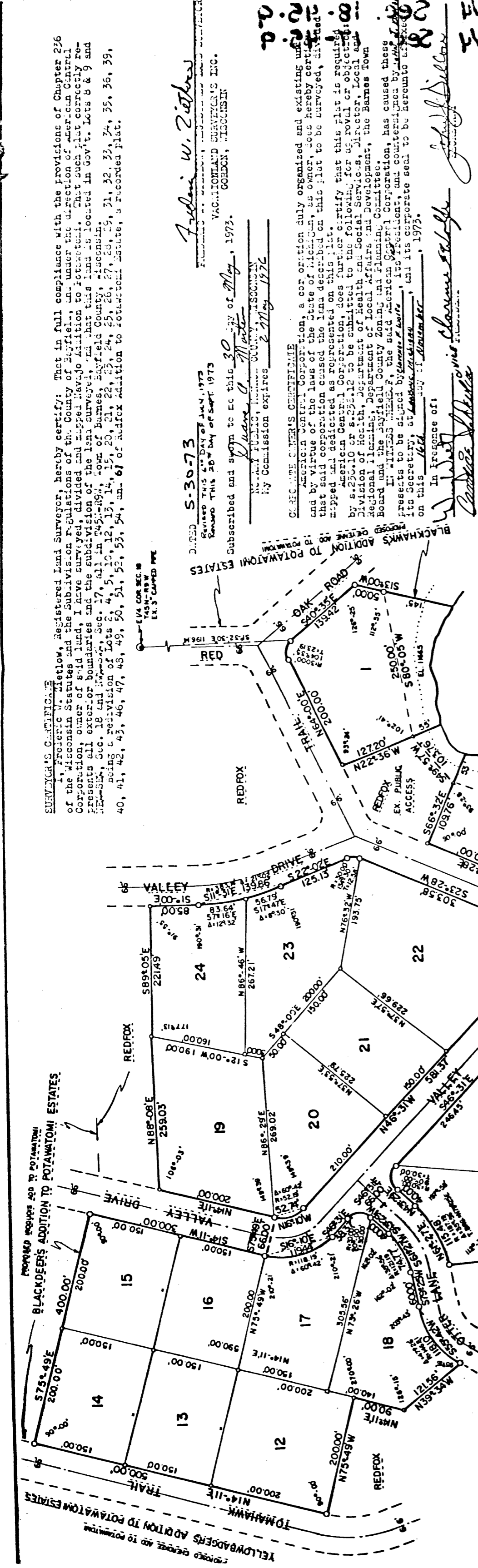
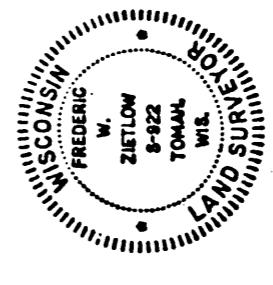
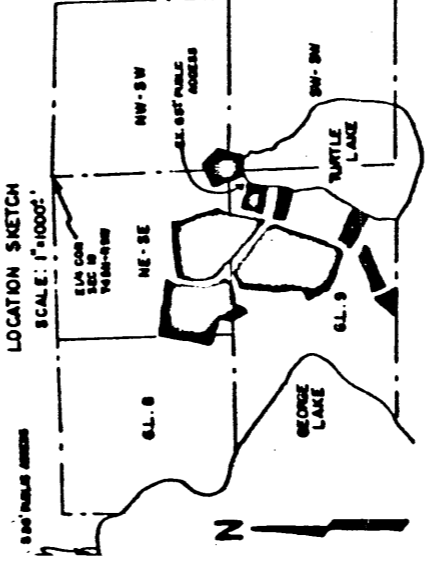


SURVEYOR'S CERTIFICATE

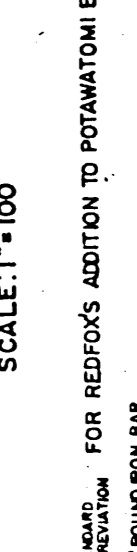
