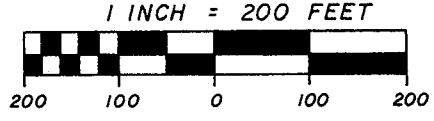

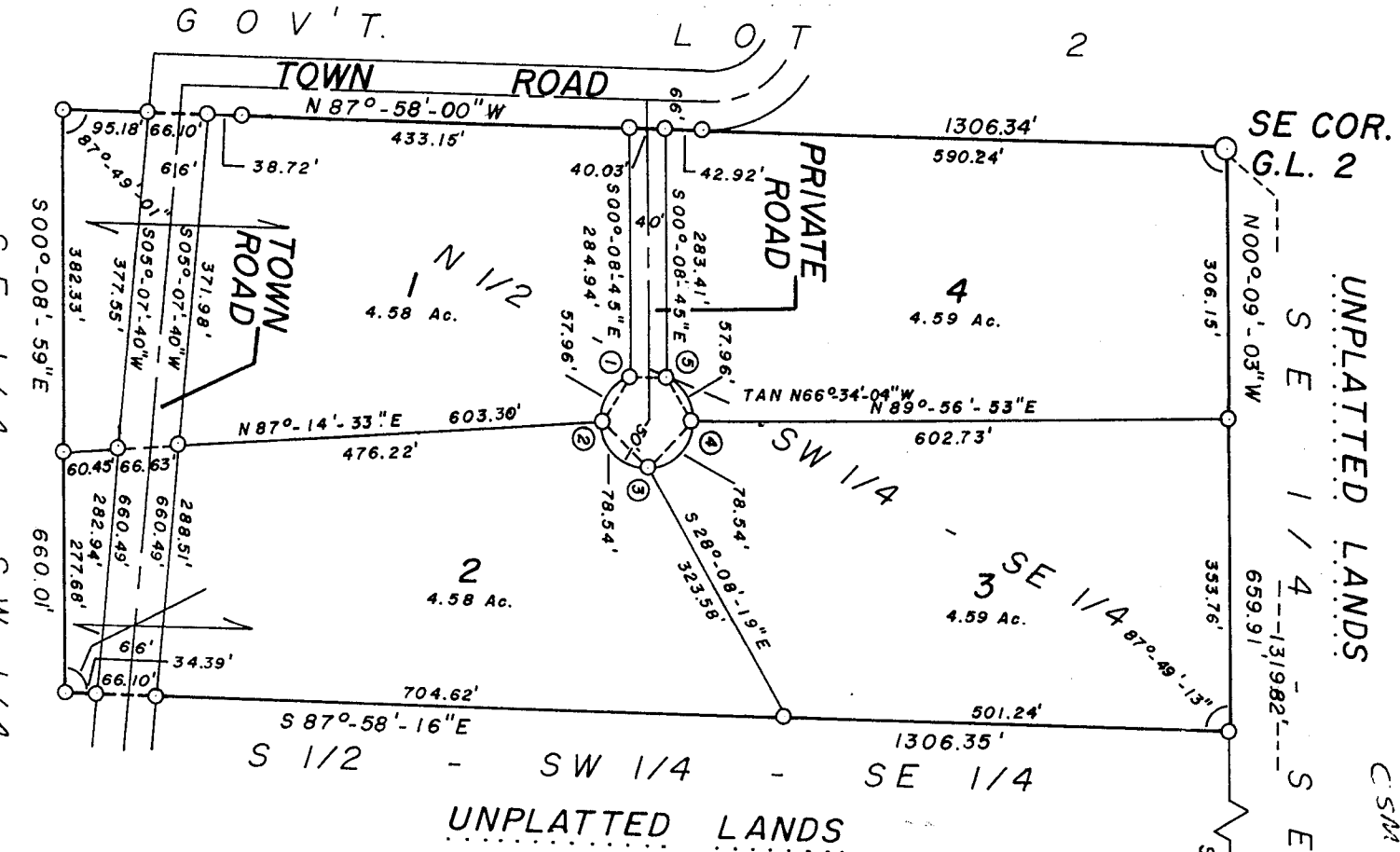

That I have surveyed, divided and mapped this certified survey located in the N $\frac{1}{2}$ of the SW $\frac{1}{4}$ of the SE $\frac{1}{4}$, Section 23, T. 51 N., R. 6 W., in the Town of Bell, Bayfield County, Wisconsin, described as follows;

To locate the Point of Beginning commence at the SE corner of said Section 23 and run N 87°-58'-31" W, along the South line of Section 23, 1306.36 feet to a 1- $\frac{1}{4}$ " capped iron pipe at the E 1/16 corner; Thence N 00°-09'-03" W, along the E 1/16 line. 1319.82 feet to a 1- $\frac{1}{4}$ " capped iron pipe at the NE corner of said SW $\frac{1}{4}$ - SE $\frac{1}{4}$, which is the Point of Beginning;

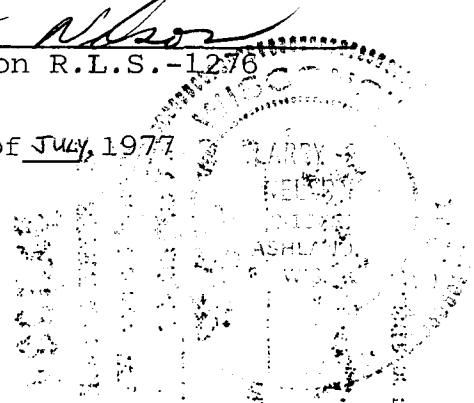
Thence from said Point of Beginning by metes and bounds;
