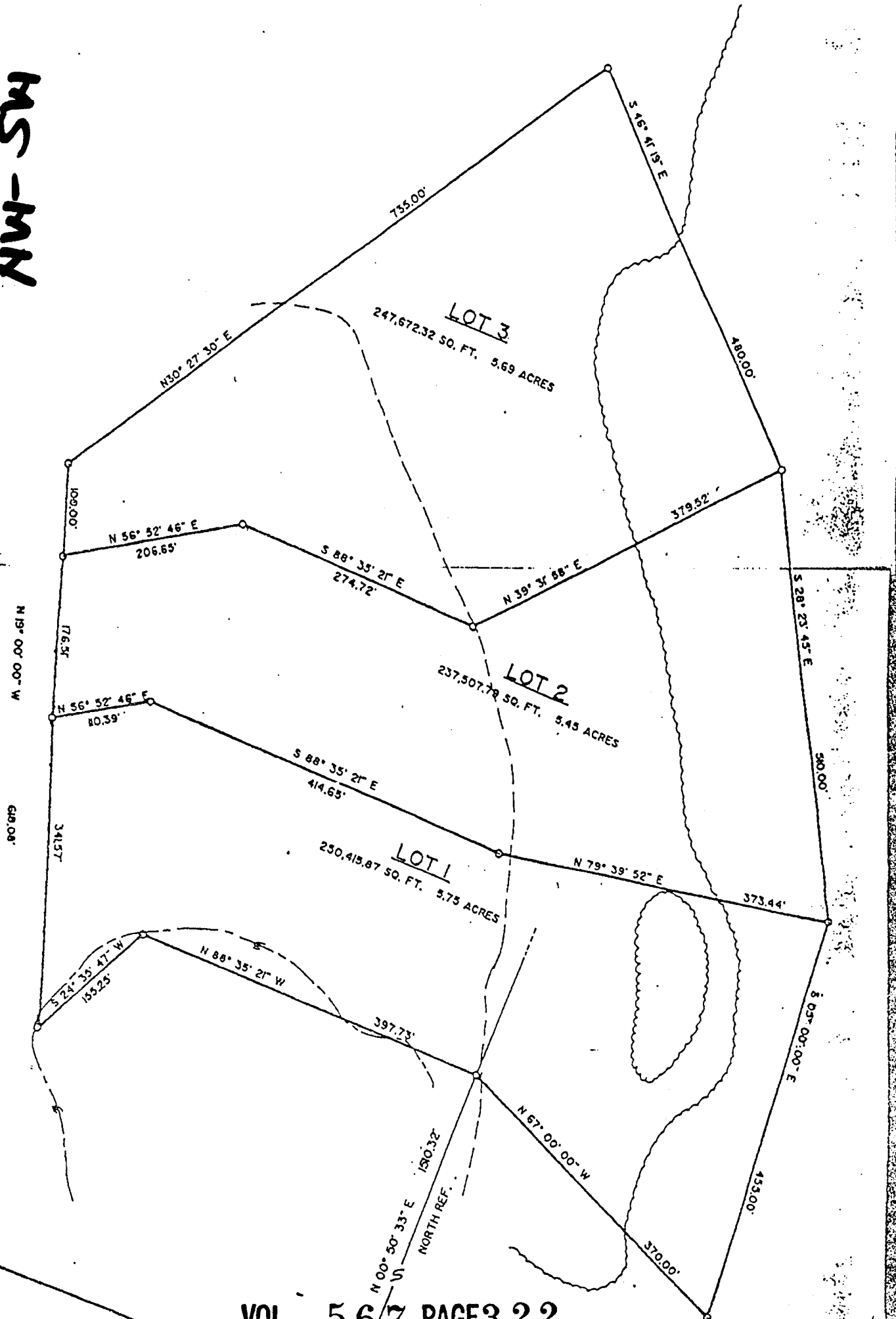

EXHIBIT A

Description of access road from Olson road to LOT 1 of the map of EAGLE BLUFFS

A 50 foot wide parcel of land located in the Southeast 1/4 of the Southeast 1/4, and part of the Northeast 1/4 of the Southeast 1/4 of Section 2, T. 50N., R. 4W., in the Town of Bayfield, Bayfield County, Wisconsin, the centerline of which is described as follows:

To locate the Point of Beginning, commence at the Southeast corner of said Section 2 and run N 85° 13' 41" W, 477.24 feet along the South line of said Section 2, which is the Point of Beginning.

Thence from said Point of Beginning by metes and bounds;

N 6° 32' 02" E, 72.75 feet; Thence along the arc of a curve to the left having a radius of 225.93 feet; a central angle of 23° 23' 49", a chord which bears N 05° 09' 52" W, and measures 91.62 feet, 92.26 feet; Thence along the arc of a curve to the right, having a radius of 189.14 feet; a central angle of 27° 47' 06", a chord which bears N 02° 58' 12" W, and measures 90.82 feet, 91.72 feet; Thence along the arc of a curve to the left having a radius of 163.21 feet; a central angle of 36° 25' 14", a chord which bears N 07° 17' 16" W, and measures 102.01 feet, 103.74 feet; Thence N 25° 29' 53" W, 13.75 feet; Thence along the arc of a curve to the right having a radius of 111.04 feet; a central angle of 34° 59' 25", a chord which bears N 08° 00' 11" W, and measures 66.76 feet, 67.81 feet; Thence N 09° 29' 32" E, 31.23 feet; Thence along the arc of a curve to the right having a radius of 190.71 feet, a central angle of 29° 22' 58", a chord which bears N 24° 11' 01" E, and measures 96.73 feet, 97.80 feet; Thence N 38° 52' 30" E, 94.23 feet; Thence along the arc of a curve to the left having a radius of 206.30 feet, a central angle of 27° 14' 52", a chord which bears N 25° 15' 04" E, and measures 97.19 feet, 98.11 feet; Thence N 11° 37' 38" E, 43.90 feet; Thence along the arc of a curve to the right having a radius of 265.93 feet; a central angle of 25° 25' 44", a chord which bears N 24° 20' 30" E, and measures 117.06 feet, 118.02 feet; Thence N 37° 03' 22" E, 31.99 feet; Thence along the arc of a curve to the left having a radius of 102.54 feet; and a central angle of 72° 21' 52", a chord which bears N 00° 52' 26" E, and measures 121.07 feet, 129.51 feet; Thence along the arc of a curve to the right having a radius of 153.40 feet; a central angle of 33° 49' 41", a chord which bears N 18° 23' 40" W, and measures 89.26 feet, 90.57 feet; Thence along the arc of a curve to the left having a radius of 134.79 feet; a central angle of 34° 15' 10", a chord which bears N 18° 36' 24" W, and measures 79.39 feet, 80.58 feet; Thence N 35° 43' 59" W, 115.96 feet; Thence along the arc of a curve to the right having a radius of 163.26 feet; a central angle of 48° 13' 21", a chord of which bears N 11° 37' 18" W, 133.39 feet, 137.41 feet.
