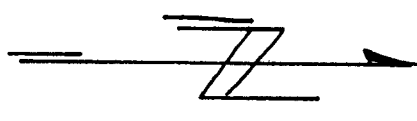


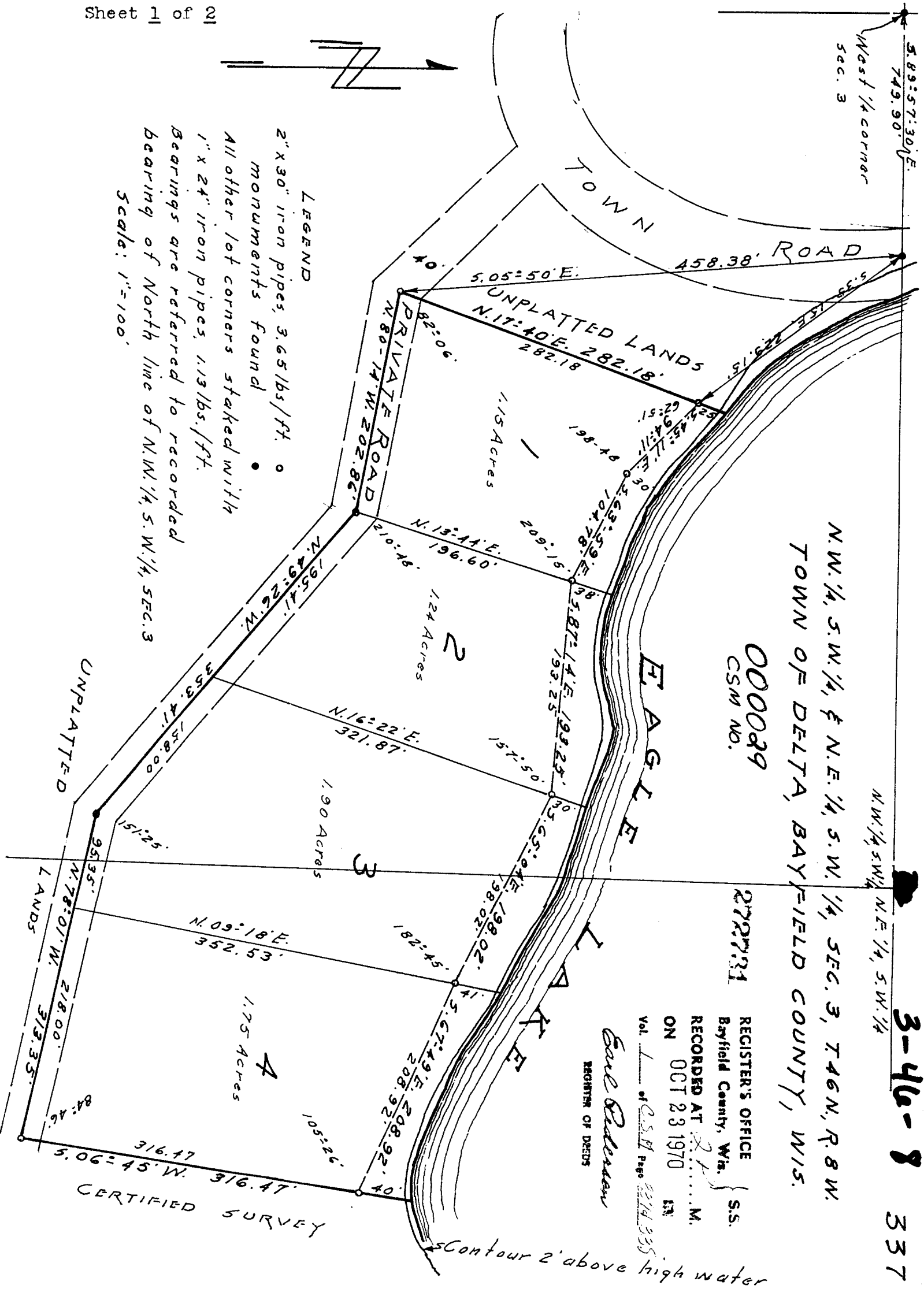

CERTIFIED SURVEY

I, Fred Aliesch, registered land surveyor, hereby certify: That in full compliance with the provisions of Chapter 236 of the Wisconsin Statutes and the subdivision regulations of the Town of Delta, and under the direction of _____ owner of said land, I have surveyed, divided and mapped certified survey; that such certified survey correctly represents all exterior boundaries and the subdivision of the land surveyed; and that this land is located in the Northwest Quarter of the Southwest Quarter (NW $\frac{1}{4}$ of SW $\frac{1}{4}$) and the Northeast Quarter of the Southeast Quarter (NE $\frac{1}{4}$ of SW $\frac{1}{4}$) of Section Three (3), Town Forty-six (46) North, Range Eight (8) West, Town of Delta, Bayfield County, Wis., to-wit:

Commencing at the West Quarter corner of Section Three, thence South 89°-57'-30 East, 749.90 feet, thence South 05°-50' East, 458.38 feet to the point of beginning, thence North 17°-40' East, 282.18 feet to a point 25 feet, more or less, from the water's edge of Eagle Lake, thence along the meander line along the lake, South 45°-11' East, 94.11 feet, thence South 63°-59' East, 104.78 feet, thence South 87°-14' East, 193.25 feet, thence South 65°-04' East, 198.02 feet, thence South 67°-49' East, 208.92 feet to a point 40 feet, more or less, from the water's edge of Eagle Lake and the end of the meander line, thence South 06°-45' West, 316.47 feet, thence North 78°-01' West, 313.35 feet, thence North 49°-26' West, 353.41 feet, thence North 80°-14' West, 202.86 feet to the point of beginning, including all the land lying between the meander line and the water's edge of Eagle Lake.
