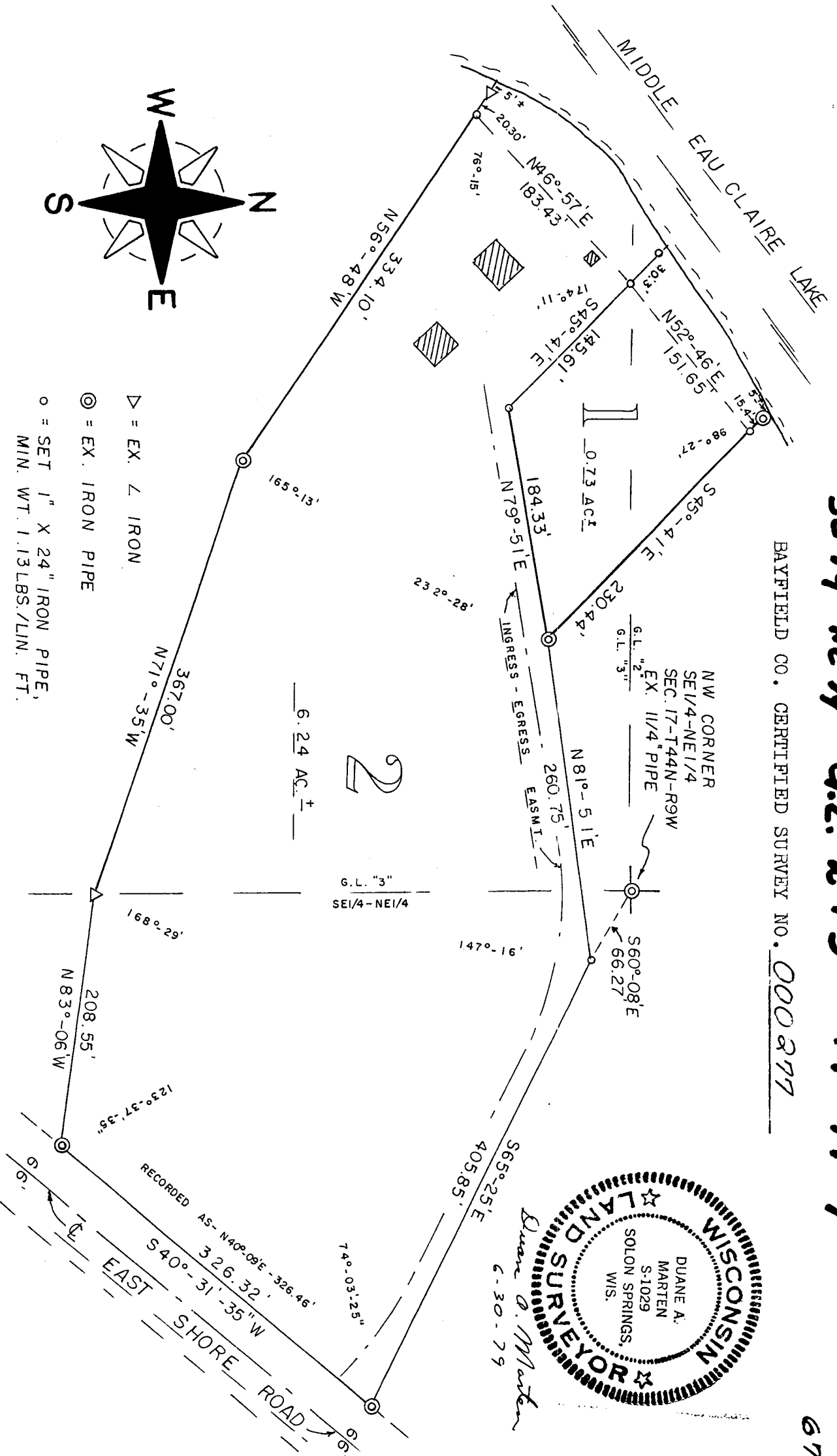

SURVEYOR'S CERTIFICATE - I, Duane A. Marten, Registered Land Surveyor, hereby certify:

That I have surveyed, divided and mapped that part of Gov't. Lots 2 and 3 and the SE $\frac{1}{4}$ -NE $\frac{1}{4}$, Sec. 17-T44N-R9W, Town of Barnes, Bayfield County, Wisconsin, bounded and described as follows:

Commencing at the NW corner of the SE $\frac{1}{4}$ -NE $\frac{1}{4}$ of said Sec. 17; thence S60°-08'E, 66.27 feet to the point of beginning; thence S65°-25'E, 405.85 feet to the Northwesterly R/W line of East Shore Road; thence S40°-31'-35"W along said line, 326.32 feet; thence N83°-06'W, 208.55 feet; thence N71°-35'W, 367.00 feet; thence N56°-48'W, 334.10 feet to a point 25 feet, more or less, from the water's edge of Middle Eau Claire Lake; thence N46°-57'E along a meanderline, 183.43 feet; thence N52°-46'E, along a meanderline, 151.65 feet to a point 20 feet, more or less, from the water's edge of Middle Eau Claire Lake; thence S45°-41'E, 230.44 feet; thence N81°-51'E, 260.75 feet to the point of beginning. Including all lands lying between the above described meanderline and the water's edge of Middle Eau Claire Lake.
