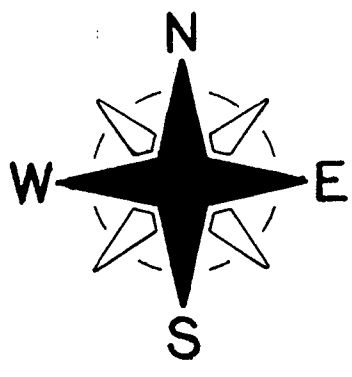

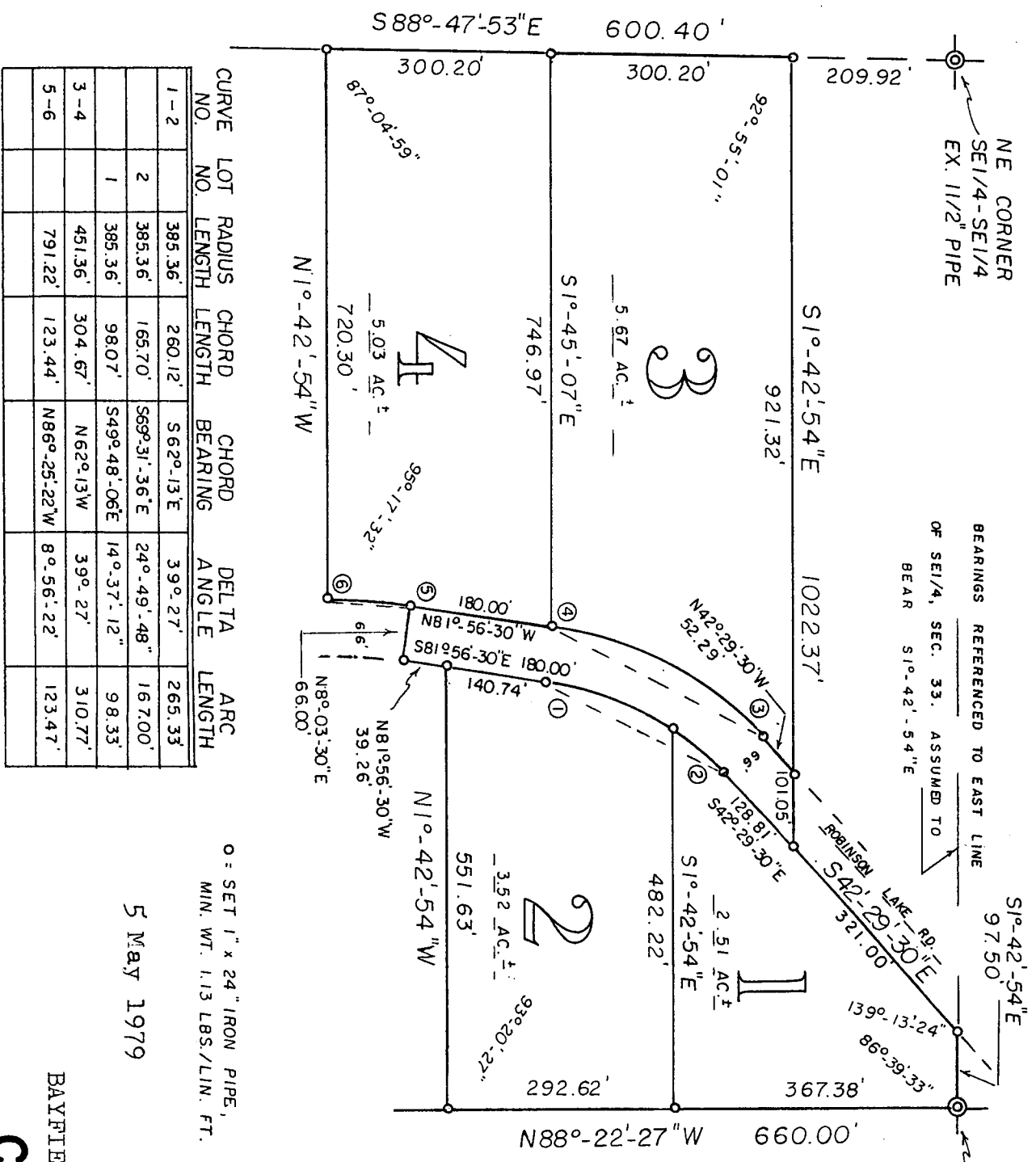

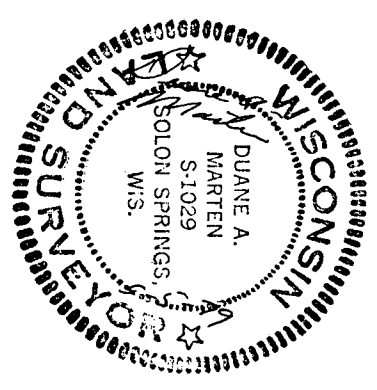

SURVEYOR'S CERTIFICATE

I, Duane A. Marten, Registered Land Surveyor, hereby certify:

That I have surveyed, divided and mapped that part of the SE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Sec. 33-T45N-R9W, Town of Barnes, Bayfield County, Wisconsin, bounded and described as follows:

Beginning at the SE corner of said Sec. 33; thence N88°-22'-27"W, 660.00 feet; thence N10-42'-54"W, 551.63 feet to the Southerly line of Robinson Lake Road; thence N81°-56'-30"W along said Southerly line, 39.26 feet; thence N80-03'-30"E, 66.00 feet to the Northerly line of Robinson Lake Road; thence along said line on a curve concave to the Southwest and having a radius of 791.22 feet (the chord of which bears N86°-25'-22"W, 123.44 feet) a distance of 123.47 feet; thence N10-42'-54"W, 720.30 feet; thence S88°-47'-53"E, 600.40 feet; thence S10-42'-54"E, 1022.37 feet to the Southwesterly line of Robinson Lake Road; thence S42°-20'-30"E along said South line, 321.00 feet; thence S10-42'-54"E, 97.50 feet to the point of beginning.
