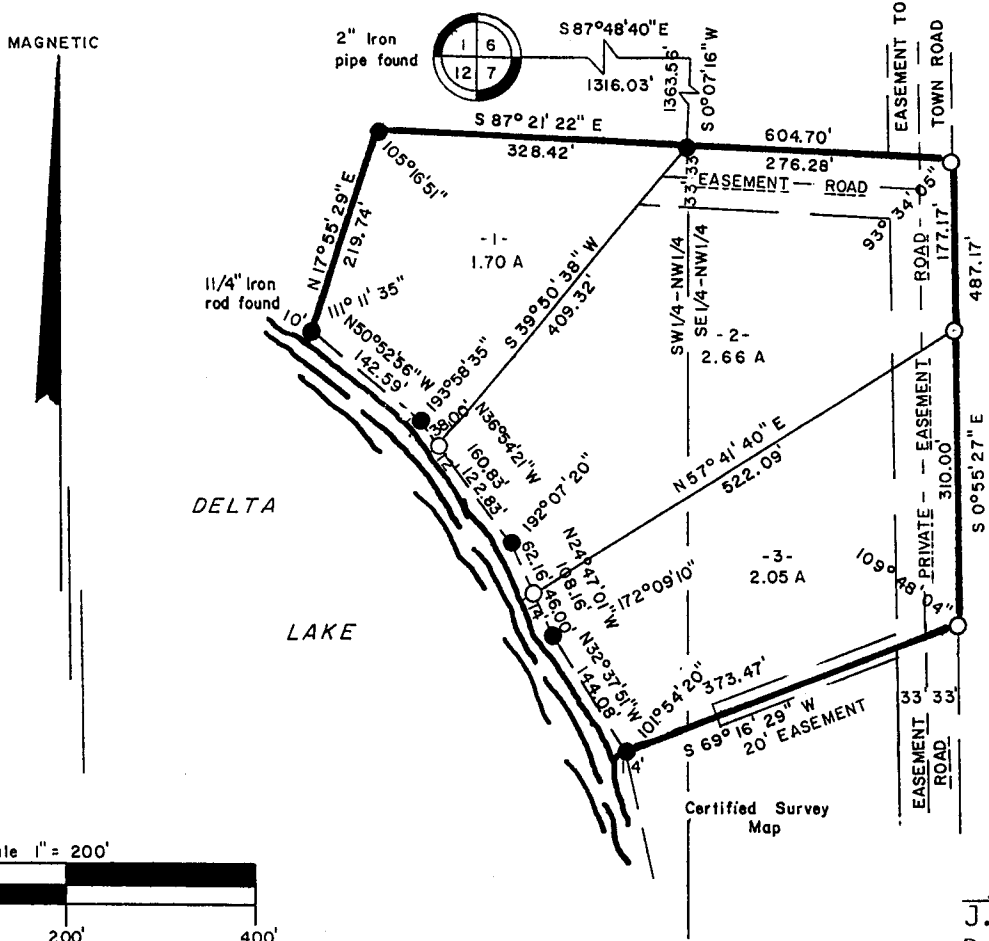

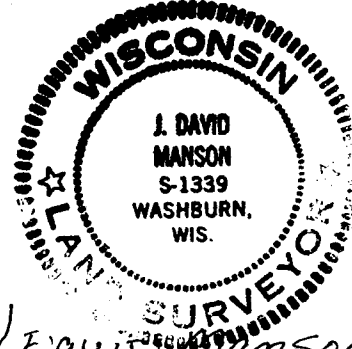

I, J. David Manson, Registered Land Surveyor, S-1339, hereby certify that we have surveyed the property described below; that this plat is an accurate survey and true representation thereof and correctly shows the exterior boundary lines and the correct measurements thereof; that we have made such survey by order of LEE NEWMAN, and that we have complied with Chapter 236.34 of the Wisconsin Statutes.

PARCELS 1, 2 and 3, being a parcel of land in the SW 1/4 of the NW 1/4 and the SE 1/4 of the NW 1/4, Section 7, T 46N, R 7W, Delta Township, Bayfield County, Wisconsin, more particularly described as follows: Commencing at the section corner common to Sections 1, 6, 7 and 12, marked by a 2" iron pipe; thence S 87°48'40"E along the North line of said Section 7, 1316.03 feet to a 1/16th corner, thence S 0°07'16"W, along the East line of the NW 1/4 of the NW 1/4 of said Section 7, 1363.56 feet to a 1/16th corner being the place of beginning, marked by a 3/4" iron rod. Thence S 87°21'22"E along the North line of said SE 1/4 of the NW 1/4, 276.28 feet to a 3/4" iron rod; thence S 0°55'27"E, 487.17 feet to a 3/4" iron rod; thence S 69°16'29" W, 373.47 feet to a 3/4" iron rod near the shore of Delta Lake; thence along the following meander line; N 32°37'51"W, 144.08 feet to a 3/4" iron rod; thence N 24°47'01"W, 108.16 feet to a 3/4" iron rod; thence N 36°54'21"W, 160.83 feet to a 3/4" iron rod; thence N 50°52'56"W, 142.59 feet to a 1-1/4" iron rod; thence leaving said shore N 17°55'29"E, 219.74 feet to a 3/4" iron rod; thence S 87°21'22"E along the North line of said SW 1/4 of the NW 1/4, 328.42 feet to the place of beginning. The above lateral lot lines extend to the lake including all riparian rights thereto. Including an easement over a 66.00 foot private road for the purpose of ingress and egress to County Trunk Highway "H". Also including an easement over a 66.00 foot private road for the purpose of ingress and egress for lands to the South.
